Presentation and Guidelines

The **Centre for Research and Studies in Sociology / Centro de Investigação e Estudos de Sociologia (CIES-Iscte)** of the **University Institute of Lisbon / Instituto Universitário de Lisboa (Iscte)** is a R&D unit, recognised and evaluated by the FCT (Foundation for Science and Technology), in the area of social sciences dedicated to studying contemporary social problems from a multidisciplinary perspective. Constituted in 1985, it is an organic unit of Iscte and is part of its School of Sociology and Public Policy.



CIES-Iscte's main scientific domain is sociology, developing relevant activity in the fields of public policy, political science, communication, education, modern and contemporary history and social work.

CIES-Iscte's activity is characterised by a demanding articulation between basic research, applied research mainly directed at the design, monitoring and evaluation of public policies in various sectors and areas of intervention and advanced training.

The Centre's research and scientific production, fosters diversity and the crossing of intensive and extensive approaches, aimed at deepening the analytical relationship

between the study of social, political and historic macro-processes and the social, cultural and spatial micro-dynamics.

Currently the research team is composed of 125 integrated PhD researchers, including a significant number of foreign researchers from 19 different nationalities (17% of integrated PhD full-time researchers). The Centre also hosts a growing number of visiting researchers (37 in 2019).

CIES-Iscte's integrated PhD researchers are mostly professors at Iscte or full-time researchers at the Centre. Another part of the integrated PhD researchers belongs to other national university and polytechnic higher education institutions, among which the Beira Interior University - UBI, where the CIES-UBI Pole is located.

The scientific structure of CIES-Iscte is based on 6 Research Groups:

- Inequalities, Migrations and Territories
- Knowledge Society, Competences and Communication
- Family, Generations and Health
- Politics and Citizenship
- Work, Innovation and Social Structures of the Economy
- Modern and Contemporary History

The development of the CIES-Iscte strategic programme is also anchored in a set of permanent research structures that are linked to the research groups and are one of the Centre's distinctive features. The [Inequality Observatory](#), [Emigration Observatory](#), [Portuguese Observatory on Cultural Activities](#) and [nascer.pt - Laboratory for the Social Studies on Childbirth](#) illustrate this dynamic.

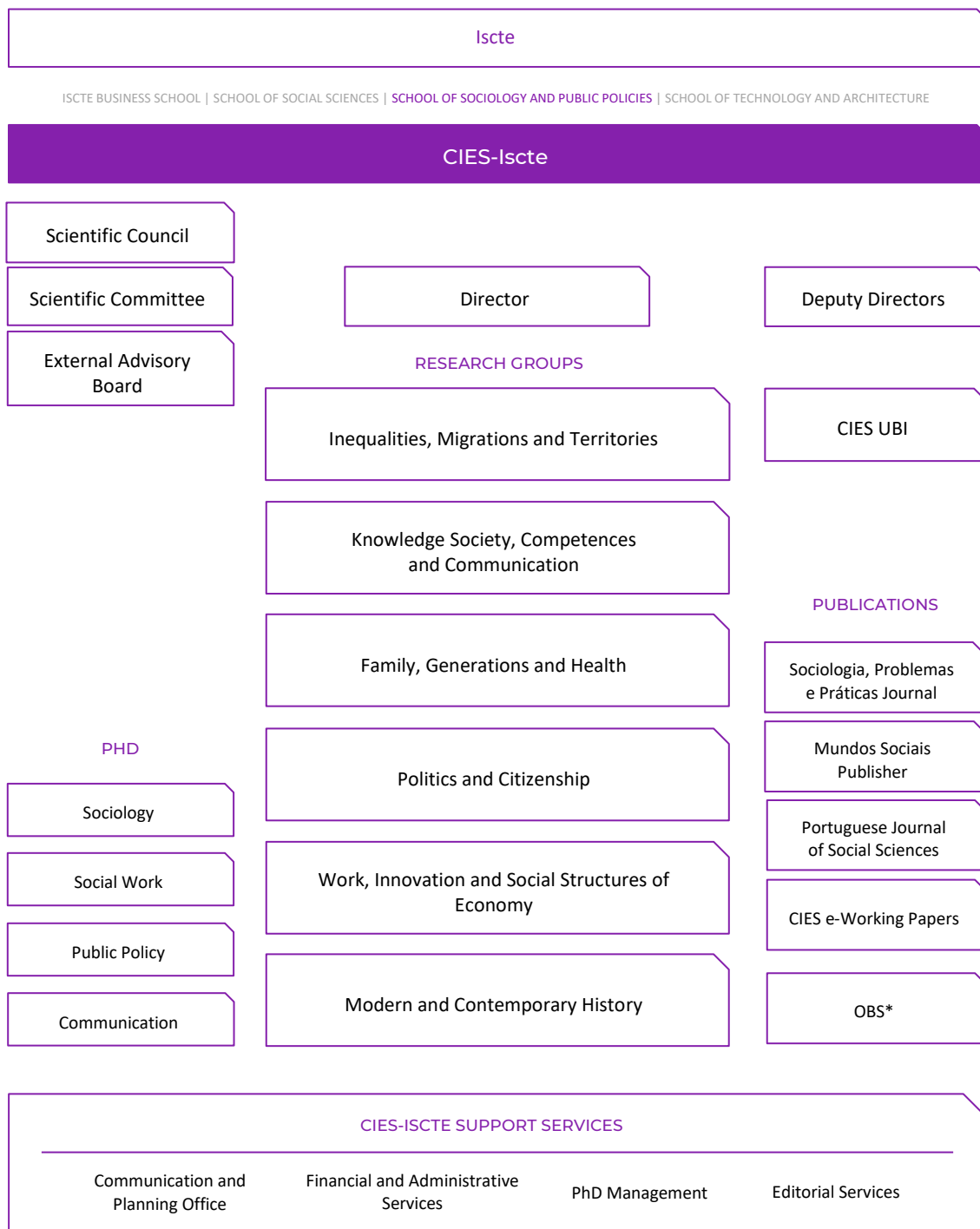
Advanced training is another fundamental pillar of CIES-Iscte, closely combined with research activities. The Centre is responsible for the scientific and administrative coordination of 4 PhD programmes - [Sociology, Public Policy, Communication, Social Work, Political Science](#) – and is associated with 4 others (Political Economy; Communication Studies: Technology, Culture and Society; Urban Studies; History: change and continuity in a global world - PIUDHist).

CIES-Iscte regularly organizes national and international conferences in order to promote a dynamic environment of up-to-date scientific debate. Since its foundation, the Centre has also been continuously developing activities to promote scientific culture, in close connection with a large number of partners.

In the editorial field CIES-Iscte publishes since 1986 the scientific journal [Sociologia, Problemas e Práticas](#) [Sociology, Problems and Practices]. The journal is indexed by several international databases such as SCOPUS and Thomson Reuters SciELO Citation Index. The Centre also publishes the [CIES e-Working Papers](#) and supports the indexed journals [Portuguese Journal of Social Science](#) and [Observatory \(OBS*\)](#). Since 2010 CIES-Iscte has its own publisher, [Mundos Sociais](#), that publishes the journal and refereed social sciences' academic books.

The *Scientific Council* includes all integrated PhD researchers and is responsible for reviewing and approving the Annual Activities Report and Plan of Activities and for discussing the Centre's scientific and organizational issues. This council also elects the Scientific Committee and proposes the nomination of the Director of the Centre (that results from an election), to be presented to the Rector of Iscte.

The *External Advisory Board* visits the Centre annually and evaluates it by analysing the annual Activity Report and the Activity Plan and discussing the strategy and results with the Executive Board. For the period 2018-2022 the Centre renewed the composition of the External Advisory Board, which includes researchers of international reputation who will contribute with their wide experience to the implementation of the proposed ambitious strategy for the following years.

Support services

The increasing complexity, globalization and competitiveness of scientific systems require professional management, to assure the access to the multiplicity of financing opportunities and the efficient use of resources to maximize the scientific and social impact of the activities.

CIES-Iscte has a set of support services to address these challenges, which include the Communication and Planning Office, the Financial and Administrative Services, the PhD Programmes Management, the MediaLab and the services of the *Mundos Sociais* publisher and the journal *Sociologia Problemas e Práticas*.

In 2019, a total of eleven full-time staff members were assigned to these services, supporting the research team and the Centre's governing bodies.

The functions performed by the Communication and Planning Office are twofold: to search for opportunities and to support the submission of applications for research activities and to monitor and manage the scientific activities in progress; and the organization of scientific events and other forms of dissemination of the activities and scientific results of the Centre, including the promotion of scientific culture.

The Financial and Administrative Services ensure budget elaboration and justification for applications and the financial management of ongoing research projects and activities, ensuring compliance with the procedures of the host institution and the requirements of the various funding institutions. These services also ensure the execution of the funds and financial prizes granted to members of the research team provided by Iscte and other sources.

The PhD Management service accompanies the students' in all phases of the PhD programme, from the application to its conclusion, as well as guarantees support to the teachers and the teaching activities, managing also the International Cycle of PhD Conferences and other scientific meetings.

The MediaLab focuses on laboratory experimentation to study communication practices in its different models and objects - from digital to analogue, from text to image, sound, audiovisual and multimedia, to network analysis and online trends, related to social media networks, online research and users' opinions, information visualisation and data science.

The supporting services of *Mundos Sociais* publisher and the journal *Sociologia, Problemas e Práticas* cover the entire editorial,

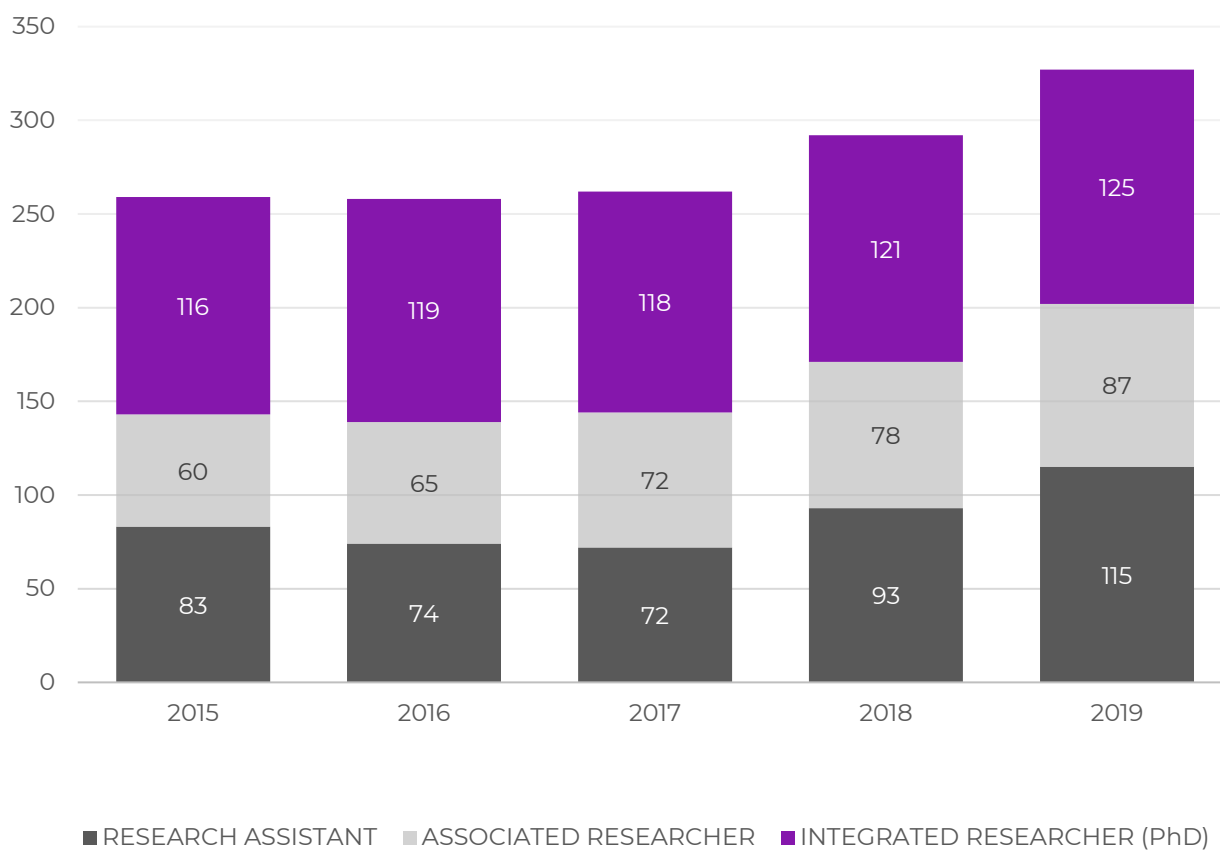
publication and dissemination process of the books published by *Mundos Sociais*, the journal *Sociologia, Problemas e Práticas* and the CIES e- Working Papers. They also ensure compliance with the procedures for the inclusion of CIES-Iscte's publications in scientific repositories and in national and international indexation databases.

Research team

The CIES-Iscte research team includes researchers (integrated PhDs), associated researchers and research assistants. Integrated PhD researchers represent the core of the team, ensuring the essential coordination of research activities. Together, the CIES-Iscte research team consists of 327 members.

In 2019, one can highlight the stabilization of the constitution of the research team, with 125 integrated PhD researchers, corresponding to 72,8 FTE (Full-Time Equivalent).

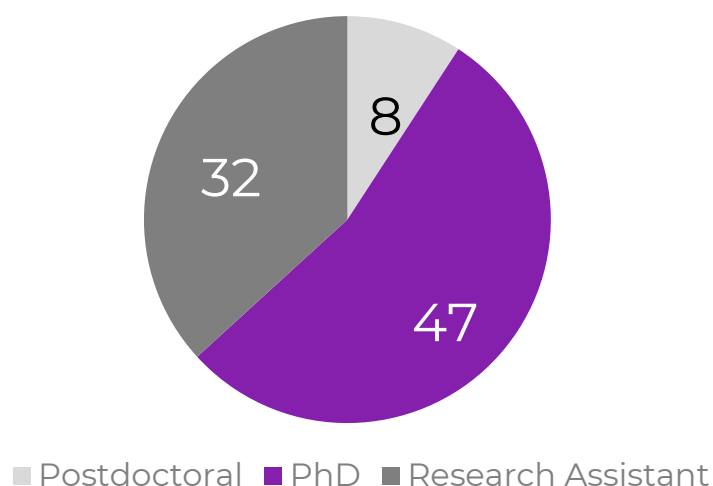
It should be noted that in all categories the majority of researchers are female (58% of the integrated PhD researchers, 62% of the associated researchers and 60% of the research assistants).

Integrated PhD researchers are mostly professors at Iscte – Instituto Universitário de Lisboa or full-time researchers at the Centre (postdoctoral fellows or hired researchers).

Another part of the integrated PhD researchers belongs to other national higher education institutions, among which the University of Beira Interior (UBI) and polytechnic institutes of different areas (Health, Tourism, Education) and regions of the country (North, Central and Metropolitan Area of Lisbon). The seven integrated PhD researchers from the University of Beira Interior (UBI) integrate the CIES-UBI Pole.

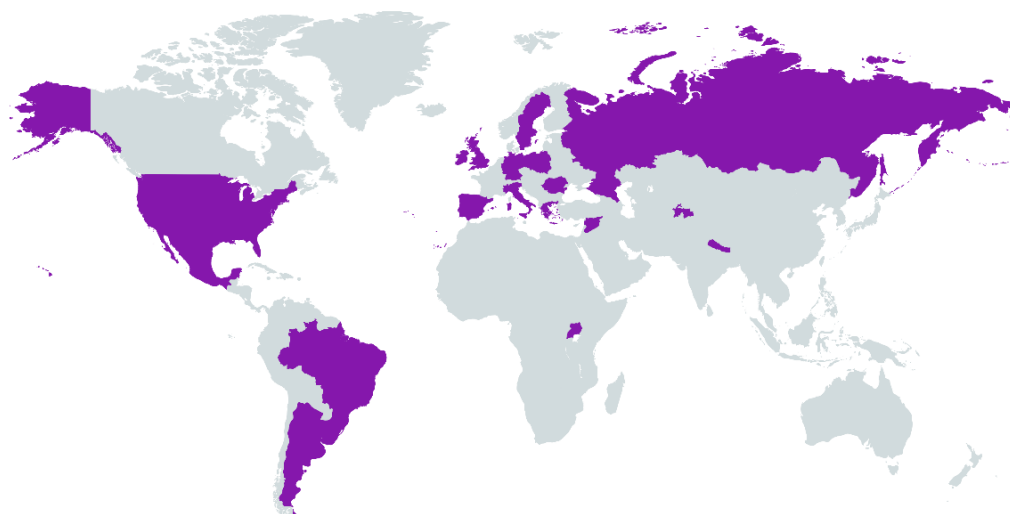
The CIES-Iscte researchers have a very positive record in obtaining research grants with 87 active scholarships (in 2019), of which 8 are postdoctoral and 47 PhD scholarships.

In 2019 CIES and Iscte have made a strong effort to quickly implement the FCT policy of scientific employment, transforming Post-doctoral grants into research contracts. 25 applications for research contracts were opened and completed until December 2018. This justifies a decrease in the number of post-doctoral fellowships from 2018 to 2019, from 34 to 8 fellowships. These contracted researchers now have a six-year commitment to the institution to develop a research plan that they have proposed. This fact, along with the Iscte's rectorate orientation to support scientific careers, will bring new possibilities to structure and develop the fulltime researchers' careers, and improve scientific work.

The internationalization of the team should also be noted. In 2019, 14% of the members of the research team are foreign, of 20 nationalities. Research team member's nationalities

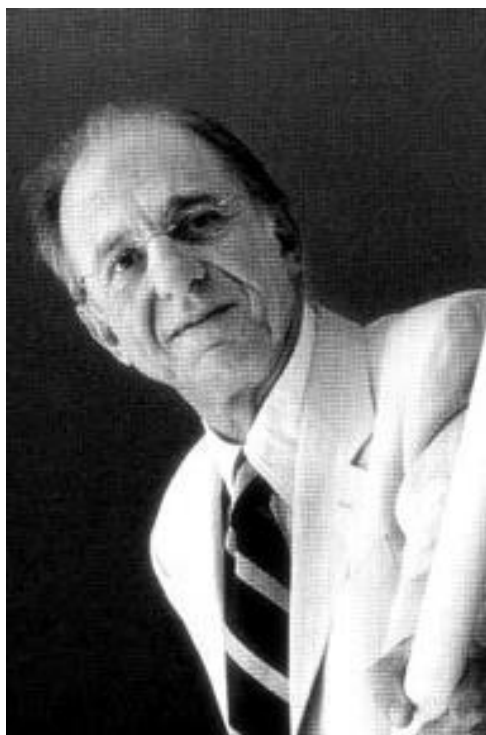

During 2019, the Centre welcomed 37 visiting researchers from Australia, Belgium, Brazil, Chile, Croatia, Germany, Greece, Italy, Netherlands, Spain and United States of America. Of these researchers, 19 were PhDs and 18 were PhD or master students who came to do research work for their thesis.

In 2019 CIES-Iscte also hosted 49 guest researchers that key-note speakers in scientific meetings organized by members of the team, namely in the International Cycle of PhD Conferences.

In Memoriam Juan Mozzicafredo (1945 - 2019)



In July 2019, our cherished colleague Juan Mozzicafredo passed away.

Juan was Emeritus Professor of Iscte and researcher at CIES-Iscte where he deeply impacted colleagues, students and staff as a competent leader, distinguished teacher and renowned researcher for over four decades.

During the years he held various leadership positions at Iscte, namely as President of the Scientific Council, Member of the Board of Directors, Vice-President of Iscte, Director of the Department of Sociology and first Director of the School of Sociology and Public Policies.

With a remarkable academic career, his research activity was intense as well as his role in the training of new researchers, having contributed in a remarkable way to the development of research in political science and public administration.

2.1 Research groups

The research activities are carried out within the framework of the Research Groups. CIES-Iscte currently has six Research Groups: Inequalities, Migration and Territories; Knowledge Society, Competences and Communication, Family, Generations and Health, Politics and Citizenship, Work, Innovation and Social Structures of the Economy and Modern and Contemporary History.

The researchers' inclusion in the Research Groups is based on the themes associated with their research activities, which can be carried out in more than one group. There are also projects and other activities with cross-cutting themes that mobilize researchers from different groups.

The Research Group "Inequalities, Migrations and Territories" consists of 32 integrated PhD researchers, 24 associated researchers and 26 researchers with doctoral scholarships and other research assistants.

Based on different theoretical perspectives and using diverse methodological approaches, the Group is a source of innovation, discovery and accumulation of national and international reference knowledge in its areas of research in areas such as: a) Social classes and social mobility; b) Social inequalities based on socio-occupational profiles, social classes, education levels, gender, ethnic background, age, income, poverty and social exclusion, lifestyles

and consumption, among others; c) Immigration, ethnicity and Portuguese emigration at the level of both the composition of international flows to/from Portugal and the social integration of migrants, refugees and their descendants; (d) Cultural values, identities and attitudes within the framework of shared European values; e) Cities and urban life, non-urban territories and environmental studies.

The research carried out has significant social impact that must be highlighted, namely in advising and evaluating public policies that promote inequality reduction.

The RG includes two permanent structures, the Inequality Observatory and Emigration Observatory (producing information for the whole national scientific system with wide public diffusion) and coordinates CIES-Iscte's participation in the European Social Survey.

The RG integrates several research networks and international scientific structures and has likewise broadened its participation in international projects.

The core of the Research Group "Knowledge Society, Competences and Communication" is composed of 27 integrated PhD researchers from different generations, whose scientific work has as analytical focus the relations between knowledge and society, namely in a set of relevant institutional domains: education, science, communication and culture. The scientific activity of the RG also includes 29 associated researchers and 51 researchers with PhD scholarships and other research assistants.

In recent years the RG developed very positively in terms of scientific results, internationalisation, and social impacts. The team has been investigating a diverse but interrelated range of areas: schooling processes, inequalities and educational trajectories, education systems, reading and

literacy, new literacies, lifelong learning, higher education networks, science and society, public engagement with science and technology, internet and social networks, journalism and media systems, culture and arts, and cultural facilities, agents and audiences.

In addition, a significant proportion of the RG's projects also make important contributions to the design, analysis and assessment of public policies in the education, science, communication and cultural fields, leading to quite relevant impacts. Besides scientific results in terms of advancing knowledge and social impacts, the RG has pursued two other primary goals. On the one hand, it has been strongly committed to both the integration and training of young researchers and the advanced training of PhD students, and the employment in science of young post-doctoral researchers. On the other, the RG has systematically been oriented towards participation in international, and above all European and Ibero-American, scientific projects and networks. It is currently seeking an even more intense international presence.

The Portuguese Observatory on Cultural Activities (OPAC) was constituted in 2018

within the framework of CIES-Iscte, which is responsible for its scientific coordination and functioning. Its mission is the study, production and public availability of rigorous and updated information in various cultural domains in order to contribute to the current debates in Portuguese society and to the formulation, monitoring and evaluation of public policies.

The Research Group "Family, Generations and Health" is composed of 23 integrated PhD researchers, whose scientific activity focuses on research on families, generations and health. Also participating in this RG are 9 associated re-searchers and 13 researchers with PhD scholarships and other research assistants.

In the last years the RG made positive advances in its scientific results and the social impact of its research. It also consolidated the establishment of international partnerships, jointly drawing up applications, pursuing research projects and increasingly publishing co-authored works.

Taken as a whole, the RG's research team has worked in domains like: a) families, parenthood and childbirth movements, family

policies, gender, domestic violence, intimate lives and new gender identities; b) youth, children and youth wellbeing; ageing processes, life transitions, generational pathways and life course; c) health and illness in current societies; health policy and health governance; medical professions; biomedicine and alternative medicines; patient pathways in health systems; d) health, risk and lifestyles; medical drug use; substance consumption and addiction.

A number of these projects make important contributions to the design and evaluation of public policies at the national, European and transnational levels. Besides its commitment to advancing knowledge in its own scientific domains, the RG has also sought to receive and train young researchers of different nationalities, both by giving advanced training to PhD students, and by incorporating young post-doc researchers into the team.

The Laboratory for the Social Studies on Childbirth (nascer.pt) was constituted in 2018 as a permanent research platform and hosted by CIES-Iscte. Its aim is to foster knowledge about the conditions and characteristics of childbirth in Portugal, to contribute to the consolidation of the Sociology of child-birth

and, at the same time, to develop synergies between structures and multidisciplinary approaches in the study of childbirth, both at national and international level. Through the production and dissemination of scientific information, *nascer.pt* comes to improve the discussion around policies, practices and paradigms of the childbirth.

The Research Group “Politics and Citizenship” is composed of 27 integrated PhD researchers, 11 associated researchers and 15 researchers with PhD scholarships and other research assistants. The group is diverse and balanced in terms of age, gender and disciplinary background. Its main objective is to understand, from an interdisciplinary perspective, the interactions between civil society, political institutions and political elites, with a view to improving the quality of these interactions and, thus, the quality of democracy. The group has four main research

foci: a first one is related to political representation. Research projects in this area have been contributing to increase, from a comparative perspective, the knowledge of institutional forms of participation and political representation, especially in the crisis and post-crisis contexts. A second axis focuses on non-conventional forms of participation and contentious politics. Related projects have focused on the role of social movements in reshaping socio-political landscapes, challenging consolidated party systems, creating new political actors, and in revitalizing civil society. A third area is connected to the analysis of public policies and the dynamics of public administration and addresses the role of political institutions and public administration in the production and implementation of public policies. A fourth recently emerging area regards citizenship and social work. It centers on the professional practice of social work and looks at the development and conditions for implementation of social policies.

The Research Group “Work, Innovation and Social Structures of the Economy” is composed of 5 integrated PhD researchers, 7 associated researchers and 3 researchers with PhD scholarships and other research assistants.

In the last years the RG has achieved multiple goals, representing both continuity and transformation. In terms of continuity, the RG focused on: professions and their associations and unions (financial analysts, artists, scientists, teachers, lawyers, expatriate workers - e.g. project "Business lawyers and large corporations: practices, identities and cultures"); industrial relations (e.g. "Portuguese Observatory of Good Labour Practices"); dynamics of the labour market, professions and their relationship with public policies (e.g. "Teachers in public education and

teachers' unions in Portugal"). Examples of research on social change include: studies on science, technology and innovation (e.g. "Scientific Development and Entrepreneurial Innovation"), and highly qualified employment (e.g. "Innovation networks and scientific employment"); the social construction of the financial markets; work representations in cinema (e.g. "Work on screen"); the servitization of the economy; posting workers abroad (e.g. "EU-Post Lab"); quality of life at work; gender equity at work; the economic crisis and transformations at companies (e.g. "Organizational strategies for adjusting to the economic crisis in Portugal, Spain and Greece."). The RG is also present in multiple (inter)national networks (e.g. Re-search Committee 07 "Futures Research", International Sociological Association; Research Committee on Sociology of Law, European Social Network; COST Action ISCH IS1001 - Bio-Objects and their Boundaries). Regular seminars promote closeness and dialogue between the RG's members. The creation of the CIES-UBI pole at Beira Interior University has enriched the RG with new scientific foci, namely the relationship between work and gender equality.

The Research Group “Modern and Contemporary History” is composed of 11 integrated PhD researchers, 6 associated researchers and 7 researchers with PhD scholarships and other re-search assistants.

The researchers of this group came from ISCTE's Centre for Studies in Contemporary History (CEHC), which was incorporated into CIES-Iscte as a RG in 2015. The Group conducts research in History from the early modern to the modern and contemporary periods. It is heterogeneous in terms of age, gender and topics of study, and this produces synergies between the different areas. As a whole, the researchers prefer a transnational approach to the different topics of research, a perspective

that make it easier to work with international research networks in projects such as "Land, Power and Territorialities in Portuguese America". This kind of approach also enable some of its re-searchers to take part in international associations like the Commission Internationale pour l’Histoire des Villes, the Associação Ibérica de História Fer-rovária, the Association d’Histoire des Sociétés Rurales, and the International Commission for the History of Universities. This is also reflected in participation in international publications in indexed journals or books and attendance at and arrangement of colloquia designed to bring Portuguese issues into international narratives. The Group also seeks to train new researchers, supervising around 30 PhD candidates whose research topics also add to the diversity of RG6's areas of study. The Group coordinates, and gives lectures for, the PhD in Modern and Contemporary History, and also participates in other PhD courses, such as PIUDHist (Universities of Lisboa, Évora and Católica), which reflect its openness to new researchers and topics. In orienting its research work, RG6 constantly seeks conceptual and methodological innovation, an international framework and social meaning.

Overall research indicators

Research projects

Research is the central element of activities at CIES-Iscte and is undertaken as part of projects performed by research groups.

The fundamental research projects at the Centre are funded by public calls with scientific assessment issued by public and private, Portuguese and European agencies and foundations and applied research projects and knowledge transfer activities with consolidated scientific skills.

One of CIES-Iscte's essential distinguishing features is that researchers can propose research projects and other scientific activities independently. This culture of initiative and cooperation is a firmly established practice. To a great extent, it is the source of the centre's ability to respond to the opportunities and challenges in research and enables us to place emerging, socially and scientifically relevant issues on the research agenda.

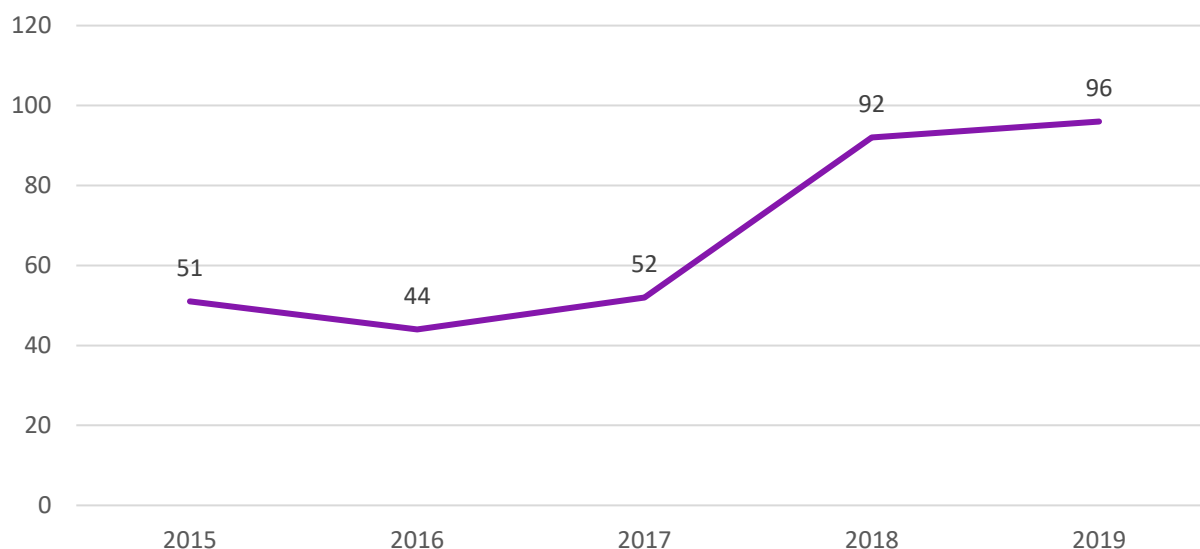
This practice is obviously encouraged among the younger generations working in the research group at CIES-Iscte or in cooperation with researchers from other groups.

Researchers often participate in the activities of more than one group.

There had been an upturn in the number of funded projects from 2017 to 2018, going from 52 to 92. In 2019 the level of projects was maintained with a slight increase. This improvement was due to national and international funding. Finance came from the FCT, other Portuguese public bodies such as ministries and local authorities, private organizations, the social sector and funding from the European Commission and other European institutions.

This success was due to a combination of public recognition of the quality of our research, the competitive bids submitted by the team in answer to external requests and the impact of CIES-Iscte's dissemination and transfer of knowledge to society.

Publications

Publication is a core element of the Centre's scientific activity, as it is a way of disseminating the results of its work to the scientific community and society.

Recent years have shown a transition in the publication pattern of the team of researchers at CIES-Iscte. It has been increasingly aligned with international trends towards publication of articles in indexed journals as opposed to books or book chapters.

In spite of this progressive increase in articles in indexed journals in Scopus and the Web of Science (WoS), CIES-Iscte researchers managed to keep a balance between the different types of publications, thereby ensuring the presentation of results to the international scientific community and dialogue with Portuguese society.

The number of publications reached 487 in 2019. The rate of publication in indexed journals has increased (149, the highest rate ever) with a progressive quality enhancement as a result of the increase in the number of articles published in journals indexed in the JCR/WoS (86) and Scimago/Scopus (106) databases. There also continued to be a large number of publications of books, including chapters and authorship and coordination of books.

Under Other Publications, 188 are peer-reviewed (publication in proceedings of

scientific events, articles in not indexed peer-reviewed journals, working papers; project reports, reviews in journals) and the remaining include forewords, afterwords, non-peer-reviewed articles, and other publications.

The ratio of publications per full-time equivalent researcher are maintained concerning books and book chapters, and has risen to 2 publications by FTE researchers of integrated PhDs with regard to articles in indexed journals, a target achieved for the first time.

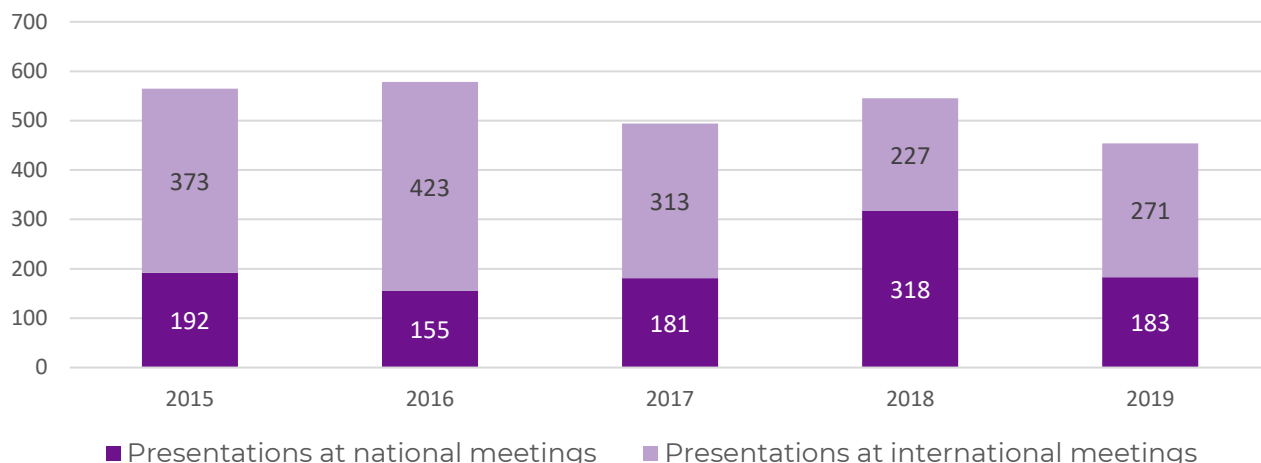

Another aspect of the Centre's scientific work is presentations at scientific meetings. In 2019, 454 presentations were given in national and international meetings.

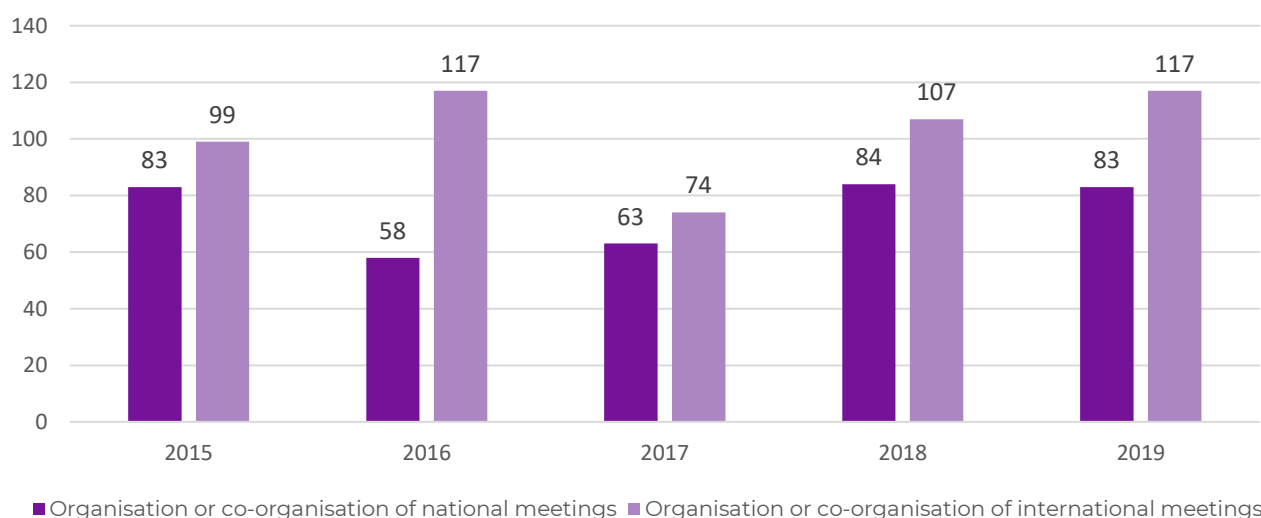
Presentations at scientific meetings (2015-2019)

Observatories and Laboratories

CIES-Iscte fosters a number of permanent research observatories and laboratories in scientific relevant areas promoting public debate on pertinent issues in each area. The Inequality Observatory (OD) and the Emigration Observatory (OEm) have over a decade of existence and have achieved growing scientific and social recognition. Recently other three research platforms were created within the framework of CIES-Iscte: The Portuguese Observatory on Cultural Activities (OPAC), the Laboratory for the Social Studies on Childbirth (nascer.pt) and more recently the Observatory for Democracy and Political Representation.

CIES-Iscte is also an honorary member of the Communication Observatory (Obercom), which analyses and assists in public policies, sector companies and academic research in communication sciences. The Family and Family Policy Observatory (OFAP) furthers and disseminates knowledge about families and family policies in Portuguese society under a partnership between ICS-ULisboa, its scientific coordinator, and CIES-Iscte.

CIES-Iscte also integrates the Collaborative Laboratory for Work, Employment and Social Protection - CoLABOR, that was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

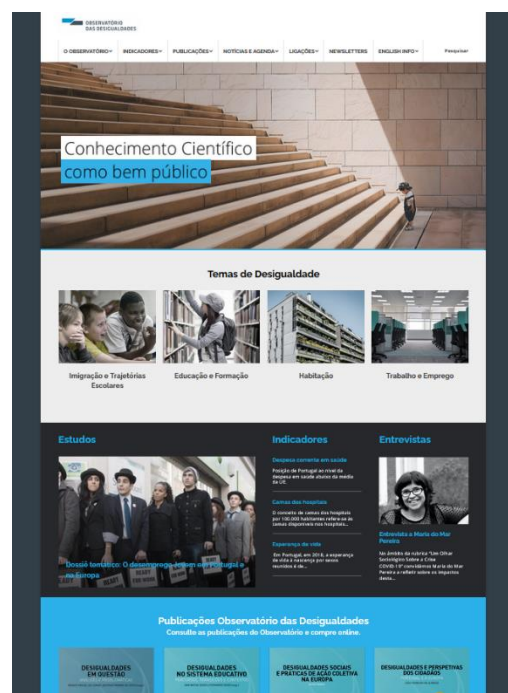

CIES-Iscte is responsible for the operation and scientific coordination of the Inequality Observatory (OD) having as partner institutions, since its initial phase, the Institute of Sociology (Instituto de Sociologia) of the Faculty of Arts of the University of Porto (ISFLUP) and the Centre for Social Studies (Centro de Estudos Sociais) of the University of the Azores (CES-UA, today CICS.NOVA.UAc). The OD studies different aspects of inequality. It conducts international comparisons of statistical indicators and a wide range of constantly updated studies and research.

In its implementation phase in 2008, it received the support of the Presidency of the Council of Ministers, the Ministry of Labour and Social Solidarity and the Ministry of Education. Since then it has been supported exclusively by CIES-Iscte. In addition to fostering scientific knowledge in this area, the OD's mission is to publish accurate, up-to-date information on inequality from the viewpoint of citizenship and a contribution to the justification and assessment of public policies. This means that it is a tool for research and scientific dissemination. It is a founding member of the European Inequality Watch network, which involves similar observatories and other institutions from different countries.

In 2019 a new version of the website of the Inequality Observatory was launched with contents about social inequalities, such as interviews, studies, working papers, reviews, indicators, glossary of indicators, links to other sites, etc. With this renovation it is now possible to explore the information in an interactive way, namely through the graphs, which allow one or more categories to be selected or the countries to be analysed. Inequality Themes were also created, which allow the various data and types of information to be aggregated, giving more focus to the selected topics. In an initial phase, four themes were put forward, in which an attempt is made to go deeper into indicators, studies and other contents: Immigration and School Paths; Education and Training; Housing; Work and Employment.



The OD regularly promotes events with academic specialists, representatives of public bodies and of civil society organizations. In 2019, an event was organised under the title "Work, social protection and inequalities: what future for public policies?".



In addition to updating all existing indicators, in 2019 new indicators were developed, such as: Retention and dropout of school rate; Approval rates of national and foreign students in primary and secondary education levels; Debtors with overdue credit from loans granted by the financial sector to households; Severe rate of deprivation of housing conditions; Financial incapacity to keep the house sufficiently warm; Overcharge rate on housing expenditure; among others.

During the year, the study "The students of foreign national in the Portuguese educational system: enrollment and teaching methods" was carried out and the regular activities of the OD were maintained, such as interviews (João Teixeira Lopes, president of the Portuguese Sociological Association, regarding his book "

Middle Classes in Portugal: Who they are and how they live" and the publication of working papers in the OD series, such as the one by Jorge Caleiras: "Between Retreat and Mitigation: Paths and deviation of Employment Policies in Portugal in the last decade".

Emigration Observatory

The Emigration Observatory (OEm) is an independent technical and research structure integrated in the CIES-Iscte. The Observatory functions on a partnership of the following university institutions of research: the Centre for Research and Studies in Sociology (CIES-Iscte) of the University Institute of Lisbon (Iscte), which ensures the coordination of the partnership; the Centre for Geographical Studies (CEG) of the Institute of Geography and Spatial Planning of the University of Lisbon (IGOT-UL); the Centre for Research in Economic and Organizational Sociology (SOCIUS/CSG), of the Institute of Economics and Management of the University of Lisbon (ISEG-UL); the Institute of Sociology (IS-UP), of the Faculty of Arts of University of Porto. Its interdisciplinary research team has the support of a Scientific Committee made up of specialists from Portuguese universities.

The main objective of OEm is to collect, harmonise and analyse information on the evolution and characteristics of Portuguese emigration and emigrated Portuguese populations, in particular, by collecting data from the statistical institutions of the countries of destination of emigration. The objectives of the Observatory are also: to disseminate all the information compiled and promote their availability and discussion to the general public, in particular to researchers, technicians, students, policy makers and journalists; contribute, through its activity, for the definition and evaluation of information-based public emigration policies and knowledge about this policy area.



OEm is a pole of other initiatives, such as the Migration Network, which includes 350 researchers from different countries, and is also the interlocutor of other national and international observatories and collaborates regularly with the media.

The main instrument of daily relationship with OEm audiences is its website, regularly

updated and progressively extended to cover all activities resulting from the achievement of the objectives for that was created. The scientific production of OEm is available on the website referred to, under access open and in three languages (Portuguese, English and French, the latter still being updated), and disseminated through a newsletter.



Briefly, the regular OEm publications include: OEm Conversations With... (nine issues published so far), OEm Country Reports (four issues), OEm Fact Sheets (eight issues), OEm Working Papers (four papers), several of which published in 2019. OEm prepares and publishes an annual statistical report since 2014, partially integrated in the annual report under the responsibility of the Office of the Secretary of State of the Portuguese Communities, presented at the national Parliament. A summary of each report is published annually in English (Portuguese Emigration Factbook).

OEm also holds national and international scientific meetings, namely within the

partnership Monthly Meetings of Migration Experiences (two in 2019: “Undocumented migrants health and access to care in Sweden” and “Violence, trafficking and humanitarian action”). In the context of the commemoration of the 10th anniversary of the OEm, in 2019, a first conference was organised on the theme of “Migration and the Welfare State”, having as keynote speaker Professor Jean-Michel Lafleur of the University of Liège. The event "Perspectives on Migration: political action and civic engagement" was also organised by OEm in 2019, through a partnership with the Portuguese and German Ministries of Foreign Affairs and the European Academy Berlin.



The set of activities carried out by OEm also support advanced training. In 2019, three curricular internships were held for undergraduate students: an intern of political science developed statistical research on the Portuguese in South and North America; an intern of sociology worked on the demographic characterization of the Portuguese who recently arrived in Brazil; and a political science intern analysed the media and the elections.

Portuguese Observatory on Cultural Activities

The Portuguese Observatory on Cultural Activities (OPAC) was launched in 2018 within the framework of CIES-Iscte, which is responsible for its scientific coordination and functioning. Its main goals are to ensure the development of accurate and up to date research and public availability of studies and information related with various cultural domains and themes aiming to contribute to current debates in Portuguese society and the formulation, monitoring and evaluation of public policies. Despite the strong emphasis on Portuguese reality, OPAC also has a transnational comparative perspective, particularly within the EU.

In 2019 the activity focused on the constitution of guiding and public visibility tools (in particular the website), the constitution of the advisory board and the team of researchers, the launching of research projects and a range of cultural indicators.



In 2019 the results of the “National Museums Visitors Survey” were presented for nine museums - House-Museum Dr. Anastácio Gonçalves, National Museum of Contemporary Art - Museum of Chiado, National Museum Grão Vasco, Monographic Museum of Conimbriga - National Museum, National Museum of Music, National Coach Museum, National Museum of Ethnology, National Museum of Theatre and Dance and National Costume Museum. In this project, commissioned by the General Directorate of Cultural Heritage - Ministry of Culture (DGPC/MC), a leaflet (printed and online) was published and public events to disseminate the results were made for each museum.



Four other research projects were also ongoing in 2019: "Diagnosis and characterization of the DGPC and DRC museums", commissioned by DGPC/MC within the Museums in the Future Project Group; “From safeguard to valorization: National Monuments in Portugal and visitor's access”; "Loulé, Territories, Memories, Identities - Exhibition at the National Museum of Archaeology",

commissioned by the Municipality of Loulé; "Social Profiles and Professional Practices of ICOM Portugal Members", a partnership OPAC/ICOM – Internacional Council of Museums Portugal.

Regarding the organization of events, the initiative "Culture in political party programs" was promoted in September 2019 with representatives of all parties with parliamentary representation in the 2015-2019 legislature (BE, CDS, PAN, PCP, PS, PSD).

Laboratory for the Social Studies on Childbirth – nascer.pt

The Laboratory for the Social Studies on Childbirth (nascer.pt) is a permanent research unit launched two years ago and hosted by CIES-Iscte. Its aim is to foster knowledge about the conditions and characteristics of childbirth in Portugal, to contribute to the consolidation of the Sociology of childbirth and, at the same time, to develop synergies between structures and multidisciplinary approaches in the study of childbirth, both at national and international level.



Throughout the year of 2019, different activities were developed aiming at a set of interlinked objectives for the development, discussion and dissemination of scientific knowledge about birth: the consolidation and enlargement of the team of collaborators (currently with 33 members); the participation in regular scientific meetings with specialists from different scientific areas; the edition of an e-book with the proceedings of the Conference “Birth and Other Debates: Gender, parenting

and creation”; the construction of the Laboratory's website (design and contents); the hosting of two undergraduate students trainees, who developed research and communication activities.

Observatory for Democracy and Political Representation

The Observatory for Democracy and Political Representation is an innovative initiative combining three core analytical levels of research at CIES-Iscte: society, political system and public policies. The launch session took place in March and the main activities in 2019 focused on two major tasks: the construction of the Observatory website, including the collection of data on relevant research projects to be made available; and the preparation of the surveys to be carried out to candidates for Members of Parliament and elected Members.



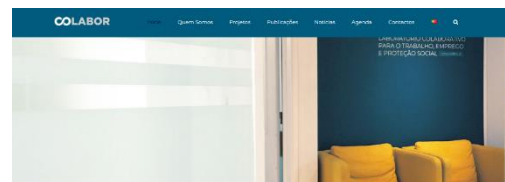

The Collaborative Laboratory for Labour, Employment and Social Protection (CoLABOR) was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

With nine partners and a multidisciplinary team of highly qualified researchers CoLABOR mobilises resources from academia, companies, and third sector institutions, having four central objectives: to support the design and restructure of policies in their thematic areas; capacity-building of institutions, including public administration, businesses and institutions in the third sector; to qualify employment through training and the creation of scientific jobs; contribute to public debate in the areas of work and social protection, through effective and innovative forms of dissemination of the results of the research it carries

CoLABOR achieves these objectives through an ambitious agenda of deepening scientific knowledge around three central thematic axes: work and employment; social protection and social facilities and responses. Across these thematic areas, CoLABOR is developing the DataLABOR digital platform, dedicated to the dissemination of statistical and legal information focusing on the areas of labour, employment and social protection.

PhD programmes coordinated by CIES-Iscte

CIES-Iscte currently coordinates a total of four PhD Programmes (Sociology, Public Policy, Communication Sciences, Social Work).

The programmes have a duration of three years. In the first year, the students attend seminars on theories and methods, as well as optional curricular units. In the other two years, they prepare their PhD thesis, carrying out research at CIES-Iscte. Complementarily, they attend a Doctoral Seminar, the International Cycle of Doctoral Conferences and the Doctoral Colloquium.

PhD students regularly participate in the activities promoted by CIES-Iscte and are encouraged to publish the results of their research in stages and to participate in national and international debate activities. The Centre's support structures ensure the necessary follow-up, both in the administrative management of the students training path and in their research activities. In this context, CIES-Iscte supports PhD students or candidates in the preparation of applications for scholarships

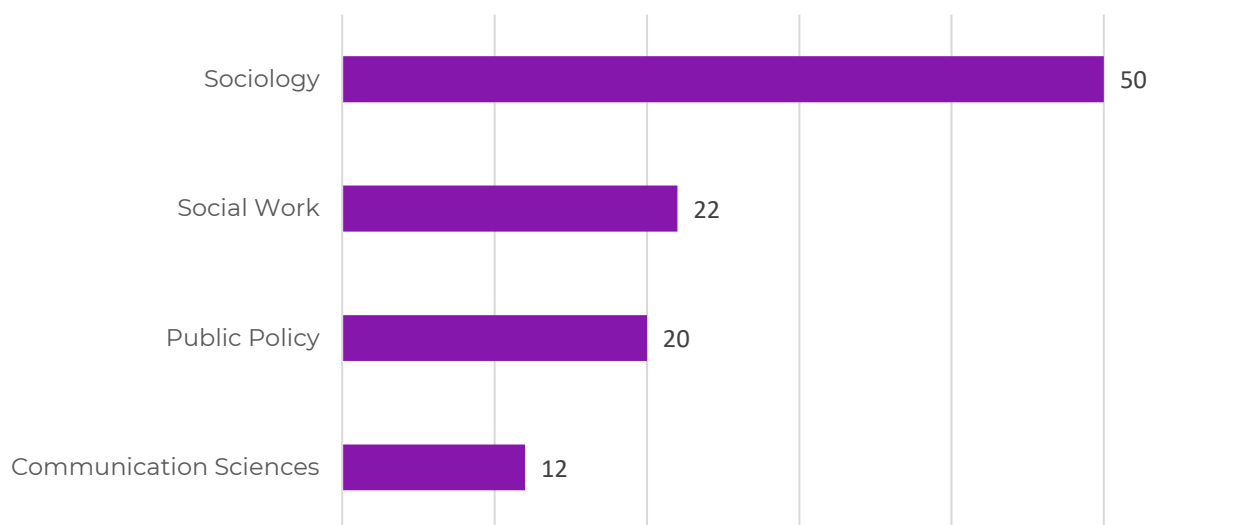
from the national Foundation for Science and Technology (FCT), the Iscte and other funding institutions.

PhD students also have access to specialised software (SPSS, MAXQDA, Qualtrics, etc.), to Iscte laboratories (namely, the Laboratory of Communication Sciences and the Computer Laboratory), and to the Iscte Library and access to the Online Knowledge Library (b-on), which provides access to the full text to thousands of journals and ebooks of the main international scientific publishers. Doctoral students with exclusive dedication and scholarships are offered a working space in a shared office.

The PhD programmes coordinated by CIES-Iscte have registered a high demand every year, which often exceeds the number of vacancies available.

In 2019, 24 doctoral theses were defended by students of the PhD programmes managed by CIES-Iscte.

Other advanced training activities

Summer schools

In 2019, the 8th edition of the [European Drugs Summer School](#) - Illicit Drugs in Europe: Demand, Responses and Public Policies, with special focus on “prisons” subject, took place at Iscte on June 24th to the 5th of July 2019. The summer school was held with the co-organization of CIES-Iscte and IPPS-IUL/Iscte, with the collaboration of the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) and NIDA (International Programme), in which 42 students from 26 countries participated.



Research internships

Another activity that links research and advanced training at CIES-Iscte are the Research Internships, under which undergraduate, master and PhD students are hosted in ongoing research projects.

In 2019, 23 trainees were hosted: 12 undergraduates, 10 master and 1 PhD students. Trainees are integrated in the research team and are supervised by the research project coordinator of which they are part. In addition to participating in different activities of the research project they may use empirical data produced by these projects for the purpose of carrying out research, master's or PhD theses.

CIES-Iscte Research Workshops fortnightly



These research workshops are regular meetings for the presentation and discussion of processes, methods and results of social science research. CIES-Iscte held 13 workshops in 2019.

International Cycle of PhD Conferences annual



The ESPP International Cycle of PhD Conferences takes place throughout the year and includes lectures organised as part of the

school's doctoral programmes in Political Science, Communication, African Studies, History, Defence and Security Studies, Public Policies, Social Work and Sociology.

The speakers are internationally renowned specialists and many of the lectures are the result of the partnership between the different programmes.

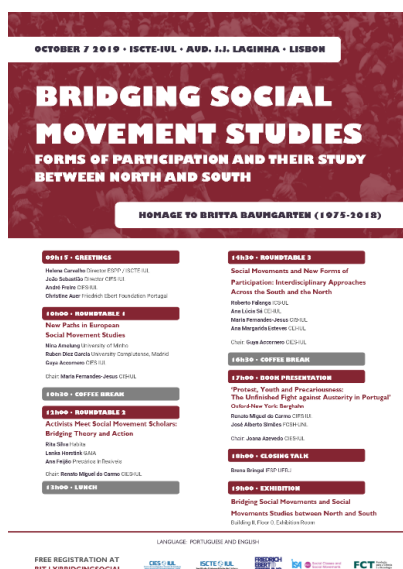
Monthly seminar on social movements and political action

These seminars began in 2014 and foster multidisciplinary reflection on social movements and different forms of political action, militancy and activism. They are designed to start an in-depth, ground-breaking debate on different perspectives, methodologies and approaches. They take advantage of Portugal's geographic, linguistic and epistemological position to cross-reference different European, North American and South American traditions of studies on social movements and political action and cover cases and areas that are often excluded from these studies, such as Portuguese-speaking African countries.

There were eight seminars as part of this initiative in 2019. The October seminar paid homage to Britta Baumgarten (1975-2018), co-

founder of this initiative and researcher of CIES-Iscte.

The session featured the presentation of the book “Protest, youth and Precariousness: the Unfinished Fight against Austerity in Portugal” and an exhibition of the past seminars’ posters.



Group Interpretation Workshop

This workshop was set up to discuss, nurture and disseminate advanced methodological skills in the CIES-Iscte team. Group interpretation as a form of triangulation is used in qualitative social research to achieve a deeper, more complex understanding of the subject and also a crucial discursive way of ensuring inter-subjective transparency during the research process. Three workshops were held in 2018.

Biography and Trajectory Seminars Cycle quarterly

Meetings about Migration Experiences

The MIGRA network and Emigration Observatory (OEm) organise these meetings. Their main goal is interdisciplinary exchanges on studies of international migration. Each meeting focuses on specific ongoing or completed work and research and cross-references practices and questions on methodologies and theories. Two meetings of this nature were held in 2019.



This cycle of seminars propagates the work of Portuguese and foreign researchers who use a biographical approach or use life course methods. It stimulates reflection on the collection, construction and interpretation of reports and biographical timelines and may set up research networks in the study of

biographies, life paths and social trajectories. Three seminars were held in 2019.

New Perspectives on Modern History

Through the presentation of some ongoing projects, developed by Portuguese and foreign historians from various universities, specialties and generations, this cycle of seminars allows to know the current trends of research in Modern History: the topics currently more developed, the main problems in focus, the new methodologies, the sources used, the new interpretations that are being produced.

The New Perspectives in Modern History cycle has been running regularly at Iscte since 2005, aimed especially at master's and doctoral students from the History Department, but open to all interested parties. 5 sessions took place in 2019.

Leituras ETNO.URB

The Leituras ETNO.URB [ETNO.URB Readings] are a series of discussion sessions around works and texts in Urban Ethnography, starting from an individual reading. The sessions are presented by members of the ETNO.URB network that includes researchers in social sciences organized around Urban Ethnography,

based in Portugal and with a strong presence in Brazil. The sessions take place in the various institutions where the members belong and there were 10 in 2019.



Other important discussion activities

Every year the CIES-Iscte team members organise many events. In addition to these regular initiatives, some of the events with the highest international impact in 2019 that took place at CIES-Iscte/ISCTE-IL were the following:

Military Studies in post-truth society: challenges and perspectives

15th Biennial ERGOMAS Conference

European Research Group on Military and Society (ERGOMAS) is an international scientific association of social scientists who study and analyze the relationship between the military and society. The 2019 conference took place at Iscte from the 17th to 21st June with David R. Segal as keynote speaker and the

attendance of over 200 participants from all over Europe and beyond.



Black In/Visibilities Contested:

7th Biennial AfroEuropeans
Network Conference

The 7th Biennial AfroEuropeans Network Conference is an important platform for the production of knowledge in the pertinent field of transdisciplinary research on racism, black cultures and identities in Europe. This dialogue and networking was promoted through keynotes and panels, round-tables, individual speakers and a rich set of artistic and cultural activities. The Conference was held at Iscte on July 2019, and gathered around 300 participants from all over the world.



Media Literacy in a Media Rich Ecology

International Conference

In association with the European project MediaCoach Initiative, Iscte and CIES-Iscte hosted in December this international conference aimed not only at the scholar community but also at non-profit organizations and activists related to the media literacy thematic.



FAMELAB Iscte

International Science
Communication Contest

FAMELAB is one of the biggest International Science Communication Contests and is supported by the British Council. In Portugal, this initiative is organized by Agência Ciência Viva. Iscte and its research units organized for the first time in 2019 a regional playoff that selected 4 candidates for the national competition. The winner went on to compete

on the international contest at the Cheltenham Science Festival.



Ciganos em Portugal, Espanha e Brasil: Analisando contextos, demandas e processos identitários

International Seminar

CIES-Iscte, in partnership with APS (Portuguese Association of Sociology) and the Federal University of Pernambuco, organized this international seminar hosted at Iscte. This initiative gathered academics, activists and political and institutional actors from Spain, Brazil and Portugal to discuss the contexts of gypsies in these countries as well to analyse research challenges in this area of study.



Urban Audiovisual Festival

Urban Mobilities

UAF emerges as a place for discussion and dialogue between professionals who work on urban life. This scientific meeting aims to promote the production of quality and the dissemination of the audio-visual work carried out by researchers and filmmakers in the field of urban studies, as well as other related disciplines. The 2019 edition took place at Marvila’s Library, Lisbon and showcased 14 selected works from international filmmakers

Promotion of Scientific Culture

The development of initiatives promoting scientific culture has been one of the Centre's concerns since it was founded and researchers have participated actively and regularly.

CIES-Iscte is a subscriber of science proximity initiatives organised by Agência Ciência Viva. They are Science and Technology Week and school-holiday scientific activities for young

people. CIES-Iscte has also participated regularly in the European Researchers' Night, which is funded by the European Commission.

The centre's research team members also undertake other activities promoting scientific culture, including events for the general public, scientific articles, participation in TV programmes, book releases, etc.

Science and Technology Week and Science in the Holidays for Young People

Science and Technology Week and the Science in the Holidays for Young People programme enable young people to come into contact with everyday life, people, projects and methods at a research centre as part of the research conducted by CIES-Iscte researchers.

In 2019, for the 20th year in a row, CIES-Iscte organised an event in Science and Technology Week, promoted by Agência Ciência Viva, in which 60 upper secondary school students spent time with researchers and projects at the centre.



CIES-Iscte also set up the 15th internship as part of school-holiday scientific activities for young people in collaboration with *Agência Ciência Viva* in 2019. 4 secondary students were hosted for two weeks.

The internship aims to provide a first contact with the daily life of a research centre in social sciences, its spaces, protagonists, projects and methodologies.

In 2019, CIES-Iscte once again opened its doors to young people interested in getting to know and experience the activities inherent to social science research, under the guidance of the Centre's members: Rita Mourão, Mara Clemente, Ana Pinto Martinho, Décio Telo, José Moreno, Daniel Malet, Rita Cachado, Carlota Veiga, Ana Rita Capucha, Inês Santos Tavares, Anne Schippling, Inês Casquilho Martins and Vanessa Figueiredo.

The participants also had the opportunity to get to know the Nucleus of Sociology Students of Iscte (NESISCTE).

In addition to the presentation of the Centre and the surrounding university context, we sought to provide a practical and diversified notion of what social sciences research is all about. To this end, the trainees were integrated into research teams with ongoing projects on various themes, experimenting with different data collection and processing techniques, as well as different ways of presenting and disseminating scientific results.

The internship came to an end with a Focus Group session in which students of the same nature of the Centre for International Studies participated, in a synergy of the two R&D units of the School of Sociology and Public Policy of Iscte.



Science in the Holidays for Young People "To be a Social Scientist for 15 days"

European Researchers' Night

European Researchers' Night is funded by the European Commission (Marie Curie Actions). Its activities took place throughout the year and culminated in a night of celebration of science, which brought researchers and public closer together in a number of European cities on the last Friday in September.



CIES-Iscte is a member of the SCILIFE - Science in Everyday Life Consortium and was responsible in 2019 for the activity “On the Wheel of Cultural Heritage” that was held at the Portuguese Science and Natural History Museum at Universidade de Lisboa.



CIES-Iscte was present in this edition through one of its structures: the Portuguese Observatory of Cultural Activities (OPAC).

Our researchers received dozens of visitors whom, through interactive games, were challenged to test their knowledge about Cultural Heritage and reflect on the importance of its safeguarding and appreciation.



The activity “On the Wheel of Cultural Heritage” was prepared and put to practice by the OPAC and CIES-Iscte researchers José Soares Neves, Ana Paula Miranda, Maria João Lima, Sofia Macedo and Sónia Apolinário.

Publishing Activities

CIES-Iscte has published the scientific journal *Sociologia, Problemas e Práticas* (SPP) since 1986. The centre has had its own publishing house, *Mundos Sociais* since 2010. It publishes the SPP journal and peer-reviewed social science book collections. The centre also belongs to consortiums that manage the indexed journals *Portuguese Journal of Social Science* (PJSS) and *Observatório* (OBS*) and publishes the CIES e-Working Papers.

CIES-Iscte actively follows an open science policy. SPP articles and the CIES e-Working

Papers are available to everyone in the RCAAP (Open-access Scientific Repositories in Portugal).

CIES-Iscte was a pioneer at Iscte in providing open access to its publications at the Iscte repository. It has been its largest contributor of scientific documents (about 2500 deposited). The centre is a founding member of the Portuguese Social Information Archive (APIS) and Production and Archive of Social Science Data (PASSDA) which stores and shares data produced in social science research projects.

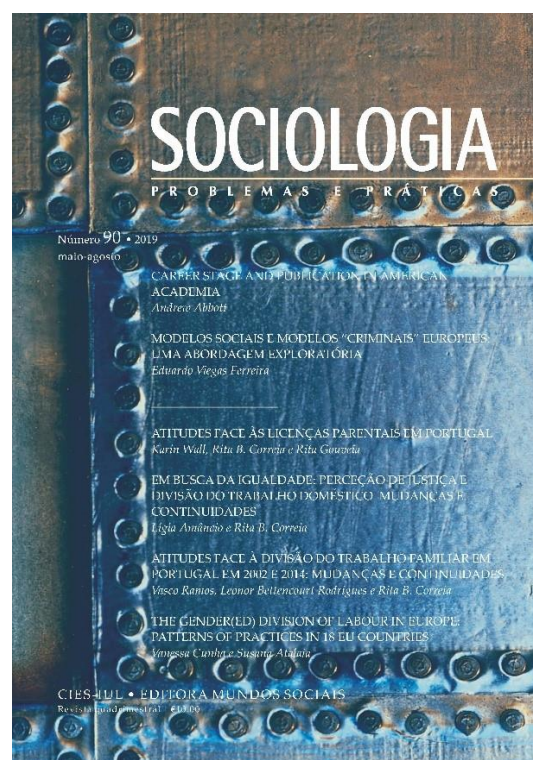
[Sociologia, Problemas e Práticas](#) is a scientific journal whose main purpose is to publish sociological analysis articles resulting from original research, the development of theory, or thematic evaluation. It also accepts papers from other social science areas, where there is an interdisciplinary interest. It is directed towards an international audience, publishing articles in Portuguese, English Spanish and French, by authors from various countries. The journal's editorial stance is governed by principles of scientific quality, paradigmatic pluralism and social relevance. It aims to ensure that the articles published make a

significant contribution to the advance of knowledge. Articles submitted for publication undergo a blind independent review by at least two recognised specialists drawn from a range of countries. The journal *Sociologia, Problemas e Práticas* was established in 1986, since when it has been published without interruption. It is indexed in various international bibliographic databases.

[Sociologia, Problemas e Práticas](#) remained on track in 2019 and its three annual numbers (nº 89, nº90 and nº91) were published regularly and punctually.

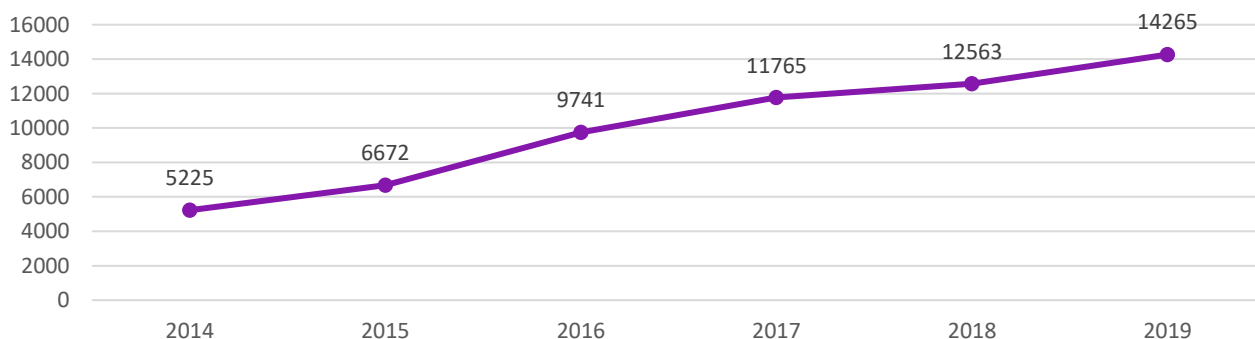

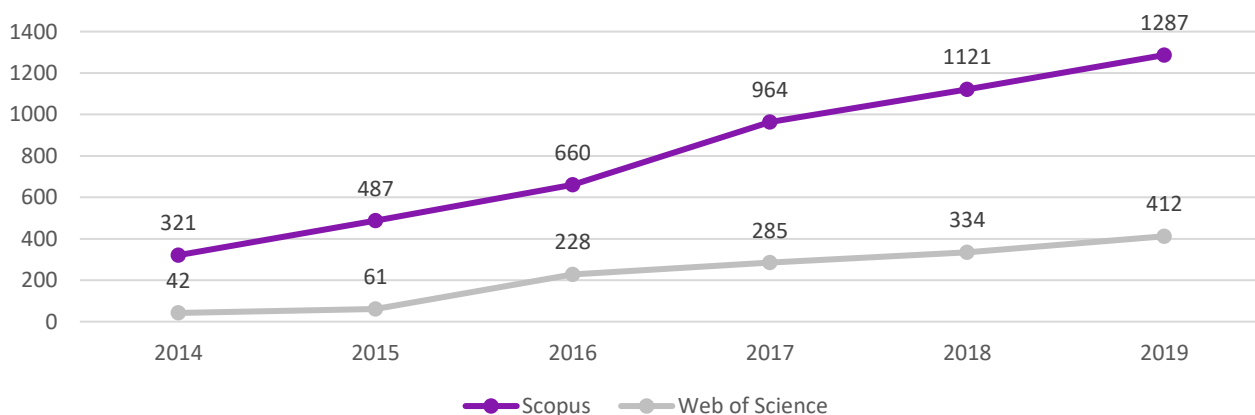
The inclusion of [Sociologia, Problemas e Práticas](#) in indexed online platforms and the visibility that they afford the journal increase quotations from its articles. Portuguese Journal of Social Science and OBS*

CIES-Iscte is part of the consortiums that publish the journal Portuguese Journal of Social Science and the e-journal OBS*.

[Portuguese Journal of Social Science](#) (PJSS) is published by Intellect and is managed by a consortium formed by Iscte – Instituto Universitário de Lisboa and three of its research units: CIES-Iscte, CIS-Iscte and DINÂMIA'CET-Iscte. In 2019 a researcher of the CIES-Iscte team, Nuno de Almeida Alves, was appointed Editor of the journal.

PJSS is indexed in the following databases, among others: SCOPUS (currently Q3 in the Scientific Journal Rankings (SJR) of Scimago), Capes-WebQualis, Cambridge Scientific Abstracts, ISBSS, Sociological Abstracts, Worldwide Political Science Abstracts, Latindex, EBSCOhost.

In 2019, the three issues of volume 18 of the journal were published.

The journal [OBS*](#) is published within the scope of the collaboration of CIES-Iscte and OberCom (Communication Observatory), being an interdisciplinary journal, open to contributions from disciplines related to communication studies, which publishes articles in English,

Spanish, Italian, Galego, French and Portuguese, in open access. The journal is indexed in several databases, such as Scopus Elsevier/Scimago, ERIH-PLUS and SciELO. In the Scientific Journal Rankings (SJR) of Scimago, the journal is now established in Quartile 3 and is placed in 2nd place among the Portuguese journals in the area of Communication.

In 2019, the OBS* journal maintained the course of its activity ensuring the regular and timely publication of its 4 annual issues.

CIES-Iscte e-Working Papers

The main goal of the [CIES e-Working Papers \(e-WP\)](#) series, initiated in 2005, is the publication of scientific papers in electronic format that result from research developed by CIES-Iscte researchers, as well as by researchers who collaborate with members or activities of the Centre.

They are available, in OpenAccess, in the [Iscte Library Repository](#), where they can be searched by date, author, title or theme.



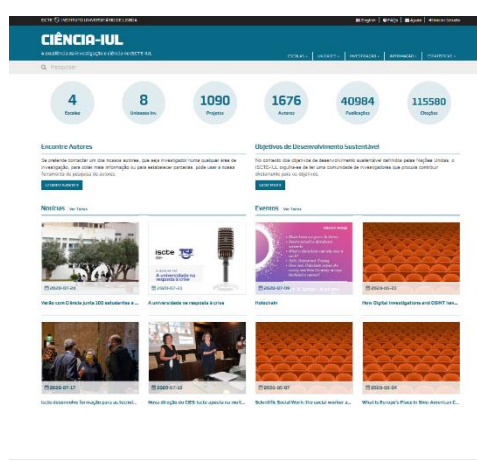
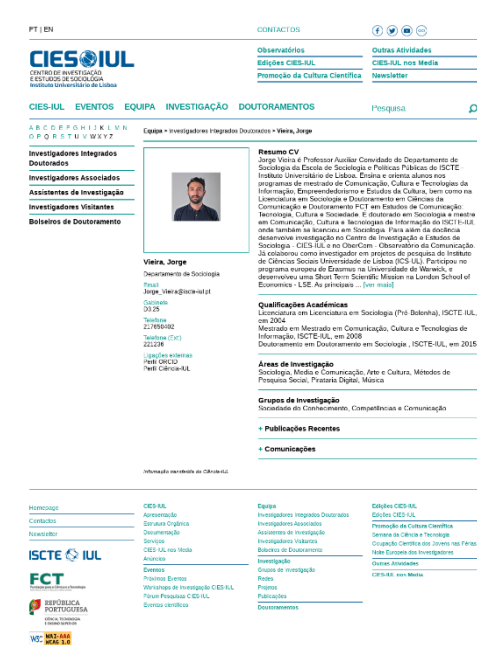

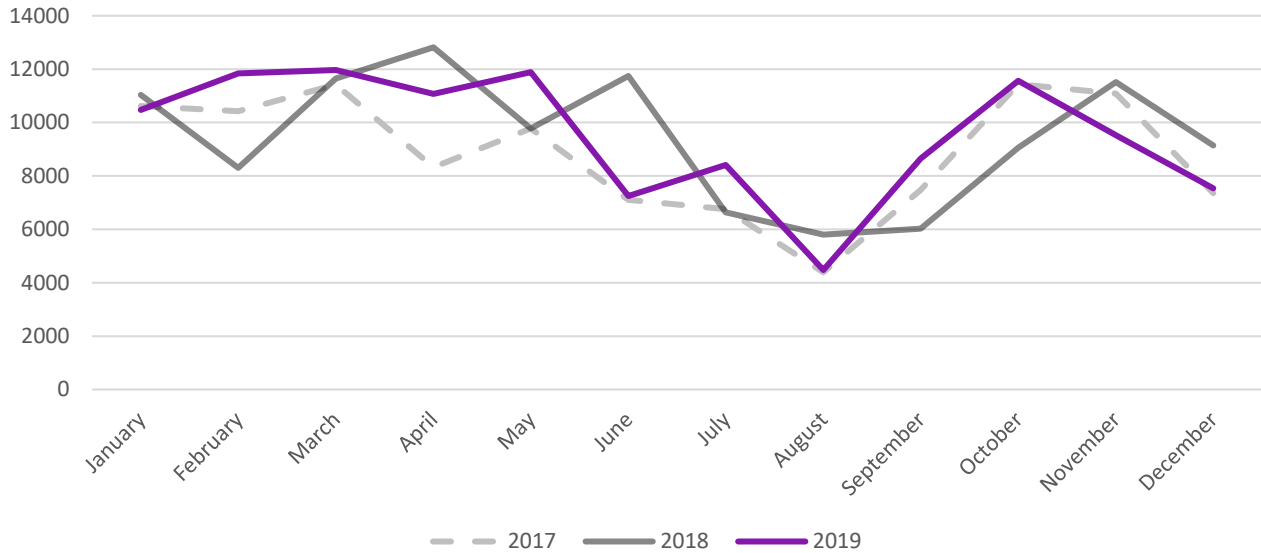

N° of Page Views

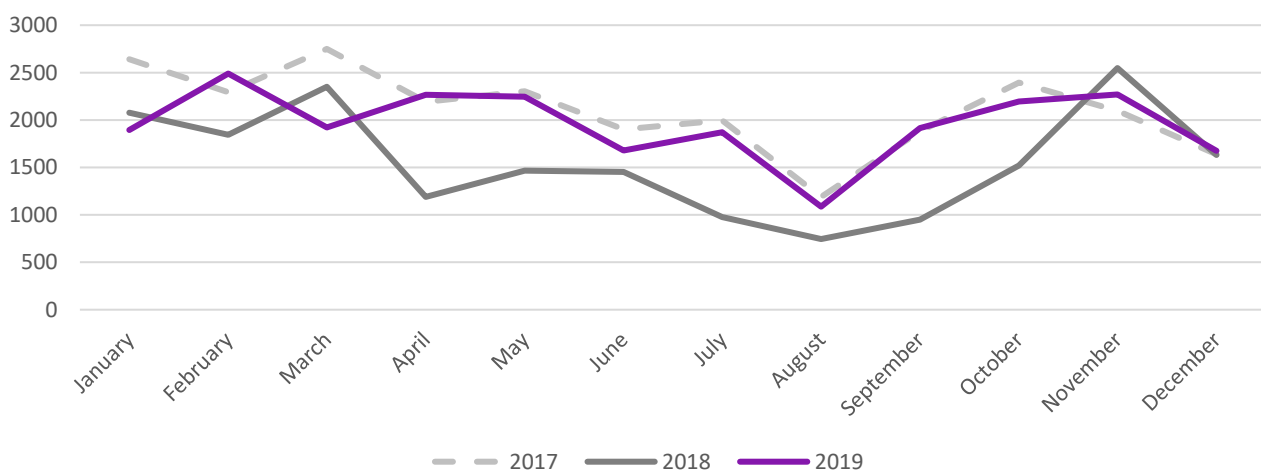

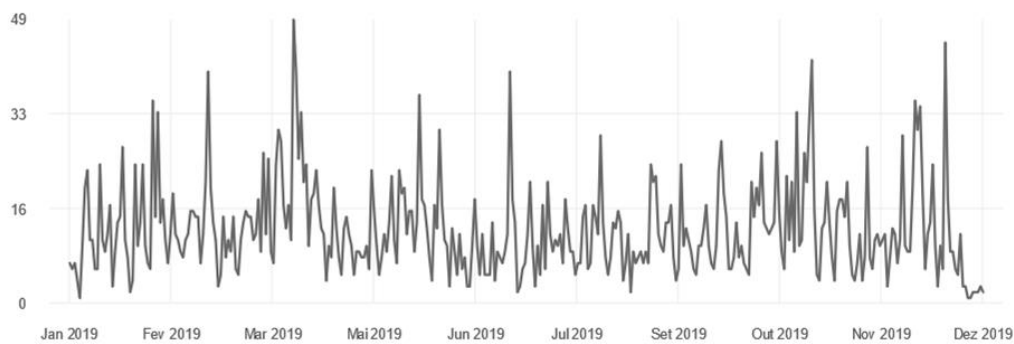

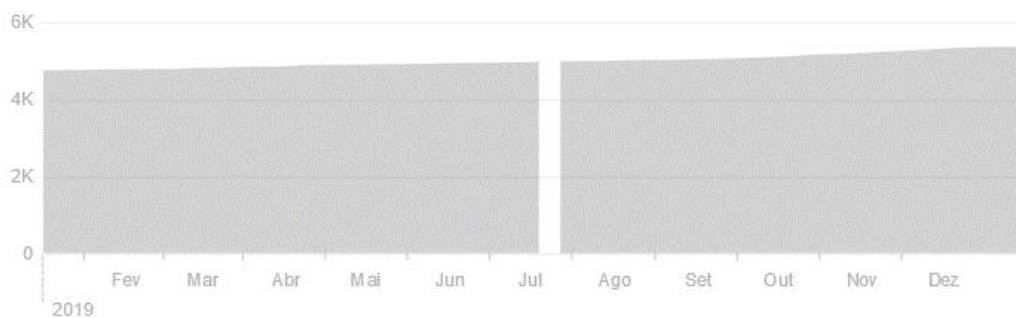

Sources of Funding

Although FCT is the major source of funding, CIES-Iscte has been able to maintain a high level of funding from various other actors in the Portuguese and European research arena, namely, Portuguese public bodies, local authorities, Portuguese private institutions and the European Union. The vast majority of funds allocated to CIES-Iscte arrive from competitive calls, which guarantees the quality of CIES-Iscte grant proposals and research.

Overall budget had a significant increase, mainly due to the FCT program for scientific employability, reflected in the major increase of the budget allocated to the recruitment of contracted researchers.

Private institution's funding has also increased significantly, showing a successful engagement

of these important actors in the scientific research of CIES-Iscte.

The apparent decrease in European Union funding is the effect of the payment cycles of the EU grants, with significant amounts being transferred in the pre-financing, together with the Grant agreement signature and then a period of usually 1.5 years until the next payment.

Regarding indirect funding and as a direct result of the FCT program for scientific employability already mentioned, FCT Post-doctoral fellowships showed a major decline. The FCT PhD fellowships showed however an increase, representing now 86.2% of the FCT indirect funding to CIES-Iscte.

Expenditure structure

With regard to overall expenditure, there has been a gradual transformation of the expenditure structure. Human resources are still the highest item but with a lower overall percentage. This item includes the salaries of employees at CIES-Iscte's central services (science management and communication, financial project management and researcher support, PhD management and the publishing department), grant-holders at the observatories, research fellows, provision of services in research projects and researchers hired under the “Investigador FCT” programme.

The support provided to researchers by CIES-Iscte for participation in scientific congresses, colloquies, etc and for the translation and revision of articles for publication in indexed international journals has grown regularly, that in 2018 was about 55% of the global expenditure.

The Centre's expenditure is generally balanced, in spite of uncertainties regarding institutional funding, and sufficiently flexible to accommodate unexpected expenses without this affecting sustainability.
