1.1 Presentation and Guidelines

The Center for Research and Studies in Sociology / Centro de Investigação e Estudos de Sociologia (CIES-Iscte) is a R&D unit, recognised and evaluated by the FCT (Foundation for Science and Technology), in the area of social sciences dedicated to studying contemporary social problems from a multidisciplinary perspective.



Constituted in 1985, CIES-Iscte is an organic unit of the University Institute of Lisbon / Instituto Universitário de Lisboa (Iscte), as part of its School of Sociology and Public Policy, and is a member of the Iscte Knowledge and Innovation - Center of Valorization and Technology Transfer / Associação Iscte - Conhecimento e Inovação - Centro de Valorização e Transferência de Tecnologias.

CIES-Iscte's main scientific domain is sociology, developing relevant activity in the fields of public policy, political science, communication, education, modern and contemporary history and social work.

CIES-Iscte's activity is characterised by a demanding articulation between basic research, applied research directed at the design, monitoring and evaluation of public policies in various sectors and areas of intervention and advanced training.

The Centre's research and scientific production fosters diversity and the crossing of intensive and extensive approaches, aimed at deepening the analytical relationship between the study of social, political, and historic macro-processes and the social, cultural, and spatial micro-dynamics.

The research team is composed of **Researchers** (Integrated PhD holders who meet the Centre's scientific criteria and national research evaluation standards), **Associate Researchers** (other PhD holders and non-PhD members with recognized scientific competence), and **Research Assistants** (non-PhD members with grants or involved in research projects or other CIES activities). Along with these three categories of members, there are **Doctoral Students** enrolled in CIES-coordinated PhD programmes. In addition, the Centre hosts **Visiting Researchers**.

The scientific structure of CIES-Iscte is based on **7 Research Groups**: Inequality, Work and Social Well-Being; Migration, Mobility and Ethnicity; Education and Science; Media and Culture; Gender, Life Course and Health; Politics and Citizenship; Historical Dynamics and Global Integration of the World.

The development of the CIES-Iscte strategic plan is also anchored in a set of permanent **research platforms** which are transversal to the research groups and are one of the Centre's distinctive features:

Advanced training is another fundamental pillar of CIES-Iscte, closely combined with research activities. The Centre is responsible for the scientific and administrative coordination of 8 PhD programs - [Sociology](#), [Public Policy](#), [Communication](#), [Social Work](#), [Political Science](#), [Public Administration](#), [Modern and Contemporary History](#) and [Policies of School Administration and Management](#) – and is associated with 3 others (Political Economy; Urban Studies; History: change and continuity in a global world - PIUDHist).

In the editorial field, CIES-Iscte publishes since 1986 the scientific journal [Sociologia, Problemas e Práticas](#) [Sociology, Problems and Practices] and, since 2020, jointly with CEI-Iscte, the journal [Ler História](#), both are indexed by several international databases as detailed further below. CIES-Iscte also supports the indexed journal [Observatory \(OBS*\)](#) and publishes the [CIES e-Working Papers](#). Since 2010, CIES-Iscte has its own publisher, [Mundos Sociais](#), that publishes the journal *Sociologia, Problemas e Práticas* and refereed social sciences' academic books.

In 2025, CIES-Iscte celebrated 40 years of research and distinction in the field of social sciences. To mark this anniversary, as will be further detailed, the Centre organised a series of initiatives open to the Iscte community and the public. [The CIES e-Working Papers Award 2025](#) promoted the visibility of research developed within doctoral programmes. A commemorative exhibition “[Memories and Horizons](#)” invited visitors to explore the evolution of CIES since its foundation, offering a broader look at the Centre's journey and the many dimensions that have shaped its identity and activity over the past four decades. In its annual edition, the [CIES Research Forum](#), was dedicated to the celebration of the Centre's 40th anniversary, reaffirming CIES-Iscte's enduring commitment to the production of knowledge and to the development of society.

Beyond this commemorative programme, 2025 was also a year of intense scientific activity across the Centre's research areas, with events organised within research projects, on the initiative of research team members and through regular seminar cycles that contribute to an environment of permanent and up-to-date scientific debate. Since its foundation, CIES has also been continuously developing activities to promote scientific culture, in close connection with several partners.

Further reinforcing the 40-year milestone, CIES-Iscte was awarded, in 2025, the classification of “Excellent” under the 2023/2024 evaluation of Research and Development (R&D) Units conducted by the Portuguese Foundation for Science and Technology (FCT), within the framework of the Multiannual Funding Programme for R&D Units.

This evaluation involved international peer review and assessed the scientific and technological activities carried out by the Unit over the period 2018–2023, as well as its strategic objectives, research agenda, organisational model and activity plan for 2025–2029. Within a highly competitive context, the classification of Excellent places CIES among those Units recognised for high scientific quality, impact and societal relevance of the research produced, as well as the Unit's organisational capacity and collaborative dynamics.

In terms of institutional organisation at the macro level, the integration of CIES-Iscte into the SocioDigital Lab for Public Policy and Iscte Knowledge and Innovation - Center of Valorization and Technology Transfer, continues to play a central role in its activity and is expected to remain a defining feature in the coming years.



[The SocioDigital Lab for Public Policy](#) (SDLab) promotes a unique interdisciplinary approach to the study of public policy and contributes to the resolution of contemporary societal problems and global challenges. The complexity of the modern world requires new approaches integrating social sciences and digital technologies to address societal problems and contribute to public policy.

This Associate Laboratory, co-chaired by a researcher and former Director of CIES, builds on past collaborations, bringing together six R&D units at Iscte – BRU, CEI, CIES, CIS, DINÂMIA'CET and ISTAR – in a consortium of interdisciplinary collaboration with a new vision that integrates social science and digital technologies to address societal problems and contribute to public policy.

In 2025, the SDLab strengthened its role as an interdisciplinary research hub focused on evidence-based public policy across five thematic areas—regenerative territories for carbon neutrality, inclusion and citizenship, societal health, global governance, and digital transformation for public policies. Key activities included the launch of a seed-funding scheme to support innovative interdisciplinary research projects, the opening of doctoral scholarships aimed at fostering multidisciplinary public policy research, the publication of policy briefs, and the organization of scientific events and public debates. A major highlight was the [4th Annual Conference](#), which brought together researchers, policymakers, and civil society representatives to discuss the five-year implementation of the European Pillar of Social Rights and its implications for future public policies.

The [Iscte Knowledge and Innovation - Center of Valorization and Technology Transfer \(CVTT\)](#) is a Technology Enhancement and Transfer Centre based on the combination of two of Iscte's benchmark research areas: social and human sciences and digital technologies, housing in one modern, state-of-the-art building, eight research units, including CIES, three associated laboratories, three collaborative laboratories, nine observatories and ten laboratories.

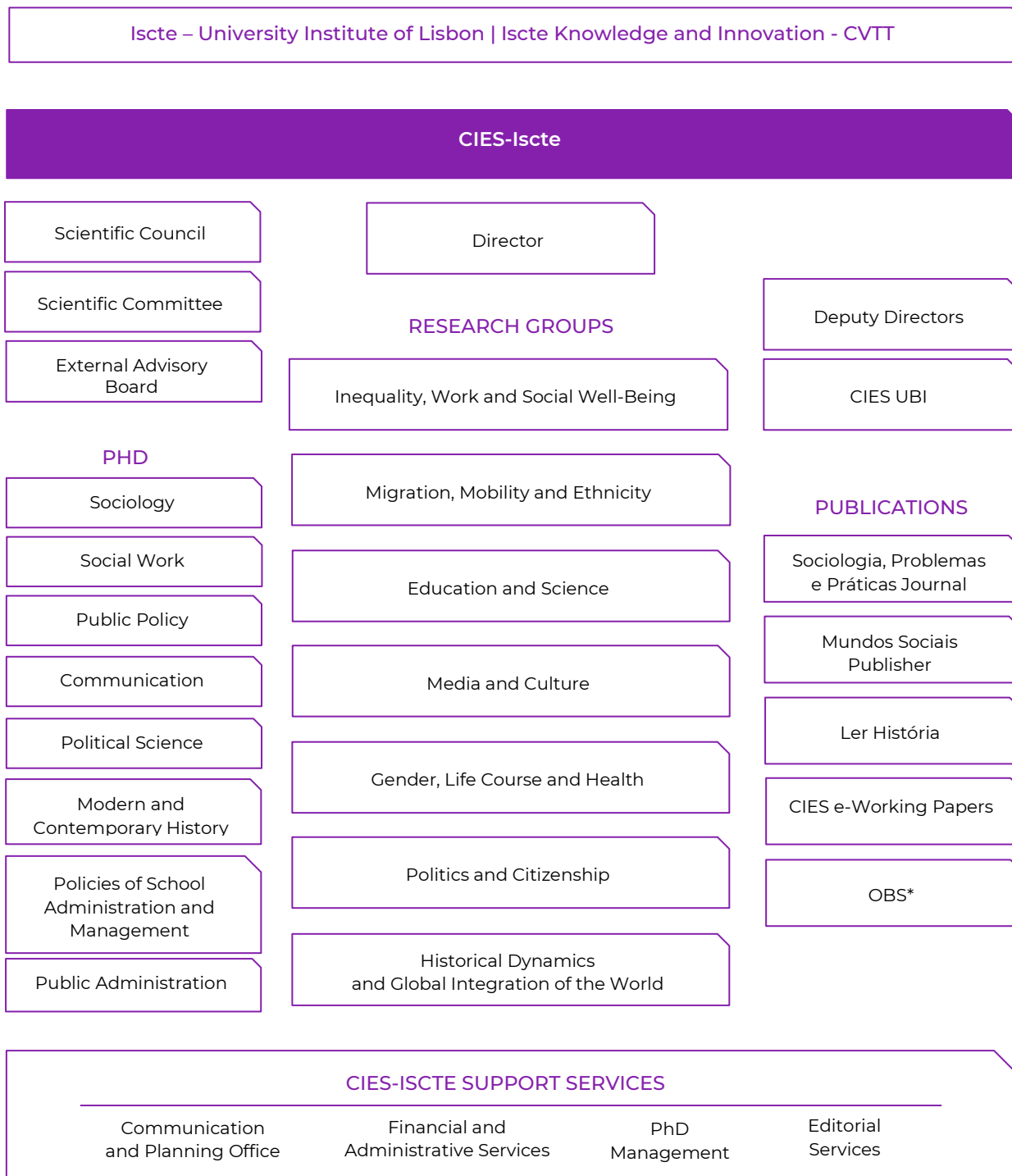
In 2025, Iscte Knowledge and Innovation reinforced its mission of connecting research, innovation, and societal impact through a wide range of scientific, technological, and knowledge-transfer activities. The center supported interdisciplinary research across its research units and observatories, promoted national and international funding opportunities, and strengthened technology transfer and collaboration with public institutions, companies, and civil society. Key initiatives included the Science and Technology Week 2025, featuring conferences, workshops, and training sessions for researchers and doctoral students, as well as events focused on research impact, evidence-based policymaking, and innovation in higher education. The center also contributed to the development of European research projects, fostered capacity building in emerging fields such as artificial intelligence and data science, and provided a collaborative environment for researchers, reinforcing its role as a hub where scientific knowledge is transformed into innovative solutions for societal challenges.

Support Services

CIES-Iscte has a set of support services which include the Communication and Planning Office, the Financial and Administrative Services, the PhD Programs Management and the services of the *Mundos Sociais* publisher and the journal *Sociologia Problemas e Práticas*.

In 2025, eleven full-time staff members were assigned to these services, supporting the research team and the Centre's governing bodies.

The functions performed by the Communication and Planning Office are threefold: to support the submission of applications for research activities and to monitor and manage the scientific activities in progress; the organisation of scientific events and other forms of dissemination, including the promotion of scientific culture; and the communication of activities and scientific results of the Centre including online platforms and through social media.

The Financial and Administrative Services ensure budget elaboration and justification for applications and the financial management of ongoing research projects and activities, ensuring compliance with the procedures of the host institution and the requirements of the various funding institutions. These services also ensure the execution of the funds and financial prizes granted to members of the research team provided by Iscte and other sources.

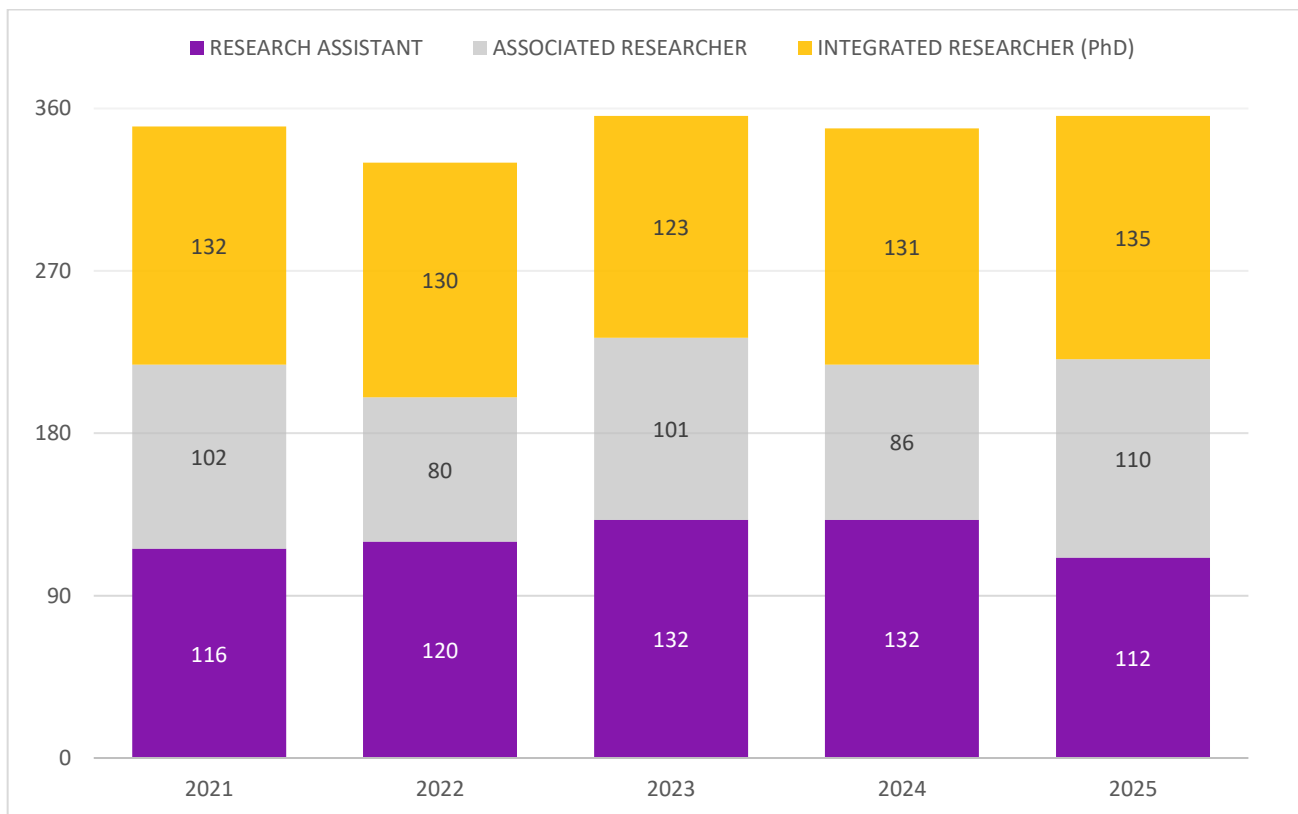
The PhD Management service accompanies the students in all phases of the PhD program, from the application to its conclusion, as well as guarantees support to the teachers and the teaching activities, also managing the International Cycle of PhD Conferences and other scientific meetings.

The supporting services of *Mundos Sociais* publisher and the journal *Sociologia, Problemas e Práticas* cover the entire editorial, publication and dissemination process of the books published by *Mundos Sociais*, the journal *Sociologia, Problemas e Práticas* and the CIES e-Working Papers. They also ensure compliance with the procedures for the inclusion of CIES-Iscte's publications in scientific repositories and in national and international indexation databases.

1.3 Research Team

The CIES-Iscte research team includes Researchers (integrated PhDs), Associated Researchers and Research Assistants. Together, in 2025, the CIES-Iscte research team consisted of 357 members.

Research team 2021-2025



There is close monitoring and updating of the categories of Integrated and Associated Researchers, implemented since 2023, resulting from the application of a set of activity and scientific production criteria, defined by the Board, in close articulation with the Scientific Committee. This ensures that the group of Integrated Researchers represents the core of the team, promoting the essential coordination of research activities. The Associated Researchers, while not having their main affiliation to CIES, collaborate and promote its activities.

The Research Assistant category is mainly composed of master's or PhD students, who are part of research projects or observatories/laboratories teams, through research grants, and PhD students, with grants to carry out the research work for their theses (69 PhD scholarships in 2025).

Regarding gender distribution of the team, as can be seen in the table below, the percentage of female researchers in each of these categories is around 60%, a little lower for the category of associate researchers (54%).

The total of 376 team members represents 191,05 FTE (Full-Time Equivalent) and the 135 Researchers (Integrated PhDs) correspond to 79,60 FTE.

CIES has been consistently pursuing a strategy aimed at enhancing and consolidating research career pathways, in line with national policies to strengthen scientific employment and promote professional stability within the scientific system.

The year 2025 marked a decisive turning point in this regard with the implementation of a new funding mechanism that promotes the recruitment of PhD graduates exclusively for permanent (tenured) positions (FCT Tenure), promoted by the Portuguese Foundation for Science and Technology. The Centre successfully recruited 15 Assistant Researchers integrated into Iscte's Research Career, who joined the 3 Assistant Researchers previously recruited in 2020 and 2024. This substantial reinforcement of the scientific staff represents a fundamental step towards institutional stability, enabling the development of medium and long-term research agendas and the strengthening of CIES research teams.

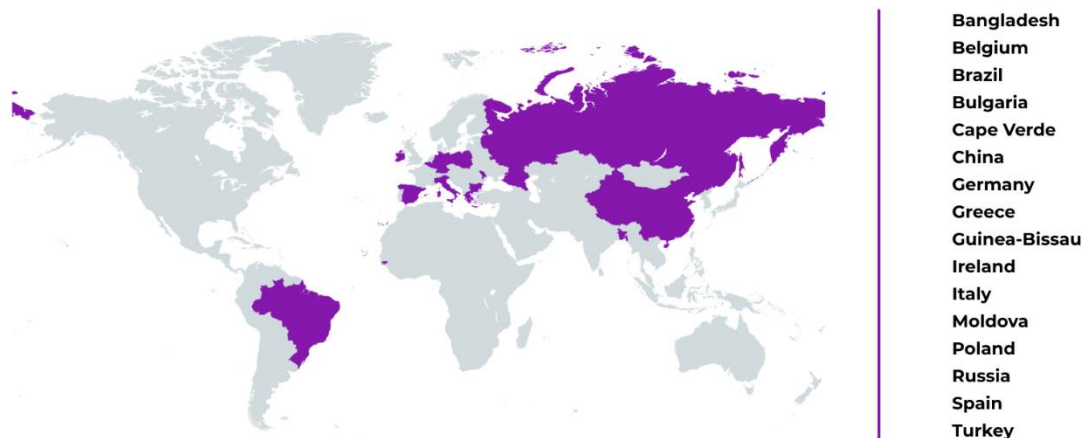

In addition to these tenured researchers (18 in 2025) and fix-term full-time hired researchers (11 in 2025), the overall group of Researchers (Integrated PhDs) includes many professors at Iscte – Instituto Universitário de Lisboa or at other national higher education institutions, among which the University of Beira Interior (UBI) and polytechnic institutes of different areas (Health, Tourism, Education) and regions of the country (North, Centre and Metropolitan Area of Lisbon). The Researchers (Integrated PhDs) from the University of Beira Interior (UBI) integrate the CIES-UBI Pole.

Regarding the nationality of the team members, in 2025, 16% of its members are foreign nationals, representing 16 different nationalities, as shown in the map below.

In 2025, CIES-Iscte welcomed 35 visiting researchers from 17 countries. Of these researchers, 24 hold a doctoral degree. Additionally, 10 PhD students, who have come to carry out research for their thesis, and one undergraduate student were hosted within the framework of Erasmus+ mobility programmes, cooperation between institutions or research projects taking place at CIES.

In 2025, this group's activities were organised around 11 ongoing research projects addressing major dimensions of inequality, social vulnerability, and labour market transformation in Portugal and in comparative contexts. These projects combine established research areas such as poverty, social exclusion, labour relations, and welfare policies with emerging themes including disability, inclusive education, artistic and cultural practices, and territorial inequalities.

Several projects focused on the evaluation and monitoring of public policies and institutional interventions, namely anti-poverty strategies, decentralisation of social policies, inclusion policies for people with disabilities, migrant integration, and initiatives promoting educational success in higher education.

Other projects examined new forms of work organisation, labour market dualisation and project-based work, analysing their implications for solidarity, regulation, and social cohesion.

The group also contributes to advanced training through research workshops actively promoted by PhD students. Across its activities, the group combines theoretical innovation, empirical research, and methodological development, with a strong commitment to socially relevant and policy-oriented knowledge production aimed at reducing inequalities and promoting social inclusion.

In 2025, a dynamic scientific programme integrating research, action-research, training and impact on public policy was reinforced by international capacity-building partnerships and by integration into local, national, international, interdisciplinary and inter-institutional networks on a global scale (Europe, America, Africa, Asia and Afro-Asia).

Researchers were involved in 11 funded projects, covering areas such as urban studies, humanitarian action, the Roma population, intra-EU and Asian migration, with a particular focus on education, housing and the labour market; such as: Human Response (Erasmus Mundus), Know, Map, Include: the Roma/Gypsy Population in Portugal (FCT) and AspirE on the (re)migration decisions of Asian citizens (Horizon Europe).

The group also ensured the continuity of specialised seminar cycles and launched new thematic series, strengthening its participation in around twenty international networks (in Portuguese, English, French and Spanish), notably IMISCOE - International Migration Research Network and International WGNDV - Working Group on Pluricentric Languages and their Non-Dominant Varieties (e.g. the 2025 international conference “Pluricentric Languages and Power: At the Crossroads of Legacies”).

During the past year, the research group has carried out a range of scientific activities focused on addressing specific research problems in the fields of Education and Science. The projects demonstrate a significant trend towards internationalisation, both in terms of the subjects of study, the teams involved, the organisational models – whether through networks or partnerships – and the respective funding. Contributions have been made to the analysis of schooling processes, inequalities and diversity in schools; scientific and technological dynamics and the role of the researcher within a context of digital transformation; higher education and its internationalisation and links with the labour market; and the strengthening of educational planning processes, in particular through applied research carried out in collaboration with local authorities. Of the research projects carried out in 2025, around a third began this year, ensuring the renewal and continuity of research in the fields of Education and Science. We highlight two of the projects approved through competitive research calls that exemplify the group's capacity for securing funding and achieving scientific recognition: the fAlces project 'Facial Recognition Technologies. 'Etho-Assemblages and Alternative Futures', which was awarded an ERC Advanced Grant; and the 'DIV_EQUAL' project – 'Pathways to Success for Immigrant Students in Portuguese Schools: Diversity and Equality' – funded by the FCT.

The group’s research activity focused on the interconnections between communication and culture as key dimensions of contemporary social life, bringing together projects that examined media, information, cultural practices, artistic production, and public engagement. A significant share of the activity was carried out through research infrastructures hosted by CIES-Iscte: MediaLab and the Portuguese Observatory of Cultural Activities (OPAC). Together, these structures strengthened the Group’s capacity to produce socially relevant research, support evidence-based public policies, and promote informed civic and cultural participation.

Within MediaLab Iscte, combating disinformation and fostering media and information literacy remained central priorities through projects funded by European and national competitive calls (Upstream; IBERIFIER Plus, ALGOWATCH, MIL CC).

Within OPAC, research focused on cultural participation, artistic practices, cultural policies, and the development of cultural indicators and evaluation frameworks through institutional partnerships (PNL2027, DG Arts, CCDR-LVT) and projects funded through national public programmes (FCT and PlanAPP/S4Policy) and private foundations, that included the evaluation of the Gulbenkian Centre for Modern Art.

The research group's team has remained stable, and 3 projects began during the course of 2025 while 3 reached their end out of a total of 14 projects; and 6 other projects were prepared and submitted to various scientific funding agencies (3 having been approved or in stage 2 of evaluation). The thematic diversity and the progressive nature of this research is evidenced by projects on, for example, (Trans)Gender Citizenship, Obstetric Violence, Adult Disability, and on Youth, Well-being and Digitalization. Funding is varied, ranging from Governmental, National Science Foundation, and, mostly, the European Commission, highlighting the internationalisation of this Research Group.

Researchers from this group present a wide-ranging type of publications during this year, most of which in collaboration with colleagues (from CIES, Iscte or other centres), and demonstrating a balance between national and international Journals/Publishers. Regarding scientific events, the Cycle Biographies and Trajectories held three conferences, the Laboratory nascer.pt promoted 16 scientific and methodological sessions and launched a new cycle of roundtables about Care and Reproductive Justice. Three international seminars connected to research projects were organised as part of Disability Studies.

This multidisciplinary research group is dedicated to the study of the relationships between civil society, political institutions, and public governance, focusing on four main areas: political representation, political participation and protest, public policy and administration, and social rights and social services. Through these interconnected fields, the group seeks to understand how citizens, social movements, and institutions interact and how these interactions shape democratic processes and public policies.

In 2025, the group was involved in several research projects, including QUALREP, which examines the quality of women's political representation; CIPO, which investigates political realignment and public opinion trends in Portugal and Spain; and TRANSPACE, a project exploring transnational climate governance and the emergence of global administrative spaces.

Among its key initiatives are the Observatory of Democracy and Political Representation, which promotes research on democratic institutions and political representation, and the monthly Seminar Series on Social Movements and Political Action, fostering multidisciplinary debate on activism, political participation, and collective action.

In 2025, two funded projects were underway, including the coordination of the 'CINCRA – International collaborations: crime and police cooperation in the Ibero-American Atlantic (c. 1870–1940)'. The project 'CRIMJUR – The criminal jury in Portugal. History of a forgotten judicial and political institution (1822–1927)' was approved and will start in early 2026.

Several sessions of the seminar cycles 'New Perspectives in Modern and Contemporary History', and 'Revisiting the 19th Century' took place as forums for academic debate, the presentation of research findings and the strengthening of national and international collaboration networks.

The Encontros com a História initiative was launched in 2025, with its first edition dedicated to the theme "War and Peace: Portugal in a Global Context" (further developed at point 5 Scientific Events), promoted by the Núcleo de Divulgação de Estudos Académicos em História / History Academic Studies Outreach Unit (NDEAH) within this research group.

The group also developed close collaboration with institutional partners such as the 50th Anniversary of 25 April Commemorative Commission and the Torre do Tombo National Archives, participating in various activities of great scientific and social significance. Several researchers from the group were part of the editorial team of the journal *Ler História*.

Overall Research Indicators

Research Projects

CIES-Iscte conducts basic research projects funded by public calls with scientific assessment issued by public and private, Portuguese, and European agencies and foundations and applied research projects directed at the design, monitoring and evaluation of public policies based on the Centers' consolidated scientific skills.

Researchers can propose projects and other scientific activities with much independence. This culture of initiative and cooperation is a firmly established practice. It is the source of the Center's ability to quickly react to the opportunities and challenges in research and enables it to place emerging, socially, and scientifically relevant issues on the research agenda.

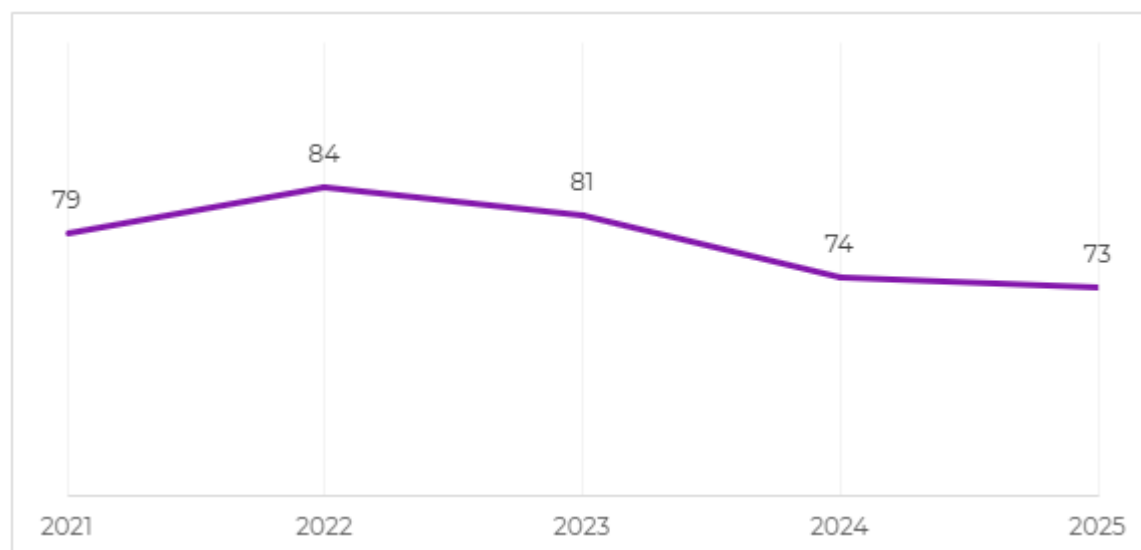
Concerning the overall number of ongoing funded projects, they amounted to 73 in 2025.

This figure doesn't include projects or work plans awarded through calls for proposals to fund researchers' employment contracts (e.g. the FCT's CEEC Programme to promote scientific employment), which for the record amounted to 15 in 2025.

Of the 34 projects with international funding, the following sources can be highlighted: Horizon Europe, Erasmus+, AMIF - Asylum, Migration and Integration Fund, European Health and Digital Executive Agency (HADEA), European Research Council, European Education and Culture Executive Agency (EACEA), International Centre for Migration and Policy Development (ICMPD), among others.

Considering projects with national funding, there are a variety of sources, demonstrating the ability to attract and obtain funding from sources other than the Foundation for Science and Technology (FCT). The projects funded by the FCT accounted half of national sources in 2025, 18 projects out of 39, and in the other half there is a great diversity of funding entities observed, including public institutions such as: municipalities, Ministry of Foreign Affairs, *Agência para o Desenvolvimento e Coesão* (Development and Cohesion Agency), I.P. (AD&C), Camões – Instituto da Cooperação e da Língua (Camões – Institute for Cooperation and the Portuguese Language) I.P, *Fundo Ambiental* (Environmental Fund), and private organisations such as the Aga Khan Foundation, and the Calouste Gulbenkian Foundation, among others.

In accordance with the United Nations 2030 Agenda for Sustainable Development, CIES-Iscte and Iscte consider the Sustainable Development Goals (SDG) fundamental to promote prosperity and well-being for all by 2030. Publications

Publication remains a core element of scientific activity, serving as a key mechanism for disseminating knowledge and research findings to both the scientific community and society at large. In recent years, the publication profile of the CIES-Iscte research team has shown a gradual transformation. While articles published in indexed journals, particularly those included in the Scopus and Web of Science (WoS) databases, continue to represent a significant share of scientific output, CIES-Iscte researchers have maintained a diversified publication strategy, preserving strong levels of production in books, edited volumes, and book chapters and thereby ensuring both international scientific visibility and engagement with Portuguese society.

The total number of publications increased in 2025, reaching 440 publications compared with 424 in the previous year. The increase was mainly driven by an increase in book chapters and other publications subject to scientific review, which rose from 119 to 139 and from 94 to 108 publications, respectively.

The number of articles published in indexed journals declined slightly, from 164 in 2024 to 148 in 2025, but remained broadly in line with the levels observed over the past five years, confirming the sustained capacity of CIES-Iscte researchers to publish in internationally recognised scientific outlets. At the same time, editorial activity increased further, with the number of edited books and special issues reaching its highest level in the period under analysis (29 publications). Although the number of authored books had a slight decrease in 2025, books and book chapters continue to represent a significant component of the institution's scientific production, reflecting the multidisciplinary nature of its research and its commitment to diverse forms of scholarly dissemination.

Overall, the publication trends observed in 2025 demonstrate the resilience and diversity of CIES-Iscte's scientific output, characterised by a balanced combination of international journal publications and other forms of academic dissemination that contribute to both scientific advancement and societal impact.

In 2025, CIES-Iscte researchers produced 148 indexed journal articles (1.9 per FTE), maintaining a similar publication ratio of the previous years. The ratio of book output remained stable at 0.6 per FTE, while book chapters increased to 1.7 per FTE.

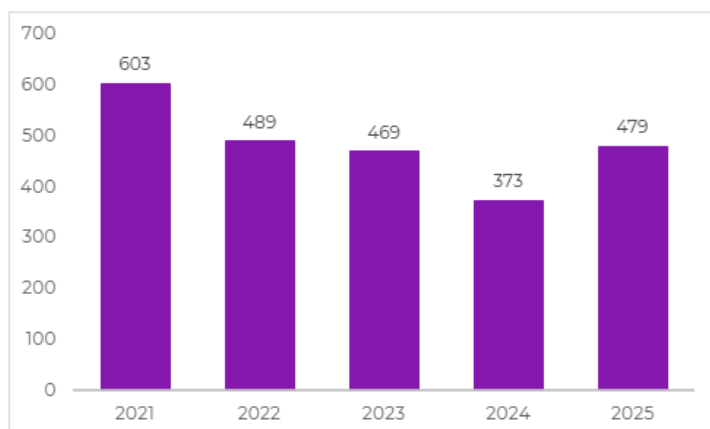

Presentations at scientific meetings

Presentations by CIES-Iscte researchers at scientific meetings remained at a high level. In 2025, the number of presentations amounted to 479, highlighting the dynamism and strong engagement of CIES-Iscte researchers in national and international scientific dissemination and academic networking activities. The first of the 5-year series (2021) was an exceptional year because many of the events were initiatives that had been postponed from 2020 that didn't take place due to the COVID-19 pandemic.

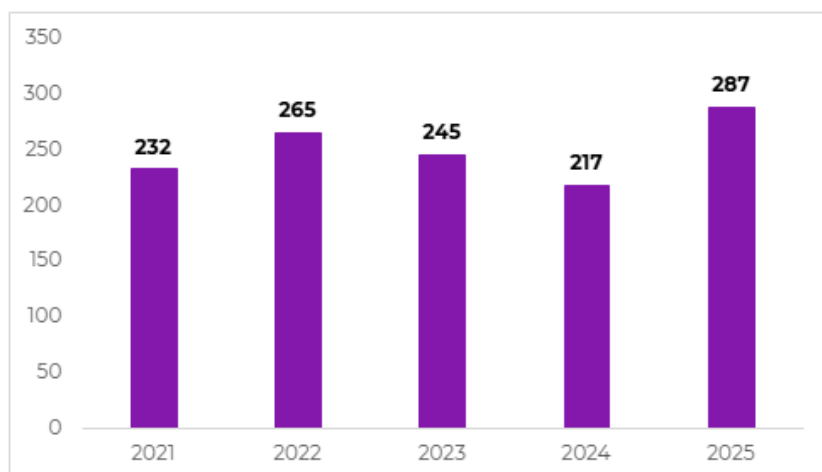
Presentations at scientific meetings (2021-2025)



Organization of scientific meetings

The participation of CIES-Iscte researchers in the organization of national and international scientific meetings has remained consistently high, reaching its highest level in 2025. Observatories and Laboratories

Observatories and Laboratories play an important role in understanding and addressing societal issues. Their primary functions include data collection, analysis and dissemination, which inform public policy, academic research, and public understanding. They also contribute to advanced training by providing internships and research opportunities for masters and doctoral students. The observatories have strengthened their mission of making rigorous and up-to-date information available to the public in their thematic areas, empowering citizens and contributing to public policies. While the laboratories have deepened their specialised competences and their cross-cutting potential towards support for research activities.

CIES-Iscte is also an honorary member of the Communication Observatory ([Obercom](#)), which analyses and assists in public policies, sector companies and academic research in communication sciences, and integrates the Collaborative Laboratory for Work, Employment and Social Protection - [CoLABOR](#), that was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

Inequality Observatory

The Inequality Observatory provides updated information, analyses, and scientific knowledge on social inequality, fostering citizenship and contributing to the design and evaluation of public policies to address its root causes. Inequality is studied in different dimensions and levels, using statistical indicators, international comparisons, and a wide range of constantly updated research and studies. Social inequality is multidimensional and identified in areas such as employment, income and wealth, education, qualifications and skills, gender, ethnicity, racial, age, health, among others. This multidimensionality is one of the most striking features of contemporary societies.

CIES is responsible for scientific coordination, partnering with the Institute of Sociology of the University of Porto and the Center for Social Studies of the University of the Azores.

MAIN ACTIVITIES CARRIED OUT IN 2025

In 2025, the Inequality Observatory strengthened its analytical and scientific contribution to the study of social inequalities through research and scientific publications, focused on recent trends in poverty and material deprivation in Portugal, as well as on young women's situation in the labour market. The Observatory also advanced its analytical framework through the development of new indicators, including the Internet Penetration Rate and Access to the Broadband Network, contributing to a more comprehensive approach to inequality.

Various dissemination and outreach activities were carried out to promote the Observatory's scientific work, including engagement with the media, the production of newsletters and participation in scientific events. In parallel, the Observatory was actively involved in the preparation and submission of applications for national and international research funding. As a result, three research projects were approved for funding — Pov_levels, Radar.Loc and Div_Equal.

Emigration Observatory

The main objective of the Emigration Observatory is to collect, harmonize and analyze information on the evolution and characteristics of Portuguese emigration, by collecting data from statistical institutions of the countries of destination of emigrated Portuguese populations.

Annual indicators include stocks (total population, place of birth, nationality, Portuguese origin and consular records), Portuguese inflows in destination countries, acquisition of nationality in destination country and emigrants' remittances. Statistical indicators include data on the entry and stay in the countries of destination, with updating of indicators.

The Emigration Observatory is a partnership with the Center for Geographical Studies and the Research Center for Economic and Organizational Sociology of the University of Lisbon, and the Institute of Sociology of the University of Porto. A cooperation agreement with DG for Consular Affairs and Portuguese Communities, supported by the Ministry of Foreign Affairs ensures activities.

MAIN ACTIVITIES CARRIED OUT IN 2025

In 2025, key outputs included the publication of the annual statistical report about Portuguese Emigration 2024 (available in Portuguese) and the *Portuguese Emigration Factbook 2024* (English version available). Also, several reports and documents were produced, notably three factsheets addressing different aspects of Portuguese emigration.

Information was also disseminated to a broader audience through the production and online publication of interviews with experts in the field of migration. In parallel, the second edition of the Atlas of Portuguese Emigration was launched, together with the first edition of its English-language version.

The Observatory further contributed to national and international academic debate through participation in conferences and by organising two scientific conferences, “‘Free’ Movement for Portuguese in Luxembourg” and “The Migration Obsession”.

Portuguese Observatory on Cultural Activities

The Portuguese Observatory on Cultural Activities is responsible for the development and production of studies and information on various cultural themes and domains, such as cultural practices, cultural and artistic agents and institutions, cultural employment, and cultural democratization, including the production and dissemination of indicators on art and culture.

The Portuguese Observatory on Cultural Activities partners with public and private institutions, in particular with the Directorate-General for the Arts of the Ministry of Culture, based on providing a range of secondary, official, and national statistical sources on cultural policies.

MAIN ACTIVITIES CARRIED OUT IN 2025

A total of six new research projects were developed in 2025, with an emphasis on the construction of indicators for Cultural Human Rights, as well as on diagnostic and cultural impact studies, including research on reading practices and cultural policies.

In the area of training, a course on Cultural Statistics was delivered to representatives of the public cultural sector from the six PALOP-TL countries, held in October 2025 within the framework of the PROCULTURA PALOP-TL project.

The Observatory also carried out science communication and outreach activities, with particular emphasis on its participation in the European Researchers' Night 2025 (NEI'25), which took place in Lisbon on 26 September 2025.

Laboratory for the Social Studies on Childbirth – nascer.pt

The Laboratory for the Social Studies on Childbirth is an interdisciplinary program addressing childbirth and its social, political, cultural, and institutional framing conditions. It informs public policy on ethics, social representations, choices, and results of childbirth.

Research and studies address the process of norms, practices, and social organizations that frame, regulate, and condition childbirth in a modern and medicalized society, as well as the institutions and the agents or practitioners involved in this process.

MAIN ACTIVITIES CARRIED OUT IN 2025

During the year, the Laboratory carried out a programme of scientific events at both national and international levels. This included the organization of ten scientific sessions, four workshops, two research meetings and two roundtables, addressing a wide range of themes and methodological approaches grounded in the sociology of childbirth and motherhood.

The Laboratory also promoted the dissemination of scientific knowledge on the social studies of childbirth to a broader audience. These activities included the publication of twelve articles on its blog and participation in the European Researchers' Night 2025 (NEI'25).

In addition, the Laboratory published the e-book "Cairo–Lisbon 2024: Three Decades of Sexual and Reproductive Health and Rights".

The Collaborative Laboratory for Labour, Employment and Social Protection (CoLABOR) was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

With nine partners and a multidisciplinary team of highly qualified researchers [CoLABOR](#) mobilises resources from academia, companies, and third sector institutions, having four central objectives: to support the design and restructure of policies in their thematic areas; capacity-building of institutions, including public administration, businesses and institutions in the third sector; to qualify employment through training and the creation of scientific jobs; contribute to public debate in the areas of work and social protection, through effective and innovative forms of dissemination of the results of the research it carries.

CoLABOR achieves these objectives through an ambitious agenda of deepening scientific knowledge around three central thematic axes: work and employment; social protection and social facilities and responses.

Across these thematic areas, CoLABOR developed [DataLABOR](#), an innovative platform that aggregates and cross-references statistical and legal data on work and employment, social protection and the social and solidarity economy in Portugal.

MediaLab-Iscte

MediaLab is focused on the analysis of communication practices in different forms and models – from digital to analogue, from text to image, through sound, audiovisual, and multimedia, to analysis of networks and online trends, related to social media networks, online research and user opinions, information visualization and Big Data. MediaLab is a research laboratory in digital media and communication by combining applied research, knowledge transfer, and societal engagement activities.

In 2025, the laboratory developed research on disinformation on social media, online hate speech, the amplification of political discourse on digital platforms, and the circulation of disinformation narratives in electoral contexts, in several nationally and internationally funded projects, including UPSTREAM – Disinformation Upstream: Identifying and Analysing the Sources of Falsehoods (Fundação Calouste Gulbenkian, 2025–2026), developed in partnership with the newspaper Público; IBERIFIER Plus – Iberian Digital Media Observatory (European Commission, 2024–2026) integrated into the European Digital Media Observatory network; the project on monitoring and detecting political disinformation during the 2025 Portuguese Legislative Elections (National Election Commission, 2024–2025); and ALGOWATCH – Developing Algorithm Literacy for All, to Fight Disinformation and Foster E-Inclusion with Quality Information for Knowledge-Based Democratic Societies (Creative Europe, 2023–2025).

Observatory for Democracy and Political Representation

The Observatory for Democracy and Political Representation concentrates its activities on democratic political representation and the integration of its citizens in political and decision-making processes, thus identifying linkages between the electorate, the elected representatives, and the formulation and implementation of public policy. Elected representatives – at the governmental levels – are held accountable for their use of power and public policies reflecting most voters' preferences.

Various surveys, including the Comparative Candidate Survey, provide comparative data on values, guidelines, and behaviors of elected and non-elected candidates. Citizen participation, either individually or through interest groups or social and political movements, is assessed in the political process and in political representation.

MAIN ACTIVITIES CARRIED OUT IN 2025

During the year, the Observatory for Democracy and Political Representation promoted and disseminated its scientific activities, as well as those of the Politics and Citizenship research group, through the management and regular updating of its institutional website and social media, and through participation in conferences and seminars.

The Observatory also promoted its scientific activity through the participation of its members in academic events and the publication of scientific texts. In parallel, it acted as an interface with civil society organisations by organising meetings and discussion forums.

In addition, the Observatory applied, harmonised and published the Survey of Candidates for the 2024 Legislative Elections (covering both elected and non-elected candidates).

Laboratory of Innovative Methodologies

The Laboratory for Innovative Methodologies promotes innovative methodological practices through workshops, interdisciplinary collaborations, and developing advanced methodological skills, such as Advanced Methods in Statistics and Data Analysis, Computer-Assisted Qualitative Data Analysis, Mixed Methods and Triangulation between Quantitative and Qualitative Methods, Biographical Method, Life Course Methodologies, Data Visualization Methods. The Laboratory for Innovative Methodologies also promotes interdisciplinary discussions in various conferences.

MAIN ACTIVITIES CARRIED OUT IN 2025

Throughout the reporting period, the Laboratory for Innovative Methodologies organised two thematic workshops — “Co-creation in Focus: Visual Experiences in Segregated Territories” and “Biographical Landscapes: Plans, Perspectives and Tools for Observing the Lives of Others”.

The Laboratory also contributed to academic debate through a presentation at the XIII Portuguese Congress of Sociology, held under the theme “Democracies under Scrutiny: Risks and Uncertainties”, held in Ponta Delgada.

Public Sphere LAB



Civic culture, the public sphere and citizenship have specific histories and meanings, but they overlap to a large extent, constituting the necessary foundation for preserving and developing the autonomy and cooperation that are indispensable in the face of the current challenges of inclusion, sustainability and digitalization.

It is within this framework that the activity of the Public Sphere Laboratory, a CIES-Iscte body with an interdisciplinary nature and scientific and technical skills, dedicated to civic culture, the public sphere and citizenship, takes place.

The Laboratory aims to boost the knowledge, capacities and skills of institutions and individuals for more enlightened action in contemporary societies, specifically contributing to the fields of literacy, civic culture, the public sphere and citizenship, based on promoting research and training in these fields, and on bringing academia closer to society in general, namely by promoting citizen science and public sociology.

The presentation of the Public Sphere Laboratory took place on 27 October 2025, and one of its ongoing initiatives is 'Semtxt': a social media publication featuring simplified, text-free infographics on contemporary societies, designed for immediate reading and based on institutionally produced databases.

PhD Programs with connection to CIES-Iscte

CIES-Iscte has long-standing experience of hosting PhD students, which creates a strong interdependence between its teaching and research environments. To ensure the completion of high-quality research, PhD students are provided with guidance and supervision by experienced researchers.

Within the School of Sociology and Public Policy at Iscte, the Center provides scientific coordination and management of the following eight PhD programs:

PhD Programs coordinated by CIES-Iscte

CIES-Iscte currently coordinates a total of eight PhD Programmes. The Communication Sciences and Public Policy programmes take three years of study, and the Political Science, Modern and Contemporary History, Policies of School Administration and Management, Social Work, Public Administration and Sociology programmes take four years of study. In the first year, the students attend seminars on theories and methods and optional curricular units. In the other years, they prepare their PhD thesis, carrying out research at CIES-Iscte. Complementarily, they attend a Doctoral Seminar, the International Cycle of PhD Conferences and the Doctoral Colloquy.

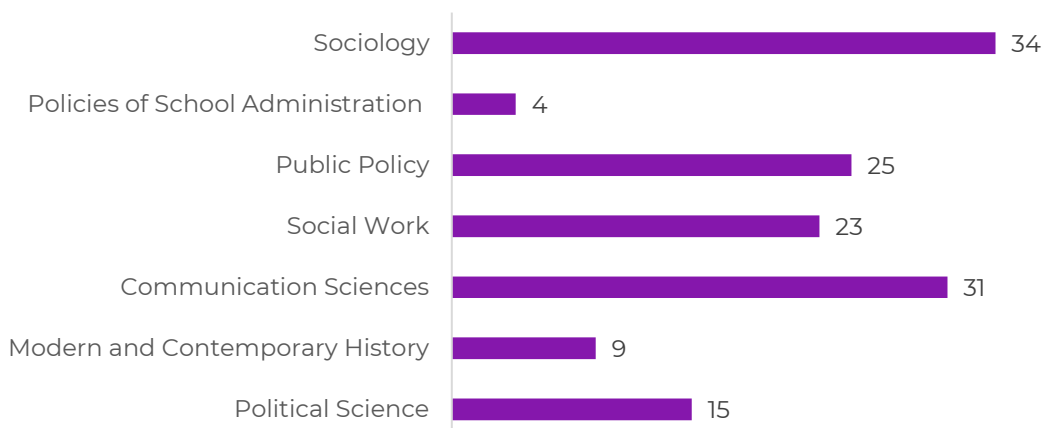
At CIES-Iscte, PhD students actively engage in a diverse range of activities while being strongly encouraged to share the outcomes of their research incrementally and participate in national and international debates.

The Centre's support structures ensure the necessary follow-up, both in the administrative management of the students' training path and in their research activities. In this context, CIES-Iscte also provides assistance in preparing applications for scholarships from the National Foundation for Science and Technology (FCT), the Iscte and other funding institutions.

PhD students benefit from dedicated research facilities in the Iscte Knowledge and Innovation Building, including workstations, collaborative spaces, laboratories, secure access and storage facilities. They also have access to specialised software (SPSS, MAXQDA, Qualtrics, etc.), and to the Iscte Library and access to the Online Knowledge Library (b-on), which provides access to the full text to thousands of journals and ebooks of the main international scientific publishers.

In 2025, 35 theses were defended by students of the PhD programs managed by CIES-Iscte.

Doctoral Colloquium

The Doctoral Colloquium of the School of Sociology and Public Policy (ESPP) has been held annually since 2013. In partnership with the IPPS, CIES organizes two annual training activities: [the European Drugs Summer School](#) and the [Winter School](#). These are supported by experts from the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA).

The winter edition of the school was held online from 10 to 21 March 2025 and focused on crime prevention. Summer School took place in person in Lisbon from 23 June to 04 July 2025, with a special focus on synthetic opioids.

The schools aim to equip professionals and students with the knowledge and skills to address complex policy issues related to drug use in Europe and around the world. CIES has been part of the organization of this initiative since 2014.

Research internships

CIES-Iscte welcomes students at various levels of their studies (undergraduate, postgraduate or doctoral) and offers them the possibility of working as interns in its laboratories and observatories or in ongoing research projects at the Center. In 2025, CIES-Iscte hosted 11 trainees.

During the traineeship, students are mentored by researchers specialized in the topic of the traineeship and are integrated into the project team or laboratory where the traineeship takes place.

Under the 2024/2025 edition of Iscte's Scientific Initiation Competition, aimed at promoting scientific training among undergraduate students, CIES hosted three projects "The Anatomy of the Vote: The motivations behind voting for the far right in Portugal", "The influence of private social solidarity organisations on the political integration of homeless people" and "Christianity and Voting for the Radical Right: The Role of Religiosity, Denominations and Christian Democratic Parties".

CIES-Iscte Research Forum annual

The [CIES-Iscte Research Forum](#) is an annual initiative promoted by the Center that has been taking place since 2006. Over the years, it has served as a dedicated space for presenting and discussing the work of CIES researchers across the various fields of social sciences, bringing together academics and practitioners for exchange, reflection and in-depth debate. In 2025, the Forum took on a special significance. Dedicated to the 40th anniversary of the Centre for Research and Studies in Sociology (CIES-Iscte), the gathering held on 12 December brought together the many people who, over four decades, helped shape one of Portugal's most influential social science research centers.

Under the theme "40 Years of CIES: Memories and Horizons," founders, former directors, research group coordinators, doctoral programme leads, journal and publication editors, and observatory coordinators gathered to revisit the Centre's history, honour its achievements and reflect on the challenges ahead.



CIES-Iscte Research Workshops fortnightly

CIES [research workshops](#) are meetings where researchers present and discuss methods, processes and results of scientific research in specific social science fields.

Seven workshops were organized by the Center in 2025 - all in a hybrid format.

New Perspectives on Modern History

The [New Perspectives in Modern History](#) cycle has been taking place regularly since 2005. It is an initiative aimed specifically at master's and PhD students in the History Department of Iscte but open to all interested parties.

The sessions include the presentation of some of the research projects in progress, developed by Portuguese and foreign historians, from different universities, specialties, and generations. This cycle of seminars provides an insight into the current trends in Modern History research: the topics that are most developed at the moment, the main problems in focus, the new methodologies, the sources used, and the new interpretations that are being produced.

In 2025, 5 sessions of this cycle of seminars were held in a hybrid format.

Monthly seminar on social movements and political action

The [monthly seminar](#) cycle began in 2014, with the aim of multidisciplinary reflection on issues related to social movements and different forms of political action, militancy, and activism.

In addition to bringing different perspectives, methodologies and approaches into dialogue in order to develop an in-depth and innovative debate, the seminar also aims to take advantage of Portugal's special geographical, linguistic and epistemological position to cross different traditions of social movement and political action studies, the different European/North American and South American ones, as well as cases and areas often excluded from this field of study, such as Portuguese-speaking Africa.

9 sessions of this cycle of seminars have taken place in 2025 and all of them can be watched on the [Youtube channel](#) of the CIES-Iscte.

Meetings about Migration Experiences

The [Migration Experience meetings](#) are an interdisciplinary seminar series co-organised by researchers from CIES and CRIA, in partnership with the Emigration Observatory. Rooted in collaborative inquiry, these meetings promote the exchange of knowledge on international migration studies, bringing together ongoing and completed research across different methodological and theoretical perspectives.

In 2025, the series marked its 10th anniversary. Over the course of the year, 7 sessions were held, maintaining the hybrid format that has allowed the initiative to reach broader and more diverse audiences. The commemorative edition offered an opportunity to reflect on the political and economic context of 2015, when the series was first launched and to chart the transformations that migration in Portugal has undergone since then. This retrospective dimension reinforced the series' role as a sustained space for critical and collective reflection within the field.



Public Policy Forum annual

The Public Policies Forum is an initiative of Iscte public policy professors and researchers, held annually since 2012. It aims at promoting ideas, knowledge, and information on public policies and at helping improve processes for planning, implementing, regulating, and evaluating public policies in Portugal.

In 2025, the Public Policies Forum focused on the new competencies of local government, a timely theme in a year marked by municipal elections in Portugal.



Encontros com a História annual

Encontros com a História [Encounters with History] is a scientific dissemination initiative promoted by the *Núcleo de Divulgação de Estudos Académicos em História / History Academic Studies Outreach Unit (NDEAH)* within CIES-Iscte's Historical Dynamics and Global Integration of the World research group, in partnership with ESPP - Iscte – University Institute of Lisbon and the national Association of History Teachers.

Conceived as a forum for the public discussion of historical knowledge, the initiative brings together researchers, invited specialists, students, and the wider community to explore topics of historical relevance from interdisciplinary and comparative perspectives. By encouraging the exchange of ideas beyond academic settings, the programme contributes to the dissemination of research outcomes and to the strengthening of public engagement with the humanities and social sciences.

“War and Peace: Portugal in a Global Context” was the theme of the first edition which took place at the Olga Cadaval Cultural Center and MU.SA, the Sintra Arts Museum, on March 7 and 8, 2025, with a vast program of conferences, round tables, visits to places of historical interest, a commented screening of a film. There were also a themed exhibition and a History Book Fair with Livraria Almedina. The 2025 edition reaffirmed the initiative's role as a platform for the dissemination of innovative historical research and the promotion of informed public debate.



Other important discussion activities

In 2025 some of the events hosted by CIES-Iscte with the highest impact were the following:



IBERIFIER

CIES-Iscte hosted, on 27 March 2025, the conference “Disinformation VS Freedom of Expression”, organised within the framework of the European project [IBERIFIER – Iberian Digital Media Observatory](#). The initiative brought together researchers, media experts, and representatives from fact-checking organisations to discuss the challenges posed by digital disinformation, promoting reflection on the role of media literacy, digital platforms, and freedom of expression in contemporary societies.



The conference constituted an important space for interdisciplinary and international dialogue on the impacts of disinformation on the public sphere and democratic processes, reinforcing IBERIFIER’s commitment to promoting critical thinking, media literacy, and a more transparent and resilient information ecosystem.

Pluricentric Languages and Power: At the Crossroads of Legacies

From 22 to 24 May 2025, Iscte – University Institute of Lisbon hosted the 11th International Conference of the International Working Group on Pluricentric Languages and their Non-Dominant Varieties (WGNDV), under the theme [“Pluricentric Languages and Power: At the Crossroads of Legacies”](#). The conference brought together researchers and specialists from different parts of the world to discuss the role of pluricentric languages in the context of power relations, colonial legacies, language policies, and cultural identities.



Over the course of the three-day event, more than 60 academic papers, roundtables, and plenary sessions were presented, with contributions from scholars in the fields of sociolinguistics, language policy, education, and cultural studies. The discussions focused on a wide range of pluricentric languages, including Portuguese, Spanish, English, and German, fostering critical reflection on linguistic diversity and the challenges associated with the coexistence of multiple national and regional standards.

The conference was organized by Iscte in partnership with CELGA-ILTEC at the University of Coimbra and formed part of an international conference cycle launched in 2011, with previous editions held in cities such as Graz, New York, and Salamanca. Locally coordinated by researchers Ana Raquel Matias, Sofia Gaspar, and Cláudia Pereira, this edition reinforced Iscte's commitment to interdisciplinary research in linguistics, sociolinguistics, language education, sociology, anthropology, and cultural studies, while also fostering the development of transnational research networks and promoting linguistic diversity as both an academic and social value.

International Collaborations: Crime and Police Cooperation in the Ibero-American Atlantic, c. 1870–1940

To mark the conclusion of the project “CINCRA – International Collaborations: Crime and Police Cooperation in the Ibero-American Atlantic, c. 1870–1940” (PTDC/HAR-HIS/3580/2021), funded by the Portuguese Foundation for Science and Technology (FCT), Iscte – University Institute of Lisbon organized the international conference “Crime, Surveillance and Mobilities in the Atlantic, 19th and 20th Centuries”, held from 10 to 12 September 2025. The event brought together researchers from several countries to discuss topics related to crime, surveillance, police and judicial cooperation, mobilities, and Atlantic circulations during the nineteenth and twentieth centuries.



[Research in Science, Technology and Society Communication](#)

Iscte – University Institute of Lisbon hosted the symposium “Research in Science, Technology and Society Communication”, organized by CIES-Iscte. The initiative brought together researchers, lecturers, and students to discuss current research in the fields of science communication, technology, and science and society studies.

The programme included presentations on topics such as scientific integrity, artificial intelligence, public communication of science, media narratives, and inequalities in science, as well as a session dedicated to undergraduate student research projects. The symposium concluded with a keynote lecture delivered by Massimiano Bucchi, contributing to the international dimension of the event and promoting interdisciplinary reflection on the relationship between science, technology, communication, and society.

Promotion of Scientific Culture

CIES-Iscte is dedicated to making science accessible to all by promoting and disseminating its research. The research team plays an essential role in advancing scientific culture, not only by sharing scientific knowledge but also by contributing to the critical development of society across various sectors.

CIES-Iscte actively participates in science outreach initiatives organized by *Ciência Viva* Agency, including Science and Technology Week and Holiday Scientific Activities for Young People. Moreover, the Center regularly takes part in the European Researchers' Night, an event funded by the European Commission.

The researchers also undertake other activities promoting scientific culture, including events for the general public, participation in TV programs and other media outlets, book releases, etc.

Women in Science

The *Ciência Viva* National Agency for Scientific and Technological Culture launched in 2025 the fifth volume of the book [Women in Science](#) on International Women's Day in a quest to raise the visibility of women in science. This edition features two researchers from CIES-Iscte.

European Researchers' Night

The European Researchers' Night (NEI) is an initiative funded by the European Commission, under the Horizon 2020 program, Marie Skłodowska-Curie Actions (MSCA), which aims to bring researchers and citizens closer together in several European cities typically on the last Friday in September.

The 2025 edition of European Researchers' Night took place at European level, with the theme "Science for Global Challenges".



CIES-Iscte developed a set of complementary science communication activities that combined participatory reflection with playful engagement, creating a dynamic interface between research and society. The initiatives *Between the Intimate and the Global: Perspectives on Reproductive and Environmental Justice* and *The Cultural Heritage Game* offered a multifaceted experience that connected individual perspectives with broader social, cultural, and environmental issues.

The activities, facilitated by research teams from *nascer.pt* – Laboratory for Social Studies on Birth, and OPAC – Portuguese Observatory of Cultural Activities, achieved a strong level of public engagement. The articulation between reflective pathways and game-based learning fostered curiosity, dialogue, and active involvement, encouraging participants to question, explore, and co-construct meanings.



40 years of CIES-Iscte



To mark the [Center's 40th anniversary](#), CIES promoted a series of activities open to the entire Iscte community and the public.

Throughout its history, CIES-Iscte has played a leading role in social science research, in accordance with international standards of excellence.

In 2025, CIES-Iscte organised several activities to celebrate this milestone, namely through an [exhibition](#) exploring the Centre's history and identity, the [annual research forum](#) titled "Memories and Horizons" ([available on YouTube](#)), an initiative that revisits the past, celebrates its legacies, and envisions the future. Also, CIES-Iscte launched an [anthology](#) of studies about Portugal in Democracy – a volume that reflects CIES's contribution to the understanding of Portuguese society and its major social issues – and the [CIES e-Working Papers Award](#), to promote the excellence of research conducted by PhD students enrolled in programmes hosted by the Centre.

Publishing Activities

CIES-Iscte has published the scientific journal *Sociologia, Problemas e Práticas* (SPP) since 1986. The center has had its own publishing house, *Mundos Sociais* since 2010. It publishes the SPP journal and peer-reviewed social science book collections. The center also publishes the journal *Ler História* jointly with CEI-Iscte and belongs to consortiums that manage the indexed journals *Portuguese Journal of Social Science* (PJSS) and *Observatório* (OBS*) and publishes the CIES e-Working Papers.

CIES-Iscte actively follows an open science policy. SPP articles and the CIES e-Working Papers are totally available online in their websites and at the RCAAP (Open-access Scientific Repositories in Portugal), and *Mundos Sociais* has published its first books with online editions.

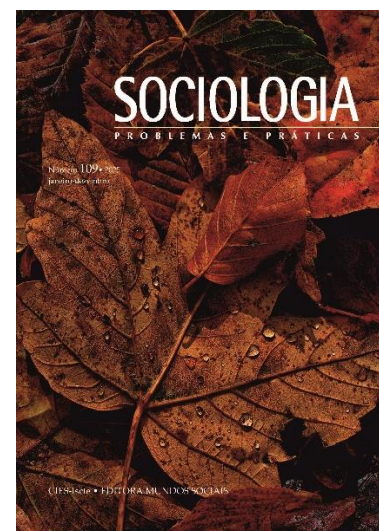
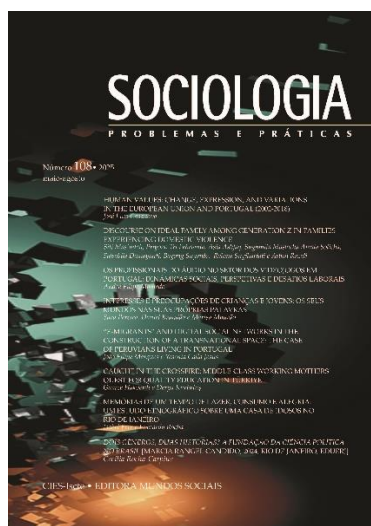
CIES-Iscte was a pioneer at Iscte in providing open access to its publications at the Iscte repository. It has been its largest contributor to scientific documents (over 4000 available). The center is a founding member of the *Portuguese Social Information Archive* (APIS) and *Production and Archive of Social Science Data* (PASSDA) which stores and shares data produced in social science research projects.

Sociologia, Problemas e Práticas

Sociologia, Problemas e Práticas is a scientific journal whose main purpose is to publish sociological analysis articles resulting from original research, the development of theory, or thematic evaluation. It also accepts papers from other social science areas, where there is an interdisciplinary interest. It is directed towards an international audience, publishing articles in Portuguese, English, Spanish and French, by authors from various countries. The journal's editorial stance is governed by principles of scientific quality, paradigmatic pluralism and social relevance. It aims to ensure that the articles published make a significant contribution to the advance of knowledge. Articles submitted for publication undergo a blind independent review by at least two recognised specialists drawn from a range of countries. The journal *Sociologia, Problemas e Práticas* was established in 1986, since when it has been published without interruption. It is indexed in various international bibliographic databases.

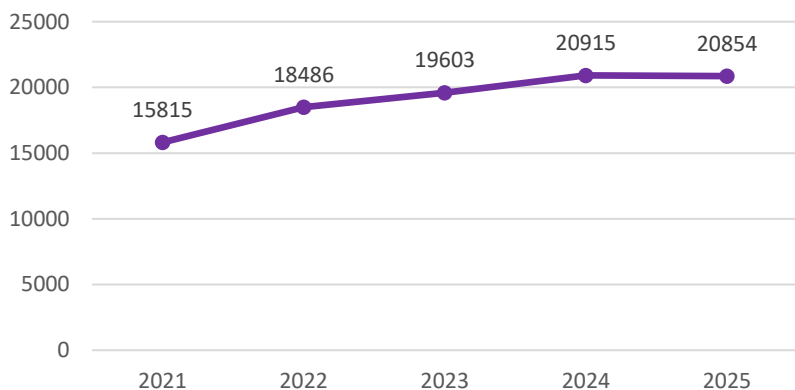
Sociologia, Problemas e Práticas remained on track in 2025 and its three annual numbers (n° 107, n° 108 and n° 109) were published regularly and punctually.



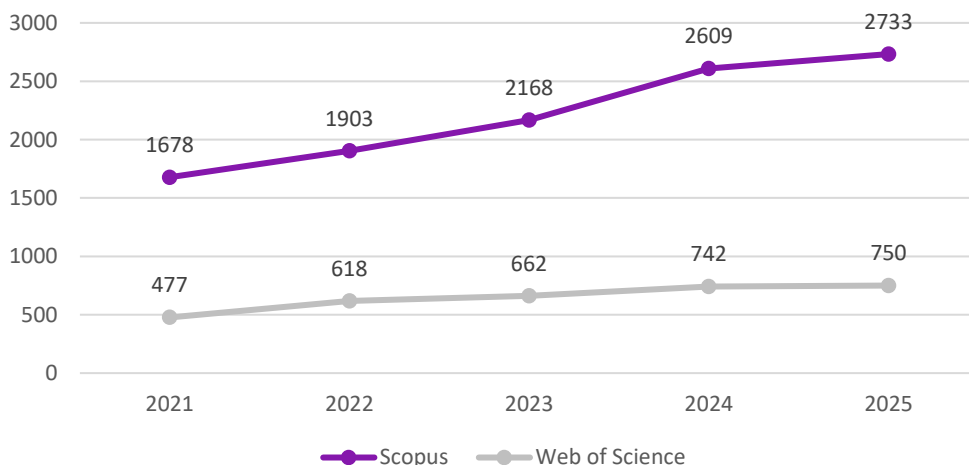
The inclusion of *Sociologia, Problemas e Práticas* in indexed online platforms and the visibility that they afford the journal increase quotations from its articles. It is positioned in Quartile 4 of Scopus, in the fields of Sociology and Political Science and Social Sciences (miscellaneous).

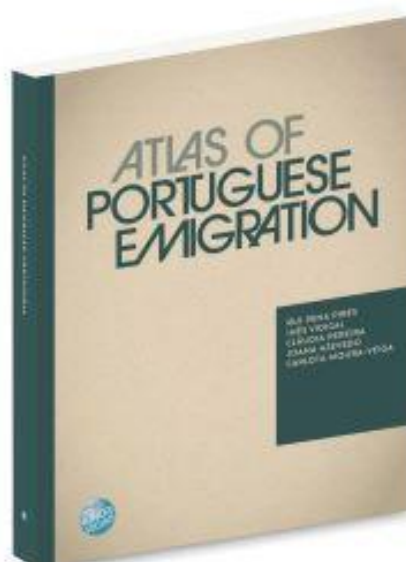

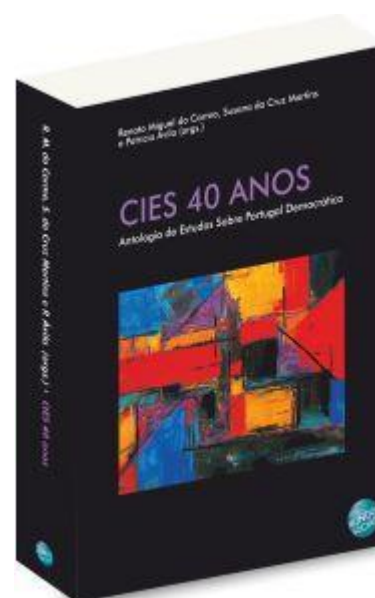

Ler História and OBS*

CIES-Iscte publishes jointly with CEI-Iscte (Center for International Studies) the journal *Ler História* and also a part of the consortium that publishes the e-journal *OBS**.

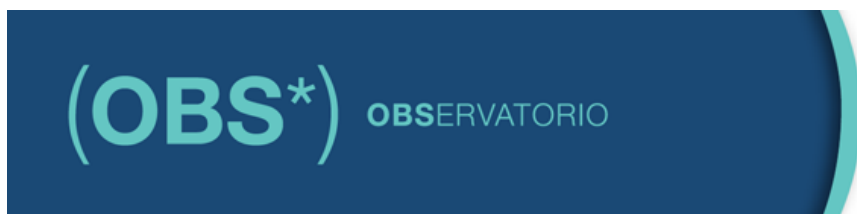


Launched in 1983, [Ler História](#) is a Portuguese academic journal in the scientific area of History, dedicated to the history of Portugal, the Portuguese Empire and the Lusophone countries, in the modern and contemporary eras, which is published in Portuguese, English, Spanish and French.

Ler História also includes in its field of interests other chronologies and geographies, such as Iberian and Ibero-American history, the history of Africa and the history of Asia, among others, being particularly receptive to approaches of comparative, transnational, or global history.

The journal is indexed in several international databases among which SJR (Scimago Journal & Country Rank) is of particular note, in which *Ler História* is classified Q1.

In 2025, issues 86 and 87 of the journal were published.



The journal [OBS*](#) is published within the scope of the collaboration of CIES-Iscte and OberCom (Communication Observatory), being an interdisciplinary journal, open to contributions from disciplines related to communication studies, which publishes articles in English, Spanish, Italian, Galego, French and Portuguese, in open access.

*OBS** is indexed in several databases, such as Scopus, ERIH and SciELO and, in 2025, the journal maintained the course of its activity ensuring the regular and timely publication of its annual volumes and a special issue on "Crisis Media Literacy".

7.4

CIES-Iscte e-Working Papers

The main goal of the [CIES e-Working Papers \(e-WP\)](#) series, initiated in 2005, is the publication of scientific papers in electronic format that result from research developed by CIES-Iscte researchers, as well as by researchers who collaborate with members or activities of the Center and students from Iscte.

CIES e-WP are typically work in progress and may be theoretical or conceptual, methodological, or empirical in nature. Texts proposed for publication are assessed by the Editorial Board and submitted to peer review to ensure the Center's standards of quality and scientific relevance.

There were two CIES e-Working Papers published in 2025, and a total of 243 working papers have already been published.

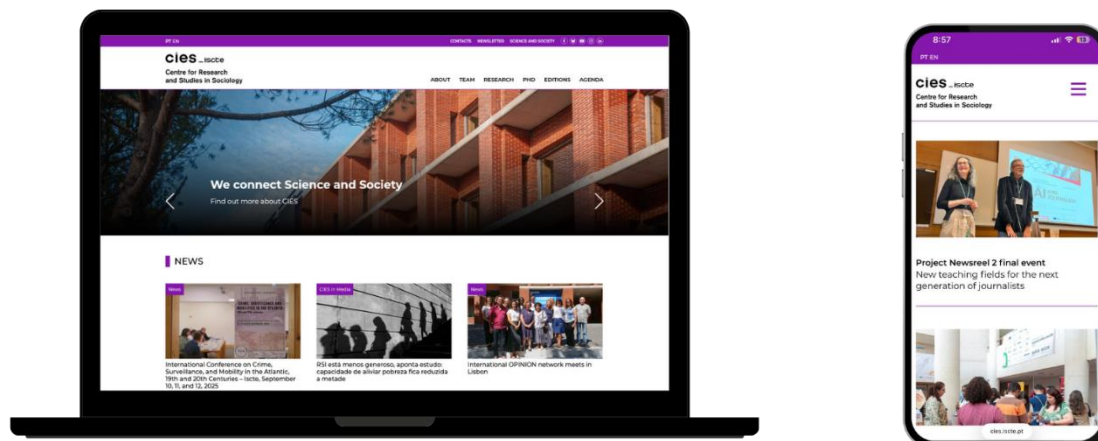

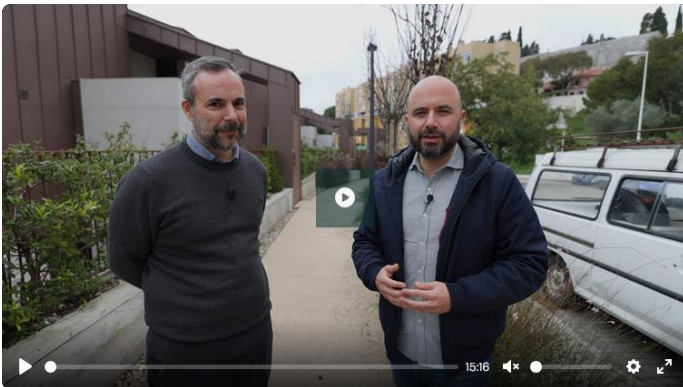

CIES-Iscte in the media

Inicialmente, Cleidi desenvolveu um estudo exploratório que constatou essa realidade. "38,5% das entrevistadas relatavam algum tipo de violência obstétrica, que era um percentual maior do que a média portuguesa considerando outras pesquisas. E tinha um percentual significativo, de 26,9%, de casos xenofobia e racismo", afirma.

Para desenvolver o estudo atual, Cleidi está ouvindo relatos de brasileiras em Portugal e de venezuelanas no Brasil, as maiores comunidades imigrantes em cada um dos países respectivamente.

A participação consiste numa conversa em formato de entrevista, com duração estimada em cerca de uma hora, que pode ser feita por videochamada ou presencialmente. Cleidi ressalta que ainda que o foco da pesquisa seja violência obstétrica, tem interesse em ouvir todos os tipos de experiência de gestação e parto de brasileiras em Portugal, sejam elas neutras, negativas ou positivas.

A pesquisadora reforça que a violência obstétrica é um fenómeno global, além de ser considerada um problema de saúde pública devido ao impacto que causa na vida das mulheres e de seus bebês. "Essas pesquisas são importantes para eventuais melhorias nas políticas públicas de cada país", diz.

In 2025, CIES-Iscte's Facebook page demonstrated consistent growth across all key performance indicators. The page gained 273 new followers, representing a 29.4% increase compared to the previous year, reflecting a steady expansion of the institution's digital community. Page visits reached 8 300, up 8.2%, indicating sustained interest from both new and returning audiences. Content interactions totalled 3 400, marking a notable 34.2% growth and suggesting that the content shared resonated increasingly well with the audience throughout the year.

Activity patterns across the three metrics reveal recurring engagement peaks, particularly around April–May and June–July, which may correspond to periods of heightened institutional activity such as events, publications, or research launches. These spikes highlight the impact of content tied to specific moments in the academic calendar.

CIES-Iscte LinkedIn page showed consistent growth across its main performance indicators, strengthening the institution's digital visibility and engagement within academic and professional networks.

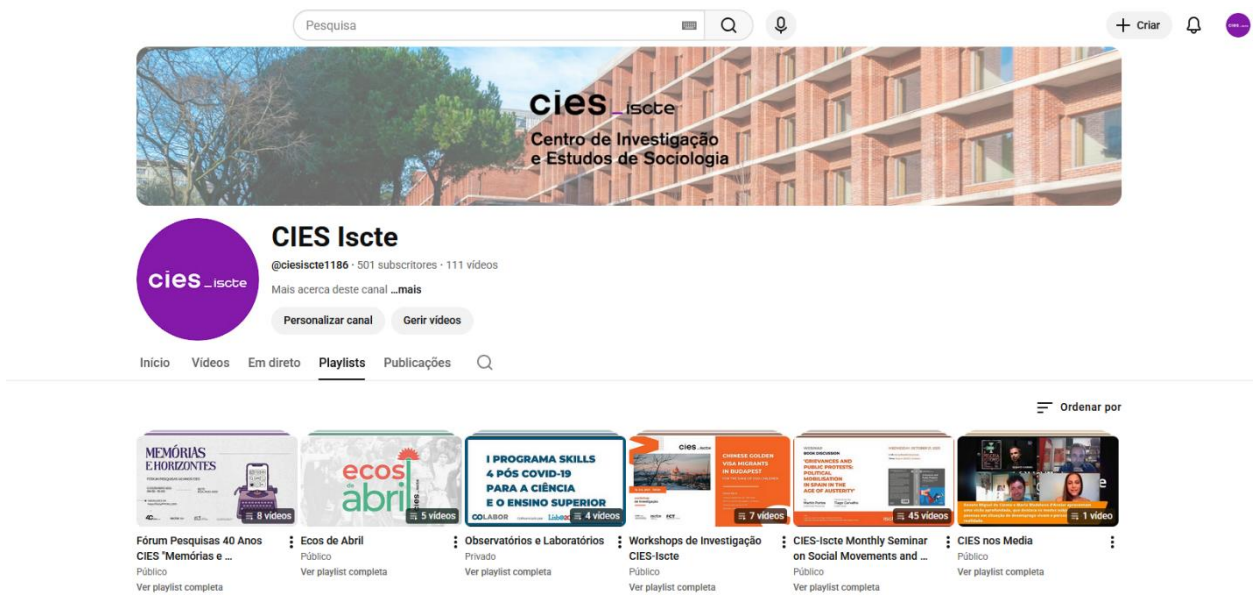
The page gained 649 new followers through entirely organic growth, while generating 92 042 impressions, 5 845 clicks and 1 279 page views throughout the year.

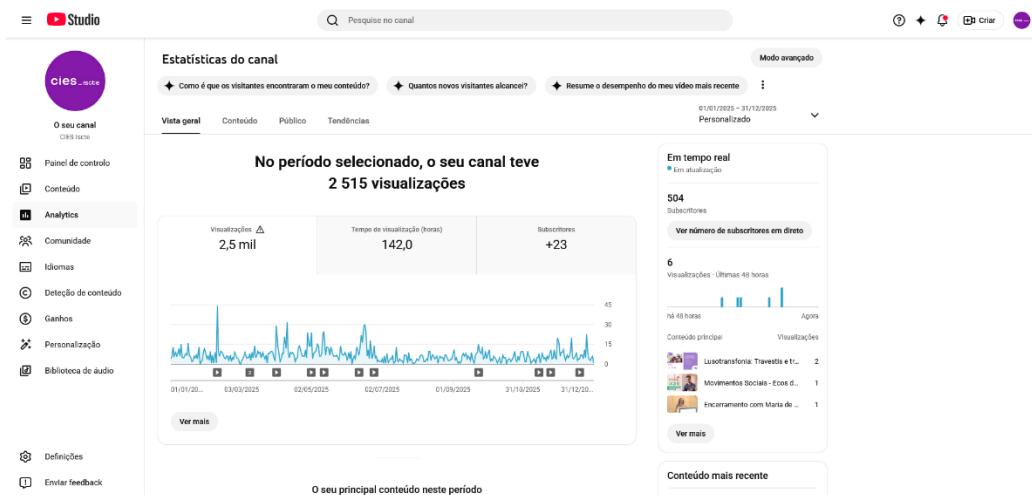
Content performance remained positive, with publications generating 1 869 reactions, 24 reposts and 16 comments, resulting in an average engagement rate of 7.64%. Periods of higher interaction throughout the year suggest increased audience engagement associated with institutional events, publications and research dissemination activities.

YouTube Channel

The CIES-Iscte YouTube channel is the main streaming tool of the center and hosts a vast archive of videos of scientific events, podcasts, and documentaries.



In 2025 the channel registered 2.5 thousand views and 142 hours of watch time, reflecting sustained audience interest in the audiovisual dissemination of the institution’s work.



The channel also recorded continued growth in its subscriber base, with an increase of 23 new subscribers over the year. The evolution of views and subscriber growth throughout 2025 suggests a stable and consistent engagement with the content published, reinforcing YouTube as an important platform for the dissemination of academic and scientific activities developed by CIES-Iscte.

Sources of Funding

Overall, the volume of the sources of funding remains similar to the previous year, with a very slight decrease.

FCT remains the major source of funding, given its support to the recruitment of researchers (work contracts for full-time PhDs). In 2024, there was a significant decrease in this funding because the research contracts under the Norma Transitória (Decreto-Lei 57/2016, Lei 57/2017) achieved their six-year limit and have ended. Some of these researchers, as well as others hired under the FCT "Stimulus to Scientific Employment" Program, were integrated into the faculty of Iscte, no longer holding a research contract. Also, concerning funding from FCT, the pluriannual is being maintained and there has been an increase in income because the FCT settled payments requests more promptly.

The level of funding from Portuguese public bodies and Portuguese private institutions had an overall rate of 23% which represents an increase in this type of financing.

The European Union funding continued to increase in 2024, with a continued expansion in this type of financing.

Expenditure structure

The distribution of expenditure in 2024 remains broadly similar to previous year.

As in previous years, Human resources are the major cost of CIES-Iscte's expenditure. This category includes the technical team of science managers and hired PhD researchers (with work contracts) and research assistants who have grants for the development of activities within the scope of the Center's observatories.

The purchasing of services to support researchers and research activities is slightly higher than in 2023 (around 20% of total expenditure).

Regarding the direct expenditure executed under FCT Pluriannual Funding and by category, the following is observed:

The Human Resources category has registered an increase in value.

The value of travel expenses is slightly lower than in 2023. In this item are included expenses related to fieldwork and networking meetings.

The dissemination category includes travel expenses (registration, accommodation and travel) for the presentation of papers at scientific meetings and other activities to disseminate the Centre's activities and scientific results. This category also includes the maintenance costs of the CIES-Iscte website and open access. The amount of expenditure recorded under this item is very similar to the previous year.

The procurement to support researchers for expenses such as translation and proofreading registered a decrease.
