# 1.1 Presentation and Guidelines

The Center for Research and Studies in Sociology / Centro de Investigação e Estudos de Sociologia (CIES-Iscte) of the University Institute of Lisbon / Instituto Universitário de Lisboa (Iscte) is a R&D unit, recognised and evaluated by the FCT (Foundation for Science and Technology), in the area of social sciences dedicated to studying contemporary social problems from a multidisciplinary perspective. Constituted in 1985, it is an organic unit of Iscte and is part of its School of Sociology and Public Policy.



CIES-Iscte's main scientific domain is sociology, developing relevant activity in the fields of public policy, political science, communication, education, modern and contemporary history, and social work.

CIES-Iscte's activity is characterised by a demanding articulation between basic research, applied research mainly directed at the design, monitoring and evaluation of public policies in various sectors and areas of intervention and advanced training.

The Center's research and scientific production, fosters diversity and the crossing of intensive and extensive approaches, aimed at deepening the analytical relationship between the study of social, political, and historic macro-processes and the social, cultural, and spatial micro-dynamics.

Including 132 integrated PhD researchers, the research team has a significant number of foreign researchers (17%) from 18 different nationalities.

CIES-Iscte's integrated PhD researchers are professors at Iscte or full-time researchers at the Center. Another part of the integrated PhD researchers are professors at other national university and

polytechnic higher education institutions, among which the Beira Interior University - UBI, where the CIES-UBI Pole is located.

Regarding the Centre's internal organization, in 2021 there was very relevant activity focused on the reorganization of the research groups. In order to meet the recent intense dynamics of the research teams, activities and groups, a restructuring of the latter has been carried out. There are now seven research groups, as follows:

- Inequality, Work and Social Well-Being
- Migration, Mobility and Ethnicity
- Education and Science
- Media and Culture
- Family, Generations and Health
- Politics and Citizenship
- Historical Dynamics and Global Integration of the World

The first four resulted from a division of two of the Centre's core groups since its foundation - Inequalities, Migration and Territories; Knowledge Society, Competences and Communication -, that had hugely grown and deepened in recent years. The new groups resulting from this division are more cohesive and focused. The groups Family, Generations and Health and Politics and Citizenship were maintained as they have been working very well, achieving great goals in terms of scientific results, internationalization, and social impacts. The group Historical Dynamics and Global Integration of the World was renamed to represent its thematic focus more clearly. Lastly, a decision was made to extinguish the group Work, Innovation and Social Structures of the Economy and to integrate its members and activities into the new Inequality, Work and Social Well-Being group, which covers the essential issues in the area of work that were being addressed, allowing an enriching articulation with the other topics of this group.

The groups' coordination teams were renewed in some cases, providing opportunities for new researchers. This reorganization will match the Centre's dynamics, increasing the potential for greater dynamism of each group, as well as between groups.

The development of the CIES-Iscte strategic plan is also anchored in a set of permanent research platforms which are transversal to the research groups and are one of the Center's distinctive features:

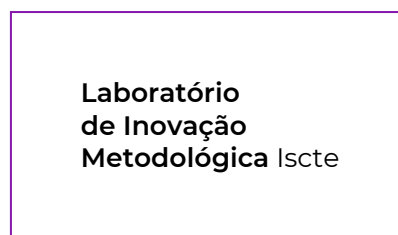

Advanced training is another fundamental pillar of CIES-Iscte, closely combined with research activities. The Center is responsible for the scientific and administrative coordination of 7 PhD programs - [Sociology, Public Policy, Communication, Social Work, Political Science, Modern and Contemporary History and Policies of School Administration and Management](#) – and is associated with 4 others (Political Economy; Communication Studies: Technology, Culture and Society; Urban Studies; History: change and continuity in a global world - PIUDHist).

In 2021, scientific meetings were in many cases online or in a hybrid format because of the COVID pandemic. The transition to this format was successful and has allowed the widening of audiences and of the dissemination of events and their outcomes. Along with the scientific events under research projects, CIES-Iscte also organised regular activities to contribute to an environment of up-to-date scientific debate, such as the [research seminar cycles](#) and the [annual Research Forum](#), in this edition dedicated to Reflections and Interventions in Communication and Culture.

Activities to promote scientific culture has been one of the Centre's concerns and researchers have participated actively. In 2021, CIES-Iscte promoted initiatives with the Agência Ciência Viva (internship for secondary students) and participated in the European Researchers' Night with two activities focused on climate change: the debate The Planet Calls. Don't stay neutral! and the Hand-made Poster Exhibition: There is no planet B.

In the editorial field CIES-Iscte publishes since 1986 the scientific journal [Sociologia, Problemas e Práticas](#) [Sociology, Problems and Practices] and, since 2020, jointly with CEI-Iscte, the journal [Ler História](#), both are indexed by several international databases as detailed further below. CIES-Iscte also supports the indexed journals [Portuguese Journal of Social Science](#) and [Observatory \(OBS\\*\)](#) and publishes the [CIES e-Working Papers](#). Since 2010, CIES-Iscte has its own publisher, [Mundos Sociais](#), that publishes the journal and refereed social sciences' academic books.

In terms of institutional organization at macro level, the integration of CIES-Iscte in two structures recently launched will mark its activity in the next years.

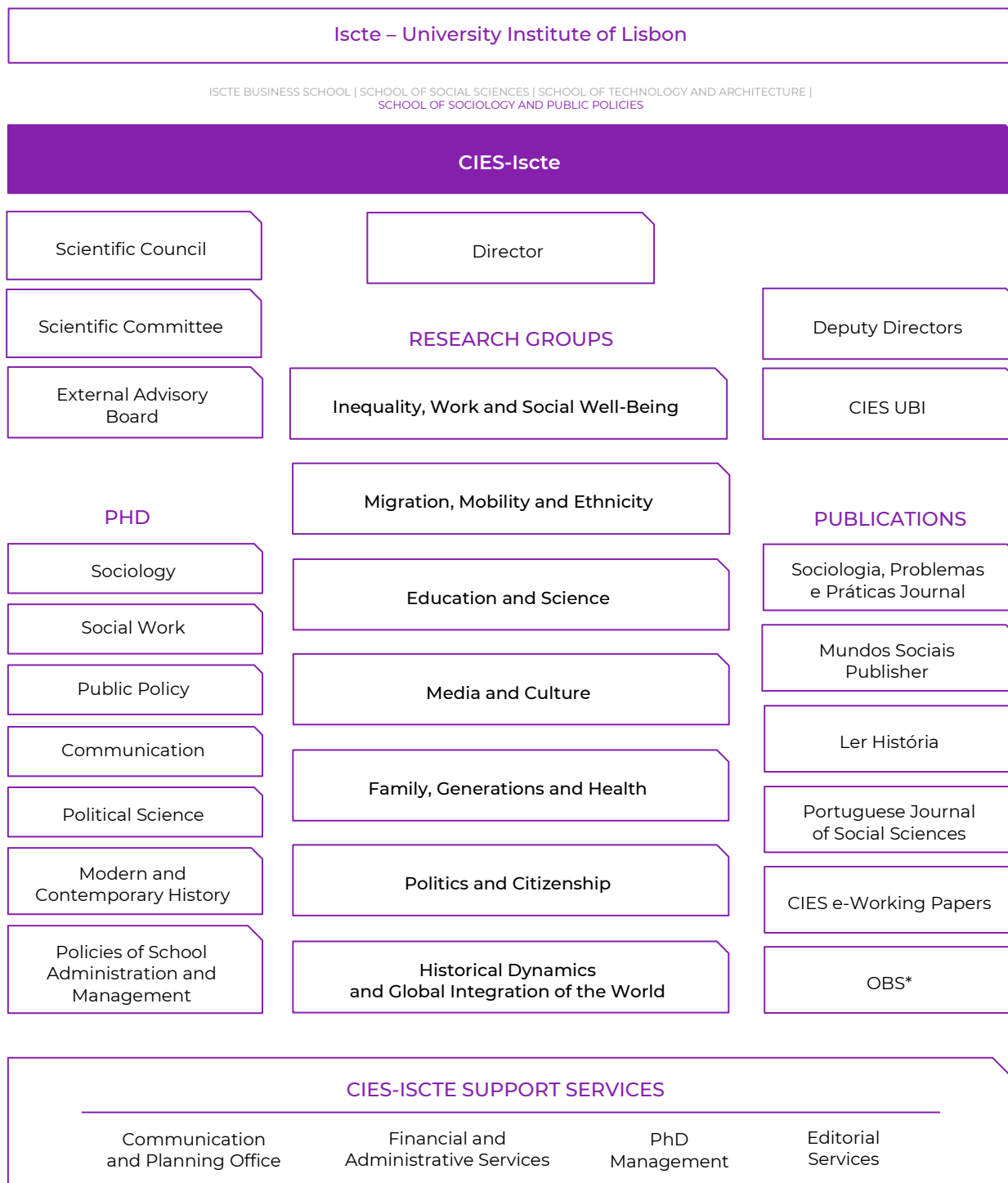
CIES-Iscte is the principal institution of the [Sociodigital Lab for Public Policy](#), composed by six research units of Iscte, submitted to FCT in 2020 for the status of Associate Laboratory and approved in 2021. By bringing together and crossing the competences of the six research units in social sciences and digital technologies, it aims to foster an interdisciplinary approach to the study of public policy and contribution to the resolution of contemporary societal problems and global challenges.

The association [Iscte - Conhecimento e Inovação, Centro de Valorização e Transferência de Tecnologias \(CVTT\)](#) was created in 2020 with Iscte and its research units as founding members. CIES-Iscte is one of those members and its Director is a member of the General Assembly. Its key aim is to provide integrated knowledge transfer solutions for society, organizations, businesses, and public administration by combining two flagship areas of research at ISCTE: social sciences and humanities and digital technologies. The project will bring together in a single space (a building adjacent to the Iscte formerly belonging to the IMT) the research groups and resources – eight research centers, ten laboratories and three observatories – currently dispersed on the Iscte campus.

## Support services

CIES-Iscte has a set of support services which include the Communication and Planning Office, the Financial and Administrative Services, the PhD Programs Management and the services of the *Mundos Sociais* publisher and the journal *Sociologia Problemas e Práticas*.

In 2021, a total of eleven full-time staff members were assigned to these services, supporting the research team and the Center's governing bodies.

The functions performed by the Communication and Planning Office are threefold: to search for opportunities and to support the submission of applications for research activities and to monitor and manage the scientific activities in progress; the organization of scientific events and other forms of dissemination, including the promotion of scientific culture; and the communication of activities and scientific results of the Center including online platforms and through social media.

The Financial and Administrative Services ensure budget elaboration and justification for applications and the financial management of ongoing research projects and activities, ensuring compliance with the procedures of the host institution and the requirements of the various funding institutions. These services also ensure the execution of the funds and financial prizes granted to members of the research team provided by Iscte and other sources.

The PhD Management service accompanies the students in all phases of the PhD program, from the application to its conclusion, as well as guarantees support to the teachers and the teaching activities, also managing the International Cycle of PhD Conferences and other scientific meetings.

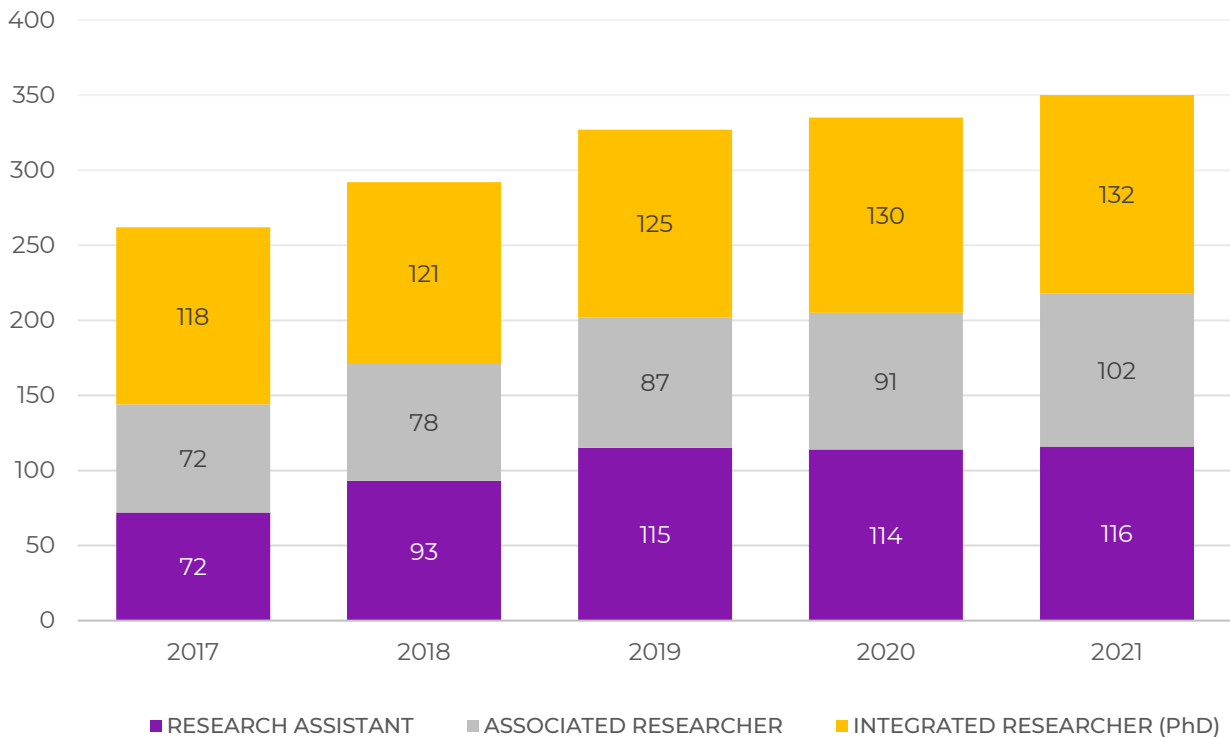
The supporting services of *Mundos Sociais* publisher and the journal *Sociologia, Problemas e Práticas* cover the entire editorial, publication and dissemination process of the books published by *Mundos Sociais*, the journal *Sociologia, Problemas e Práticas* and the CIES e- Working Papers. They also ensure compliance with the procedures for the inclusion of CIES-Iscte's publications in scientific repositories and in national and international indexation databases.

# 1.3

## Research team

The CIES-Iscte research team includes Researchers (integrated PhDs), Associated Researchers and Research Assistants. Together, in 2021, the CIES-Iscte research team consisted of 350 members.

Research team 2017-2021



The Research Assistant category is mainly composed of master's or PhD students, who are part of research projects or observatories/laboratories teams, through research grants, and PhD students, with individual grants to carry out the research work for their theses.

The Researchers (integrated PhDs) category has grown gradually and consistently through the years. Some stability, although temporary, is a result from the FCT scientific employment program, which has allowed, since 2019, to hire PhD researchers on a contractual basis.

Regarding the number of PhD researchers with 100% affectation and employment contract, as mentioned, in 2019 there was a significant increase following the great effort CIES and Iscte had made to quickly implement the FCT scientific employment program created through the *Decreto-Lei 57/2016, Lei 57/2017*, namely the *Norma Transitória* that converted post-doctoral grants into research contracts (25 researchers were contracted under this program). Also, annually since that year the FCT has opened the Stimulus to Scientific Employment - Individual call, which also allows the hiring of PhDs under the above-mentioned law and under which CIES has hosted researchers

with approved applications every year. In both cases the contracts under this program have a six-year commitment to the institution to develop a research plan that they have proposed.

This legal framework has also allowed the hiring of PhD researchers within the scope of research projects, with national or international funding, and under the Multi-annual Funding of R&D Units by FCT. In these cases, the duration of the contract is more precarious due to its limitation by the duration of the project/funding.

The ongoing contracts maintained stable figures (33 in 2020 and in 2021) despite some annual renewal. Every year new contracts start, but some come an end, in the context of research projects, and also some contracted researchers resigned their position by joining the academic teaching career or permanent positions, at Iscte, in Portugal and abroad.

Regarding gender distribution of the team, as can be seen in the table below, the percentage of female researchers in each of these categories is around 60%.

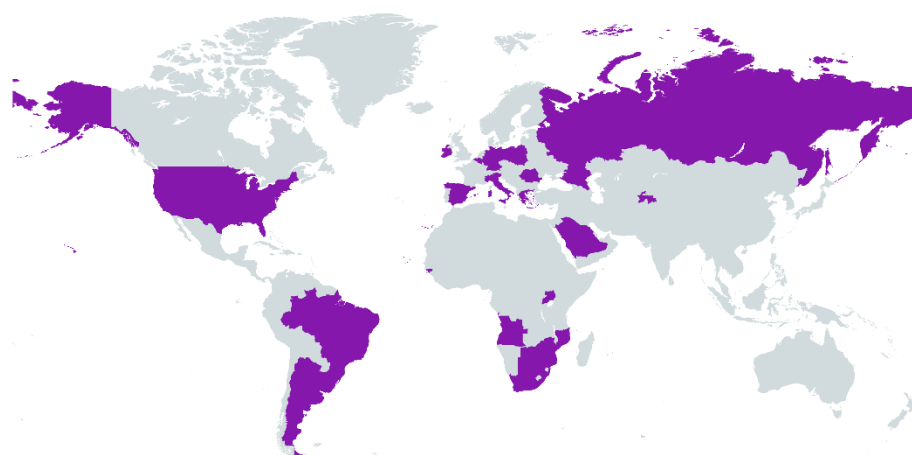
Integrated PhD researchers are mostly professors at Iscte – *Instituto Universitário de Lisboa* or full-time hired researchers at the Center.

Another part of the integrated PhD researchers belongs to other national higher education institutions, among which the University of Beira Interior (UBI) and polytechnic institutes of different areas (Health, Tourism, Education) and regions of the country (North, Central and Metropolitan Area of Lisbon). The seven integrated PhD researchers from the University of Beira Interior (UBI) integrate the CIES-UBI Pole.

Regarding CIES-Iscte members with research grants, they totalized 94 in 2021, of which 52 were PhD scholarships (with FCT funding), 38 are grants for research assistants within the framework of research projects, and 4 were postdoctoral grants. Three of these post-doctoral fellowships are the last CIES has been hosting with funding under FCTs’ fellowship program, which last edition took place in 2016. As mentioned above, FCT is now implementing the Stimulus of Scientific Employment, which foresees the grant of work contracts of limited duration instead of fellowships.

Looking at the teams’ internationalization, in 2021, 17% of the members of the research team are foreign, of 18 nationalities, as shown on the following map.

During 2021, CIES-Iscte welcomed 14 visiting researchers from Brazil, Spain, Italy, Sweden, and Hungary, who have begun to come again in greater numbers with the lifting of some of the circulation restrictions under the pandemic. Of these researchers 8 were PhD's and 6 were PhDs students who came to do research work for their thesis.

In 2021, the Center also welcomed 17 researchers specialized in different topics who participated in the International Cycle of Doctoral Conferences. Some of these conferences were held online, considering mobility restrictions due to COVID-19 pandemic.

## 2.1 Research groups

The research activities are carried out within the framework of the Research Groups. Following the Centers' research dynamics an update of these groups took place in 2021 in coordination with the past and present group coordinators and the CIES-Iscte bodies.

CIES-Iscte currently has the seven research groups listed below and the researchers' inclusion in them is based on the themes of their research activities, which can be carried out in more than one group. There are also projects and other activities with cross-cutting themes that mobilize researchers from different groups.

The new groups resulting from this division are more cohesive and focused. The groups Family, Generations and Health and Politics and Citizenship were maintained as they have been working very well, achieving great goals in terms of scientific results, internationalization, and social impacts. The group Historical Dynamics and Global Integration of the World was renamed to represent its thematic focus more clearly. Lastly, a decision was made to extinguish the group Work, Innovation and Social Structures of the Economy and to integrate its members and activities into the new Inequality, Work and Social Well-Being group, which covers the essential issues in the area of work that were being addressed, allowing an enriching articulation with the other topics of this group.

The groups' coordination teams were renewed in some cases, providing opportunities for new researchers. This reorganization will match the Centre's dynamics, increasing the potential for greater dynamism of each group, as well as between groups.

When necessary, researchers were reallocated to the new groups and projects and activities were reclassified to allow for longitudinal analysis.

In this year of transition and for the consolidation of the seven research groups reorganized in 2021 support has been given and will be reinforced, including regular meetings, and ensuring an environment that encourages joint initiatives and activities. Also, regular meetings with the coordinators of the Research Groups will start to prepare for the FCT evaluation of research units.

# Overall research indicators

### Research projects

CIES-Iscte conducts basic research projects funded by public calls with scientific assessment issued by public and private, Portuguese, and European agencies and foundations and applied research projects mainly directed at the design, monitoring and evaluation of public policies based on the Centers' consolidated scientific skills.

Researchers can propose projects and other scientific activities with much independence. This culture of initiative and cooperation is a firmly established practice. To a great extent, it is the source of the Center's ability to quickly react to the opportunities and challenges in research and enables it to place emerging, socially, and scientifically relevant issues on the research agenda.

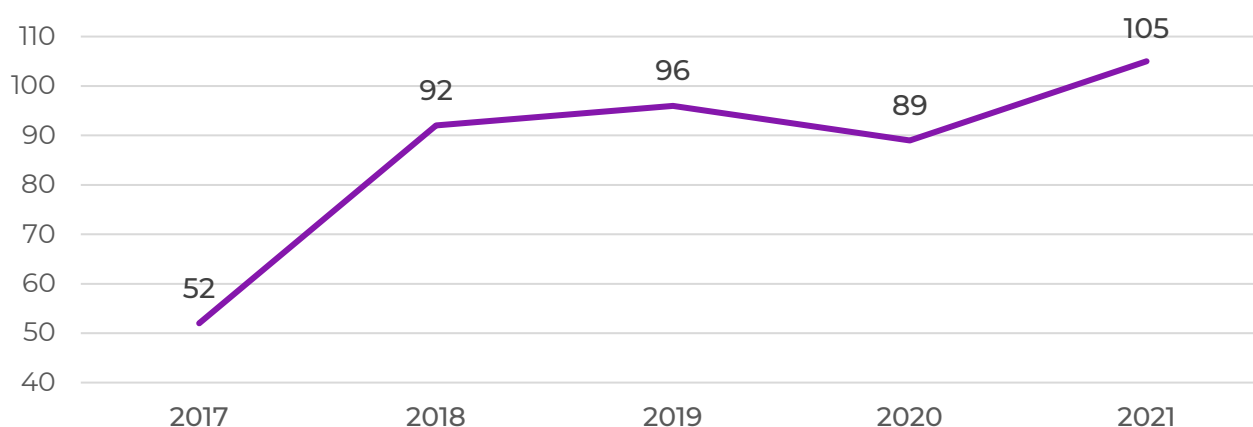
For example, there have been several initiatives and projects to analyse the effects of the Covid-19 pandemic on various sectors of the society and the perceptions about it.

Concerning the overall number of ongoing projects, there has been a gradual increase in the number of funded projects that reached 105 in 2021.

In 2021, the projects with international funding, had the following sources: Horizon 2020/Horizon Europe, Erasmus+, DG Employment, Social Affairs and Inclusion, European Digital Media Observatory, AMIF - Asylum, Migration and Integration Fund, EEA Financial Mechanism.

Among the projects with national funding, there is a variety of sources, demonstrating ability to attract and obtain funding from sources other than FCT. The projects were funded by other Portuguese public bodies and local authorities (IEFP - Instituto do Emprego e Formação Profissional / Institute for Employment and Vocational Training, INR - Instituto Nacional para a Reabilitação / National Institute for Rehabilitation, IDN - DG de Recursos da Defesa Nacional / National Defense Resources, DGPC - DG Património Cultural / Cultural Heritage, Intermunicipal Communities of Alto Alentejo, Baixo Alentejo and of Cávado, Municipalities of Cascais, Maia, among others), private and social sector organisations (e.g. Aga Khan Foundation, Calouste Gulbenkian Foundation, FFMS - Francisco Manuel dos Santos Foundation).

# Publications

Publication is a core element of scientific activity as a way of disseminating knowledge and results to the scientific community and society. Recent years have shown a transition in the publication pattern of the team of researchers at CIES-Iscte. Despite the increase in articles in indexed journals, namely in the Scopus and the Web of Science (WoS) databases, CIES-Iscte researchers managed to keep a balance between the different types of publications, maintaining the publication rates of books and chapters and thereby ensuring the presentation of results to the international scientific community and dialogue with Portuguese society.

The overall number of publications is at the same level as in recent years, amounting to 487 in 2021, as shown in the following table.

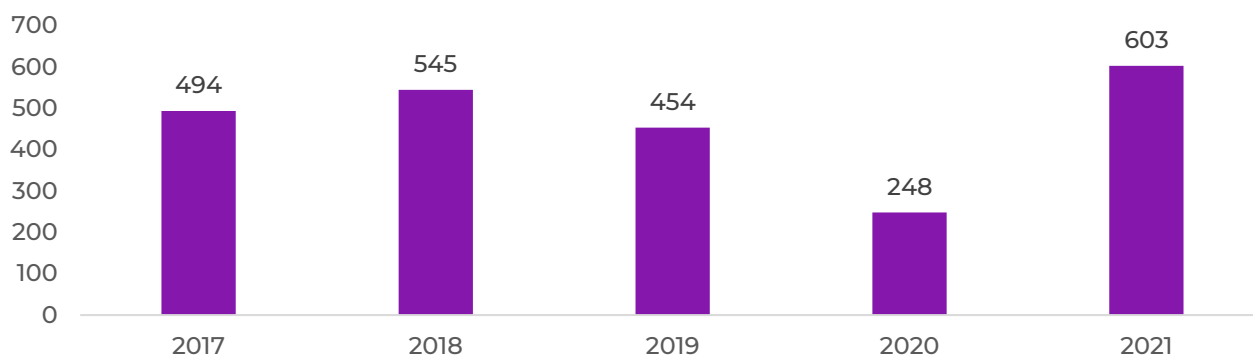

## Presentations at scientific meetings

In 2021, most scientific meetings were in a hybrid format. The transition to this format has allowed a widening of audiences and increased the dissemination of events and their outcomes. Along with the scientific events organized within research projects, CIES-Iscte also organized regular activities – detailed later in section 5. Scientific Events – to contribute to an environment of up-to-date scientific debate, such as the research seminar cycles and the annual Research Forum, in this edition dedicated to Reflections and Interventions in Communication and Culture.

In total, in 2021, researchers participated in the organization of 232 national and international scientific meetings and presented over 600 communications, returning to the pre-pandemic figures.

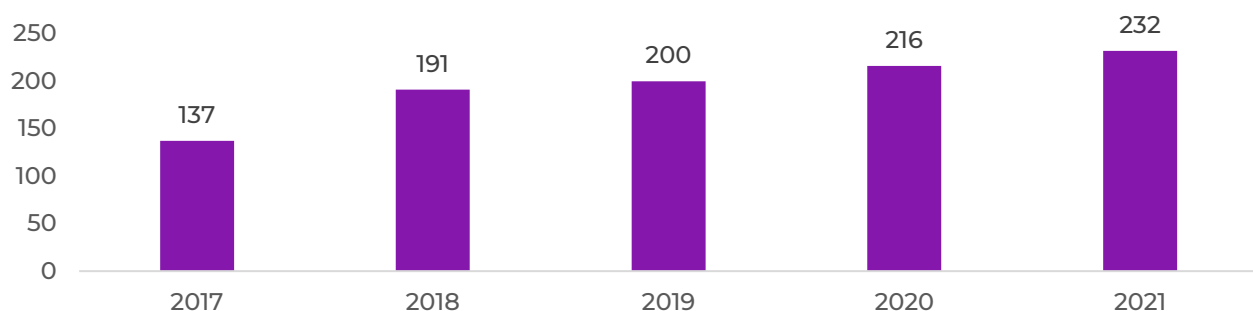
### Presentations at scientific meetings (2017-2021)

# Observatories and Laboratories

CIES-Iscte fosters several permanent research observatories and laboratories in scientific relevant areas promoting public debate on pertinent issues in each area. The Inequality Observatory (OD) and the Emigration Observatory (OEm) have fifteen years of existence and have achieved growing scientific and social recognition. In 2018, two other research platforms were created within the framework of CIES-Iscte: The Portuguese Observatory on Cultural Activities (OPAC) and the Laboratory for the Social Studies on Childbirth ([nasc.pt](http://nasc.pt)). More recently, the Observatory for Democracy and Political Representation has started activity and, from 2021, significant steps were taken in the development of the Laboratory of Innovative Methodologies (LIM), a research structure that will seek to disseminate and further develop methodological innovation practices among CIES-Iscte researchers and research areas and to strengthen interdisciplinary collaboration in this area.

CIES-Iscte is also an honorary member of the Communication Observatory ([Obercom](http://Obercom)), which analyses and assists in public policies, sector companies and academic research in communication sciences, and integrates the Collaborative Laboratory for Work, Employment and Social Protection - [CoLABOR](http://CoLABOR), that was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

# Inequality Observatory

CIES-Iscte is responsible for the operation and scientific coordination of the Inequality Observatory (OD) having as partner institutions, since its initial phase, the Institute of Sociology (Instituto de Sociologia) of the Faculty of Arts of the University of Porto (ISFLUP) and the Center for Social Studies (Centro de Estudos Sociais) of the University of the Azores (CES-UA, today CICS.NOVA.UAc). The OD studies different aspects of inequality. It conducts international comparisons of statistical indicators and a wide range of constantly updated studies and research.

In its implementation phase in 2008, it received the support of the Presidency of the Council of Ministers, the Ministry of Labour and Social Solidarity and the Ministry of Education. Since then, it has been supported exclusively by CIES-Iscte. In addition to fostering scientific knowledge in this area, the OD's mission is to publish accurate, up-to-date information on inequality from the viewpoint of citizenship and a contribution to the justification and assessment of public policies. This means that it is a tool for research and scientific dissemination. It is a founding member of the European Inequality Watch network, which involves similar observatories and other institutions from different countries.

In addition to its permanent work of updating and developing of new indicators, expanding the glossary and the national and international links, producing the newsletter, news releases, replying to press requests, hosting internships namely for master students, among others, in 2021 the main activities and outputs were:

- Edition, launch and dissemination of the book "[Desemprego em 2020. Impactos da pandemia, mapeamentos e reflexões](#)" (Unemployment in 2020. Impacts of the pandemic, mappings, and reflections).

- Collection and dissemination of [two interviews](#) (with Ana Nunes de Almeida and Susana Peralta).
- Implementation of the study "[Desemprego e Precariedade Laboral na População Jovem: Tendências Recentes em Portugal e na Europa](#)" (Unemployment and Labour Precariousness in the Young Population: Recent Trends in Portugal and Europe).
- Preparation and presentation of several papers at scientific events (e.g., two papers at the Portuguese Sociology Association - APS Congress, one on inequalities in housing and the other on inequalities in the labour market).
- Organisation of a book entitled "What Future for Equality? Thinking Society and the Post-Pandemic", to be published in 2022.
- Launch of [reviews](#) ("Gender, power and progress: How norms change", by Francisca Reina; and "A Miséria do Tempo: Vidas Suspensas pelo Desemprego" (The Misery of Time: Lives Suspended by Unemployment) by Sara Franco da Silva).
- Collaboration in the final report on social inequalities in housing within the scope of the Working Group on Social Inequality Indicators of the Statistical Council.
- Publication of two [working papers](#): "Empoderamento político das mulheres em perspetiva comparada: uma revisão crítica dos índices de género" (Women's political empowerment in a comparative perspective: a critical review of gender índices) by Francisca Reina and "Desenvolvimento Humano e Desigualdades de Género nos PALOP – Tendências do Novo Milénio" (Human Development and Gender Inequalities in PALOP - Trends in the New Millennium) by Tânia Liberato.

# Emigration Observatory

The Emigration Observatory (OEm) is an independent research and technical structure integrated in the CIES-Iscte, where it has its office. It operates based on a partnership between this Center and the Center for Geographical Studies and the Research Center for Economic and Organisational Sociology, both of the University of Lisbon and the Institute of Sociology of the University of Porto. The interdisciplinary research team is supported by a Scientific Council which brings together experts from Portuguese universities.

The main objective of OEm is to collect, harmonise and analyse information on the evolution and characteristics of Portuguese emigration and emigrated Portuguese populations by collecting data from the statistical institutions of the countries of destination of emigration. The objectives of the Observatory are also: to disseminate all the information compiled and promote their availability and discussion to the general public, in particular to researchers, technicians, students, policy makers and journalists; contribute, through its activity, for the definition and evaluation of information-based public emigration policies and knowledge about this policy area.

OEm is a pole of other initiatives, such as the Migration Network, which includes 350 researchers from several countries and is also the interlocutor of other national and international observatories and collaborates regularly with the media.



As in previous years, annual indicators were made available on stocks (total population, nationality, nationality, Portuguese origin, and consular records), Portuguese inflows in destination countries, acquisition of nationality in the destination country and emigrants' remittances. In 2021, the work of periodic compilation of statistical indicators on the entry and stay of Portuguese in the countries of destination of emigration was continued, updating the indicators for the set of destination countries. The number of countries with information on the new indicators on sex and age group for those born in Portugal, with Portuguese nationality and entering Portuguese was also extended to all countries for which information was available.

The Observatory also systematically and periodically collects diverse documentary information on Portuguese emigration, namely bibliographic, film and research references, links to different types of entities, particularly emigrants' associations, and press clippings. In 2021, the Observatory continued the work of periodically compiling this information, available on the website under "Resources".

The website is indeed the main instrument of daily relationship with the OEm audiences, as it is regularly updated and progressively extended to cover more data, publications, and relevant information, with access open in three languages (Portuguese, English and French, the latter still being updated) and disseminated through a newsletter.

With regard to [expert interviews](#), in 2021, the Observatory ensured: the collection of six new interviews with researchers Alan Gamlen, Thomas Faist, Giuseppe Formato, Giuseppe Sciortino, Bridget Anderson (published in 2021) and Jean-Pierre Cassarino (to be published during 2022); the publication of two interviews conducted in 2020 with Diego Acosta and Duval Fernandes; and the revision and publication of an interview with researcher Jorge Arroiteia.

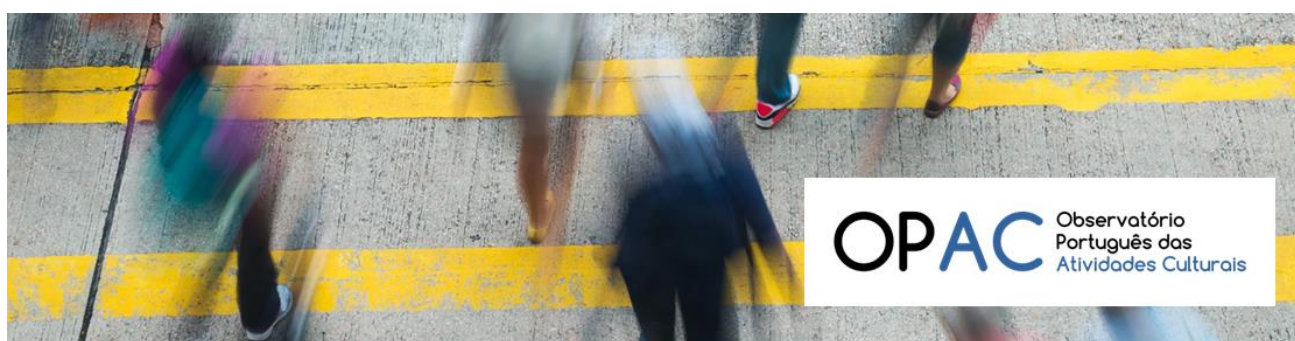
[OEm publications](#) include books, reports, information briefs, studies, and testimonials, and are organised into six periodical collections: OEm Conversations With..., OEm Country Reports, OEm Fact Sheets, OEm Working Papers, Portuguese Emigration Factbook the Statistical Report. In 2021, the Observatory published eight issues of the OEm Conversations With... collection, three OEm Fact Sheets, on 2020 remittances, Portuguese residence permits in Brazil, 2000-2015 and births in Spain to Portuguese mothers, 1996-2019; A OEm Country Report on the Netherlands, a OEm Working Papers on the integration of Portuguese emigrants into the labour market; the Portuguese Emigration Factbook 2020 (in English) and Portuguese Emigration 2021 Statistical Report, partially integrated in the annual report on Portuguese emigration of the responsibility of the Office of the Secretary of State for the Portuguese Communities; the first volume of the new book collection Estado da Emigração Portuguesa, on Three Studies on the New Portuguese Emigration.

The Observatory promotes, in collaboration with other entities, scientific and science communication meetings, as well as training actions. In 2021 the highlight goes to the organization of the colloquium "[Potencial Económico da Diáspora](#)" (Economic Potential of the Diaspora), in partnership with the Secretary of State for Portuguese Communities and the Regional Council of Portuguese Communities in Europe (CRCPE) and of four webinars with international speakers on various migration-related topics: Alan Gamlen "Suspended Globalization: Human Migration and Mobility After the 2020 Pandemic"; Thomas Faist "The Transnationalized Social Question: Migration and the Politics of Inequalities"; Giuseppe Sciortino "International Mobility and Emerging Lovespaces: Human Migration as an Intimate Experience" and Bridget Anderson "Can we de-colonise 'migration'?".

# Portuguese Observatory on Cultural Activities

The Portuguese Observatory on Cultural Activities (OPAC) was launched in 2018 within the framework of CIES-Iscte, which is responsible for its scientific coordination and functioning. Its main goals are to ensure the development of accurate and up to date research and public availability of studies and information related with various cultural domains and themes aiming to contribute to current debates in Portuguese society and the formulation, monitoring, and evaluation of public policies. Despite the strong emphasis on Portuguese reality, OPAC also has a transnational comparative perspective, particularly within the EU.



In 2021, besides the various publications including in scientific journals, meeting and dissemination proceedings, conference papers, training actions, scientific dissemination initiatives and the hosting of internships, the following activities of OPAC may be highlighted:

As part of the [Study of the Artistic and Cultural Sector in Portugal \(ESAC\)](#), which stems from an institutional partnership agreement between DGARTES and Iscte through OPAC, the Survey of Independent Arts and Culture Professionals was conducted (responses of 1,727 independent professionals collected in October/November 2020). Under this survey, four reports were released: Report #1 Cultural employment and social and labour profiles; Report #2 Labour relations and wages; Report #3 Social Security and Finance Framework; Report #4 Representations on self-employment in arts and culture. This was the first of three modules that will make up the Study.

The study [DOCLISBOA - International Film Festival: impact of the festival and its audiences](#), which foresees the monitoring of three editions of the [festival](#), in 2021, 2022 and 2023 began. It includes survey of in-person audiences and an online survey of professional participants.

The study [From safeguarding to valorisation. Portugal's national monuments and their opening to the public](#), which began in 2019, had its [third edition](#). This survey had two specific objectives: to update statistical series for 2020 on public use and access, visitors, and human resources; and to further collect information on the impacts and activities carried out throughout the pandemic crisis between March 2020 and April 2021.

The results of [the second part of the study Reading Practices of Students in Primary and Secondary Education](#), concerning the 1st and 2nd cycles, were presented on 7 December, with online transmission and the presence of the Commissioner and Sub-Commissioner of the National Reading Plan (PNL2027) and the State Secretary for Education.

Nascер.pt, the Laboratory for the Social Studies on Childbirth, is a permanent structure linked to CIES-Iscte, which brings together a group of researchers from different scientific and professional areas, and from different institutional and geographical contexts. Its aim is to foster knowledge about the conditions and characteristics of childbirth in Portugal, to contribute to the consolidation of the Sociology of childbirth and, at the same time, to develop synergies between structures and multidisciplinary approaches in the study of childbirth, both at national and international level.



In 2021, the Laboratory nascер.pt continued its regular activity, maintaining its website and social networks (Youtube, Facebook and Instagram), to disseminate online content in a broad perspective. [Indicators](#), [research projects](#), [scientific articles](#) or information about childbirth in Portugal were published throughout the year.

To reach its objectives of fostering interdisciplinary knowledge and dissemination about the conditions and characteristics of childbirth in Portugal, a blog with launched in 2021, and 5 articles published: [O Laboratório](#) (The Laboratory); [O que querem as mulheres no parto? Algumas pistas do Babies Born Better Portugal](#) (What do women want in childbirth? Some clues from Babies Born Better Portugal); [A emergência de maternidades “naturalizadas” como uma questão de igualdade e cidadania](#) (The emergence of 'naturalised' motherhood as a question of equality and citizenship); [2 minutes for nascер.pt](#), a video in which the coordination of the Lab - Dulce Morgado Neves, Mário JDS Santos and Sónia Cardoso Pintassilgo - talk about the vision and mission of nascер.pt.



# CoLABOR

The Collaborative Laboratory for Labour, Employment and Social Protection (CoLABOR) was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

With nine partners and a multidisciplinary team of highly qualified researchers [CoLABOR](#) mobilises resources from academia, companies, and third sector institutions, having four central objectives: to support the design and restructure of policies in their thematic areas; capacity-building of institutions, including public administration, businesses and institutions in the third sector; to qualify employment through training and the creation of scientific jobs; contribute to public debate in the areas of work and social protection, through effective and innovative forms of dissemination of the results of the research it carries

CoLABOR achieves these objectives through an ambitious agenda of deepening scientific knowledge around three central thematic axes: work and employment; social protection and social facilities and responses.

Across these thematic areas, CoLABOR developed [DataLABOR](#), an innovative platform that aggregates and cross-references statistical and legal data on work and employment, social protection, and the social and solidarity economy in Portugal.

# MediaLab-Iscte

MediaLab-Iscte is a laboratory dedicated to experimentation, supporting research and production of editorial content in the field of communication sciences, but covers also other disciplines in the fields of social and human sciences.

The MediaLab was set up with the strategic objective of providing CIES-Iscte with skills and resources to support scientific research and innovative projects. Its ability to connect theoretical and empirical research with the technological dimension is essential to follow the dynamics of social transformation.

The lab encourages and supports communication practices in its different models and objects – from digital to analogue, from plain text to multimedia, from analysis of online networks and trends to social media networks, research online and user reviews, news media monitoring, data visualization and big data.

Since 2020, MediaLab has been focused on the study of the role of the media and the analysis of disinformation on social networks in the context of the Covid-19 pandemic. In this context and for illustration, in 2021 the following reports were published: [Covid-19: Comunicação e desinformação](#) (Covid-19: Communication and disinformation); [Cobertura jornalística na pandemia de coronavírus](#) (Journalistic coverage in the coronavirus pandemic) within the scope of the News Barometer project (2020 edition); and [O falso plano de desconfinamento: uma anatomia da desinformação e da contranarrativa](#) (The false deconfinement plan: an anatomy of disinformation and counter-narrative), conclusions of a survey of Portuguese users of social networks, through crowdsourcing, with a view to studying the processes of dissemination of disinformation in Portugal.

In 2021 MediaLab continued its work monitoring news production in Portugal, [MediaLab-Priberam News Barometer](#), producing 12 monthly reports and creating structured databases for consultation and further study and to host the Portuguese participation in the European Journalism Observatory (EJO).

In addition to supporting Master and PhD students in research for their theses, the MediaLab also contributes to advanced training by hosting master and PhD student internships and collaborating in the “Science in the Holidays for Young People” activities CIES-Iscte promoted in collaboration with the Agency Ciência Viva. In 2021, also worthy of mention of the laboratories’ outreach activities is the support to the Working Group for the Prevention and Combating of Racism and Discrimination (Presidency of the Council of Ministers) and the Youth Parliament Program (Portuguese Parliament).

## Observatory for Democracy and Political Representation

This observatory results from the consolidation of the long tradition of study of democratic political representation at CIES-Iscte, namely with the various surveys of elected representatives (MPs and non-elected MP candidates) and voters, from at least about two decades ago, comparing the values, orientations and behaviors of both, but also the questions of citizen participation in political processes (individually or collectively, i.e. through interest groups and/or social movements) and the question of the processes of political representation itself assessed through the link between elected representatives, voters and policy making (in the various types of policies).

Its main goal is the collection and dissemination of data on social and political movements and on democracy and political representation in Portugal, Europe, and the World.

In 2021, the Observatory organized the conference “Da austeridade à pandemia: Portugal e a Europa entre as crises e as inovações” (From austerity to pandemic: Portugal and Europe between crises and innovations), held on 17 and 18 June 2021, and that foresees the edition of a book under the same title.

Also in this year, major investment of time was made on gathering of information for the Observatory’s website that will include information of its activities and publications, and data of relevant research projects and is planned to be available in 2022.

With regard to the survey(s) of candidates for the legislative elections (elected and non-elected), the application of the surveys to candidates for the 2019 legislative elections was finalized, via email and post mail, and the database was prepared as well as the report and codebook. The 2022 edition has begun to be planned. These activities ensure the Portuguese participation in the joint multi-national research project [Comparative Candidate Survey \(CCS\)](#).

## Laboratory of Innovative Methodologies

LIM (Laboratory of Innovative Methodologies) is a new structure of CIES-Iscte that seeks to disseminate and develop methodological innovation practices among researchers and research areas of CIES-Iscte, as well as to strengthen interdisciplinary collaboration in this area with other research centers of Iscte, and in particular with the recently created SocioDigital Lab – Associated Laboratory. This will be achieved by the development of interdisciplinary projects with innovative methodological strategies and the design of research projects whose work program involves methodological innovation practices and debate and training activities in methodological innovation.

In mid-2021 a PhD researcher was recruited for LIM, with solid experience in qualitative and quantitative methodologies, and it is expected that in 2022 the laboratory will be fully operational.

# PhD Programs with connection to CIES-Iscte

CIES-Iscte has a long-standing experience of hosting PhD students, which creates a strong interdependence between its teaching and research environments. In order to ensure the completion of high-quality research, PhD students are provided with guidance and supervision by experienced researchers.

Within the School of Sociology and Public Policy at Iscte, the Center provides scientific coordination and management of the following seven PhD programs:

# PhD programs coordinated by CIES-Iscte

As mentioned in the previous section CIES-Iscte currently coordinates a total of seven PhD Programs. The Communication Sciences and Public Policy programs take three years of study, and the Political Science, Modern and Contemporary History, Policies of School Administration and Management, Social Work and Sociology programs take four years of study. In the first year, the students attend seminars on theories and methods, as well as optional curricular units. In the other years, they prepare their PhD thesis, carrying out research at CIES-Iscte. Complementarily, they attend a Doctoral Seminar, the International Cycle of PhD Conferences and the Doctoral Colloquy.

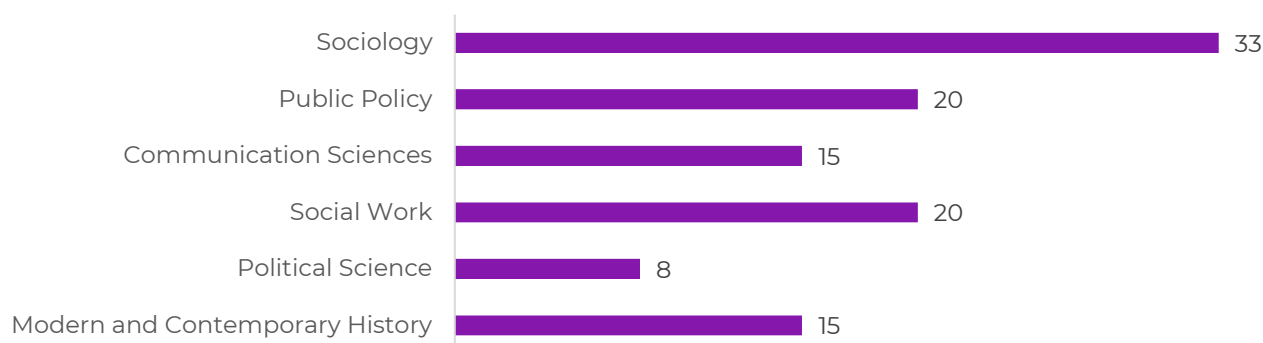
At CIES-Iscte, PhD students actively engage in a diverse range of activities while being strongly encouraged to share the outcomes of their research incrementally and participate in national and international debates.

The Center's support structures ensure the necessary follow-up, both in the administrative management of the students' training path and in their research activities. In this context, CIES-Iscte also provides invaluable assistance to PhD candidates in preparing applications for scholarships from the National Foundation for Science and Technology (FCT), the Iscte and other funding institutions.

PhD students also have access to specialised software (SPSS, MAXQDA, Qualtrics, etc.), to Iscte laboratories (namely, the MediaLab), and to the Iscte Library and access to the Online Knowledge Library (b-on), which provides access to the full text to thousands of journals and ebooks of the main international scientific publishers. Doctoral students with exclusive dedication and scholarships are offered a working space in a shared office.

In 2021, 26 doctoral theses were defended by students of the PhD programs managed by CIES-Iscte.

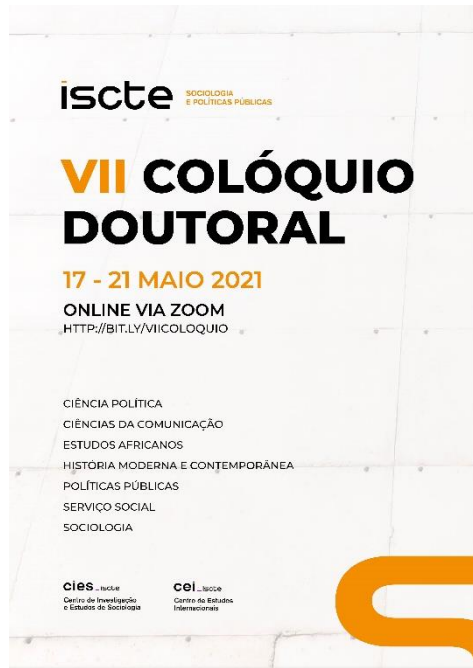

## Doctoral Colloquium

The Doctoral Colloquium of the School of Sociology and Public Policy (ESPP) is an initiative, held since 2013, to publicly present and discuss ongoing research within the doctoral programs coordinated by the School's two research centers, CIES-Iscte and the Center for International Studies (CEI-Iscte).

The initiative also encourages graduate students to become more involved in academic life and to support them in developing their dissertations.

In 2020/2021, due to the pandemic, the Doctoral Colloquy was held online and about five dozen doctoral students, as well as researchers and lecturers from PhD programs in Political Science, Communication Studies, African Studies, Modern and Contemporary History, Public Policy, Social Work and Sociology.



## 4.3 Other advanced training activities

### Summer and winter schools

#### European Drugs Summer and Winter School

In partnership with the IPPS, CIES organizes two annual initiatives: [the European Drugs Summer School](#) and the [Winter School](#). These are supported by experts from the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA). The schools aim to equip professionals and students with the knowledge and skills to address complex policy issues related to drug use in Europe and around the world.

The Winter School, from 01 to 12 March 2021, focused mainly on responses to and preparedness for health-related threats.

The Summer School, from 28 June to 09 July 2021, focused on illicit drugs and vulnerable groups.

In 2021, due to the COVID-19 pandemic, the Winter and Summer School initiatives took place exclusively online. The sessions were also recorded and available for viewing afterwards.

## Research internships

CIES-Iscte welcomes students at various levels of their studies (undergraduate, postgraduate, or doctoral) and offers them the possibility of working as interns in its laboratories and observatories or on research projects conducted at the center.

Research internships are an opportunity for students to get in touch with the reality of a research center. They also allow them to develop methodological and scientific skills that are essential for the development of their projects and theses.

During the traineeship, students are mentored by researchers specialised in the topic of the traineeship and are integrated into the project team or laboratory where the traineeship takes place.

In 2021, CIES-Iscte hosted 22 trainees: 9 undergraduates and 13 masters students.

CIES-Iscte is responsible for promoting events and initiatives that foster an environment of broad and timely scientific debate.

Since 2020, the Center has adapted to scientific events in hybrid formats. This allows wider audience access and availability of content.

In addition to recurring activities and research project initiatives, the Centre develops several interdisciplinary activities throughout the year of which the following are examples.

## CIES-Iscte Research Forum annual

The [CIES-Iscte Research Forum](#) is an annual initiative promoted by the Center that has been taking place since 2006. This initiative aims to publicise the work of CIES researchers in the various fields of the social sciences. It is also an opportunity for exchange, reflection and in-depth discussion on the topics covered.

In 2021, due to the restrictions caused by the Covid-19 pandemic, CIES postponed the 15th edition of the Research Forum to January 2022. The event was held exclusively online, around the theme "Reflections and Interventions in Communication and Culture", which provided a broad platform to discuss topics such as online social networks, cultural practices in a pandemic, inclusion, citizenship and well-being.

## New Perspectives on Modern History

The [New Perspectives on Modern History](#) cycle has been taking place regularly since 2005. It is an initiative aimed specifically at master's and PhD students in the History Department of Iscte but open to all interested parties.

The sessions include the presentation of some of the research projects in progress, developed by Portuguese and foreign historians, from different universities, specialties and generations. This cycle of seminars provides an insight into the current trends in Modern History research: the topics

that are most developed at the moment, the main problems in focus, the new methodologies, the sources used, and the new interpretations that are being produced.

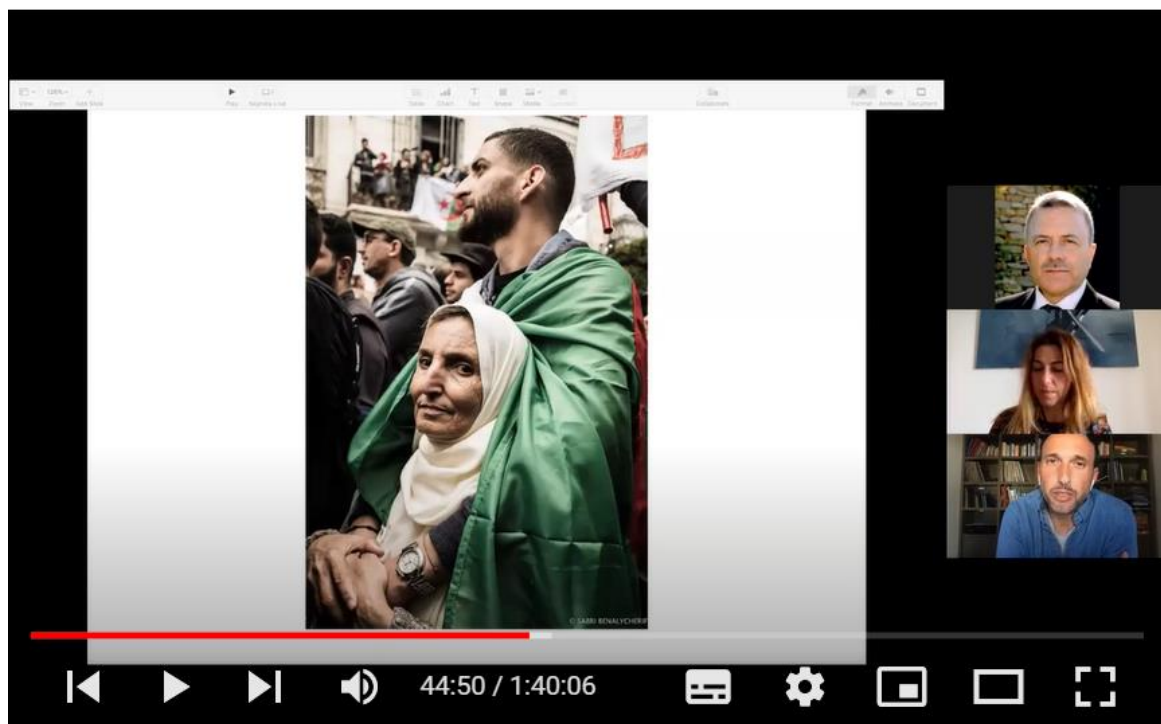
The 2021 cycle includes four meetings: two face-to-face sessions, two online sessions, and one in a hybrid format.

## Monthly seminar on social movements and political action

The [monthly seminar](#) cycle began in 2014, with the aim of multidisciplinary reflection on issues related to social movements and different forms of political action, militancy, and activism.

In addition to bringing different perspectives, methodologies and approaches into dialogue in order to develop an in-depth and innovative debate, the seminar also aims to take advantage of Portugal's special geographical, linguistic and epistemological position to cross different traditions of social movement and political action studies, the different European/North American and South American ones, as well as cases and areas often excluded from this field of study, such as Portuguese-speaking Africa.

Ten sessions of this cycle of seminars have taken place in 2021 and all of them can be watched on the [Youtube channel](#) of the CIES-Iscte.

## Meetings about Migration Experiences

Each meeting focuses on specific ongoing or completed work and research and cross-references practices and questions on methodologies and theories.

### International Congress on the Bicentenary of the 1820 Revolution

The bicentenary of the 1820 Revolution represents both an opportunity and a challenge to re-examine and better understand an important period in modern Portuguese history. The international conference organized to mark the occasion aimed to identify the main lines of interpretation, in line with a comprehensive existing historiographical base, and to encourage the introduction of new analytical approaches and points of view.

The conference was held at the Assembly of the Republic and the Calouste Gulbenkian Foundation and was simultaneously broadcast live on the various organizers YouTube channels and at the Assembly of the Republic TV Channel.

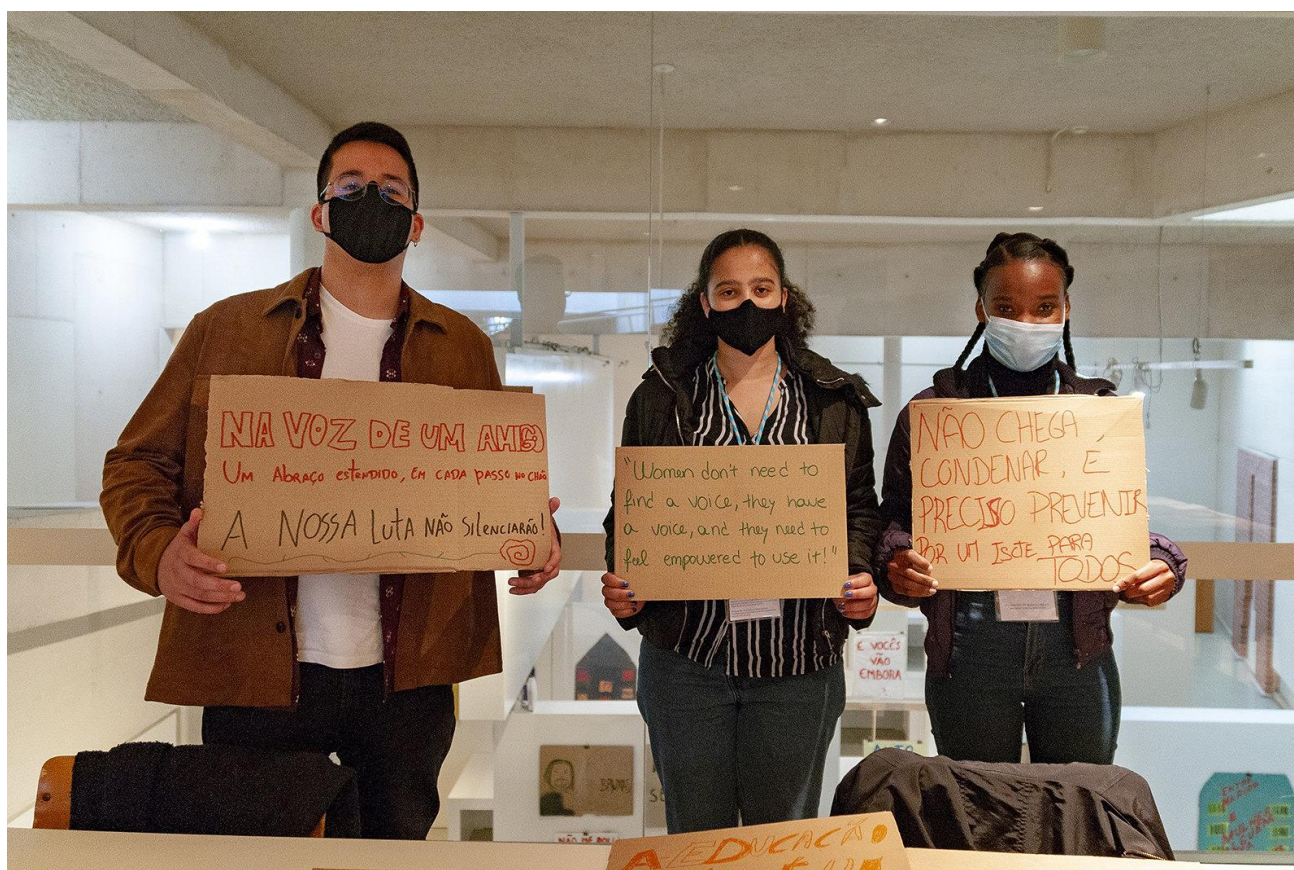
The conference brought together sociologists, and other researchers from other disciplines with the aim of reflection and the development of collective knowledge in a common field.

In collaboration with the Ephemera Archive, CIES organised an exhibition and a conference. The exhibition included handmade posters collected during demonstrations on a variety of topics, such as the Troika, feminism, LGBTI+ and the climate emergency. The conference was attended by several CIES researchers involved in research on these issues and was recorded and can be viewed on the Iscte YouTube channel.



## International Seminar on Research and Teaching of Humanitarian Action

The Centre supported an international seminar on research and teaching of humanitarian action in universities in Portuguese-speaking countries, in partnership with Centre for International Studies (CEI-Iscte) and the Camões Institute.

The initiative was attended by speakers with expertise in the field and promoted a broad debate on the Portuguese language, teaching, and culture in the lusophone area and was broadcast live on CIES youtube.



## VIII Congress of Railway History

CIES-Iscte collaborated with the Iberian Association of Railway History (ASIHF) to organize the [VIII Congress of Railway History](#), held in a hybrid format at Iscte, in association with the University of Évora and the New University of Lisbon.

The Congress brought together researchers to discuss the new perspectives for the Portuguese railways, to examine the impact of the railway infrastructure on the urban development of cities in the Iberian Peninsula, and to review the history of the railways in Portugal and Spain.

## Reading and practices of primary and secondary school students

The [results of the second part](#) of the study "Reading practices of students in primary and secondary education", concerning the 1st and 2nd cycles, were presented on 7th December at Iscte, with an online transmission, and the presence of the Commissioner and Sub-Commissioner of the National Reading Plan (PNL2027) and the State Secretary for Education.

The study is the result of a partnership between the National Reading Plan 2017-2027 (PNL2027) and Iscte through the OPAC - Portuguese Observatory on Cultural Activities. The research was supported by the Directorate-General for Education and Science Statistics (DGEEC) and the Network of School Libraries (RBE) and also sponsored by the McDonald's Restaurant Association.

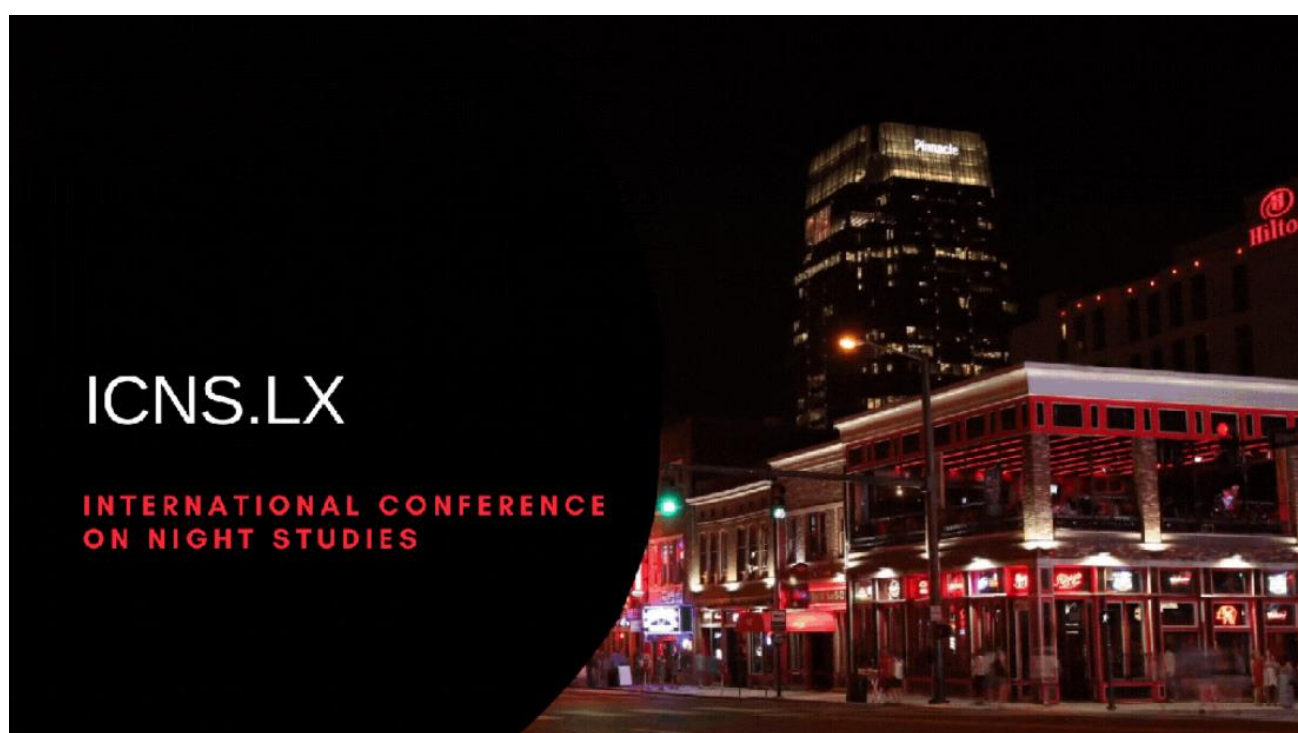


## ICNS.Lx 2021 International Conference on Night Studies

# Science and Technology Week & Science in the Holidays for Young People

Science and Technology Week and the Science in the Holidays for Young People program enable young people to come into contact with everyday life, people, projects and methods at a research center as part of the research conducted by CIES-Iscte researchers.

The Science and Technology Week, which took place from 22nd to 28th November 2021, counted on the participation of the Emigration Observatory and the Inequalities Observatory, structures of CIES-Iscte, which together with IS-UP (Sociology Institute of the University of Porto) developed activities to promote science. The activities took place on the campus of the University of Porto.

CIES-Iscte also set up the 17th internship as part of school-holiday scientific activities for young people in collaboration with Agência Ciência Viva. 4 secondary school students welcomed to the "Being a Social Scientist in Pandemic Times" internship week.



The internship had the objective of familiarizing interns to learn about the Centre, its protagonists, projects, and methodologies. Moreover, the students had the opportunity to get close contact with researchers and to experience social science research through the prepared activities.

# Publishing Activities

CIES-Iscte has published the scientific journal *Sociologia, Problemas e Práticas* (SPP) since 1986. The center has had its own publishing house, *Mundos Sociais* since 2010. It publishes the SPP journal and peer-reviewed social science book collections. The center also publishes the journal *Ler História* jointly with CEI-Iscte and belongs to consortiums that manage the indexed journals *Portuguese Journal of Social Science* (PJSS) and *Observatório* (OBS\*) and publishes the CIES e-Working Papers.

CIES-Iscte actively follows an open science policy. SPP articles and the CIES e-Working Papers are totally available online in their websites and at the RCAAP (Open-access Scientific Repositories in Portugal), and *Mundos Sociais* has published its first books with online editions.

CIES-Iscte was a pioneer at Iscte in providing open access to its publications at the Iscte repository. It has been its largest contributor of scientific documents (over 3500 available). The center is a founding member of the *Portuguese Social Information Archive* (APIS) and *Production and Archive of Social Science Data* (PASSDA) which stores and shares data produced in social science research projects.

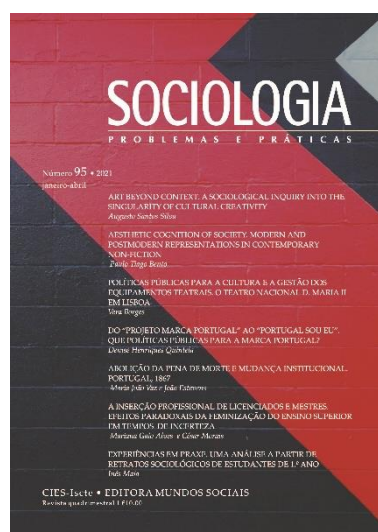

## Sociologia, Problemas e Práticas

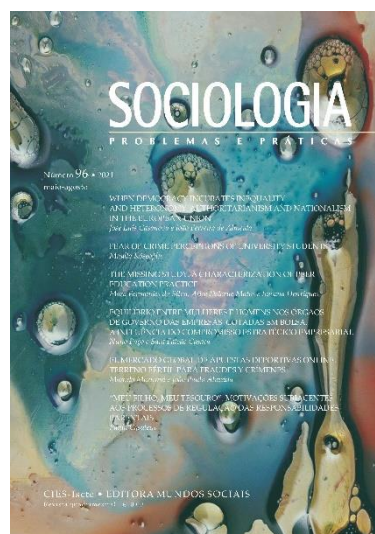
*Sociologia, Problemas e Práticas* is a scientific journal whose main purpose is to publish sociological analysis articles resulting from original research, the development of theory, or thematic evaluation. It also accepts papers from other social science areas, where there is an interdisciplinary interest. It is directed towards an international audience, publishing articles in Portuguese, English Spanish and French, by authors from various countries.

The journal's editorial stance is governed by principles of scientific quality, paradigmatic pluralism and social relevance. It aims to ensure that the articles published make a significant contribution to the advance of knowledge. Articles submitted for publication undergo a blind independent review by at least two recognised specialists drawn from a range of countries. The journal *Sociologia, Problemas e Práticas* was established in 1986, since when it has been published without interruption. It is indexed in various international bibliographic databases.

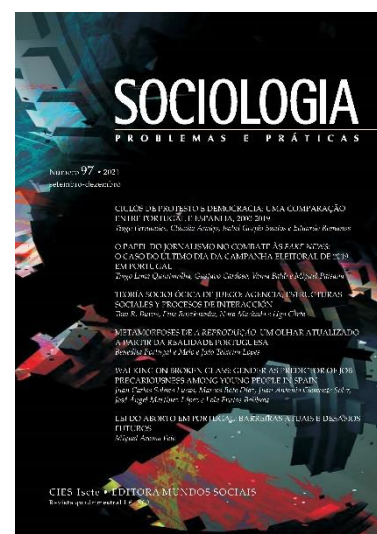
*Sociologia, Problemas e Práticas* remained on track in 2021 and its three annual numbers (n° 95, n°96 and n°97) were published regularly and punctually.

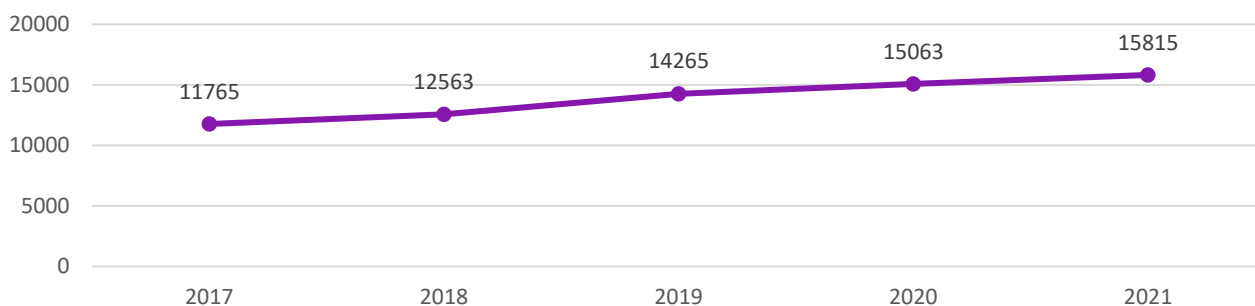

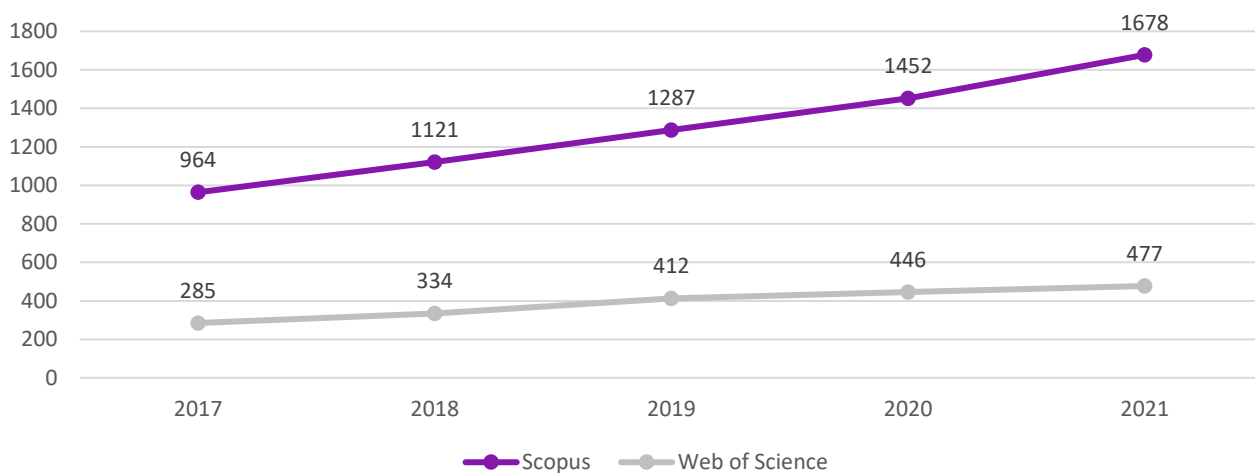

# 7.3 Ler História, Portuguese Journal of Social Science and OBS\*

CIES-Iscte publishes jointly with CEI-Iscte (Center for International Studies) the journal *Ler História* and is part of the consortiums that publish the journal *Portuguese Journal of Social Science* and the e-journal *OBS\**.

Launched in 1983, [Ler História](#) is a Portuguese academic journal in the scientific area of History, mainly dedicated to the history of Portugal, the Portuguese Empire and the Lusophone countries, in the modern and contemporary eras, which is published in Portuguese, English, Spanish and French.

*Ler História* also includes in its field of interests other chronologies and geographies, such as Iberian and Ibero-American history, the history of Africa and the history of Asia, among others, being particularly receptive to approaches of comparative, transnational or global history.

As a publication of Iscte, since 2020 it began to be published by CIES-Iscte and CEI-Iscte given the relevance to the scientific and thematic areas of the two research units.

The journal is indexed in several international databases among which SJR (Scimago Journal & Country Rank) is of particular note, in which *Ler História* is classified Q2.

In 2021, the issues 78 and 79 of the journal were published.

[Portuguese Journal of Social Science](#) (PJSS) is published by Intellect and is managed by a consortium formed by Iscte and three of its research units: CIES-Iscte, CIS-Iscte and DINÂMIA'CET-Iscte. Since 2019 a researcher of the CIES-Iscte team, Nuno de Almeida Alves, is Editor of the journal.

PJSS is indexed in the following databases, among others: SCOPUS (Scimago), Capes-WebQualis, Cambridge Scientific Abstracts, ISBSS, Sociological Abstracts, Worldwide Political Science Abstracts, Latindex, EBSCOhost.



The journal [OBS\\*](#) is published within the scope of the collaboration of CIES-Iscte and OberCom (Communication Observatory), being an interdisciplinary journal, open to contributions from disciplines related to communication studies, which publishes articles in English, Spanish, Italian, Galego, French and Portuguese, in open access.



The journal is indexed in several databases, such as Scopus Elsevier/Scimago, ERIH-PLUS and Scielo. In the Scientific Journal Rankings (SJR) of Scimago, the journal is now established in Quartile 3 and is placed in 2nd place among the Portuguese journals in the area of Communication.

In 2021, the OBS\* journal maintained the course of its activity ensuring the regular and timely publication of its four annual issues (Vol. 15).

The main goal of the [CIES e-Working Papers \(e-WP\)](#) series, initiated in 2005, is the publication of scientific papers in electronic format that result from research developed by CIES-Iscte researchers, as well as by researchers who collaborate with members or activities of the Center and students from Iscte.

CIES e-WP are typically work in progress and may be theoretical or conceptual, methodological or empirical in nature. Texts proposed for publication are assessed by the Editorial Board, and are submitted to peer review, so as to ensure the Center's standards of quality and scientific relevance.

There were three CIES e-Working Papers published in 2021, and a total of 239 working papers have already been published.

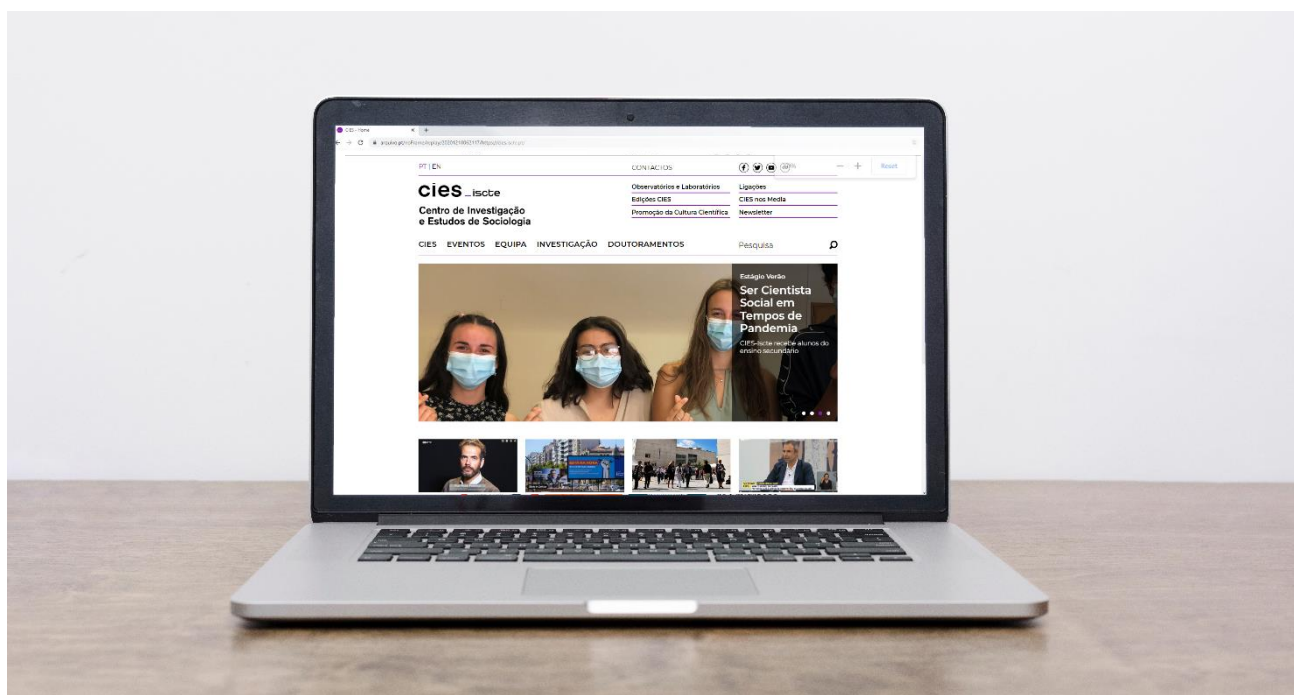

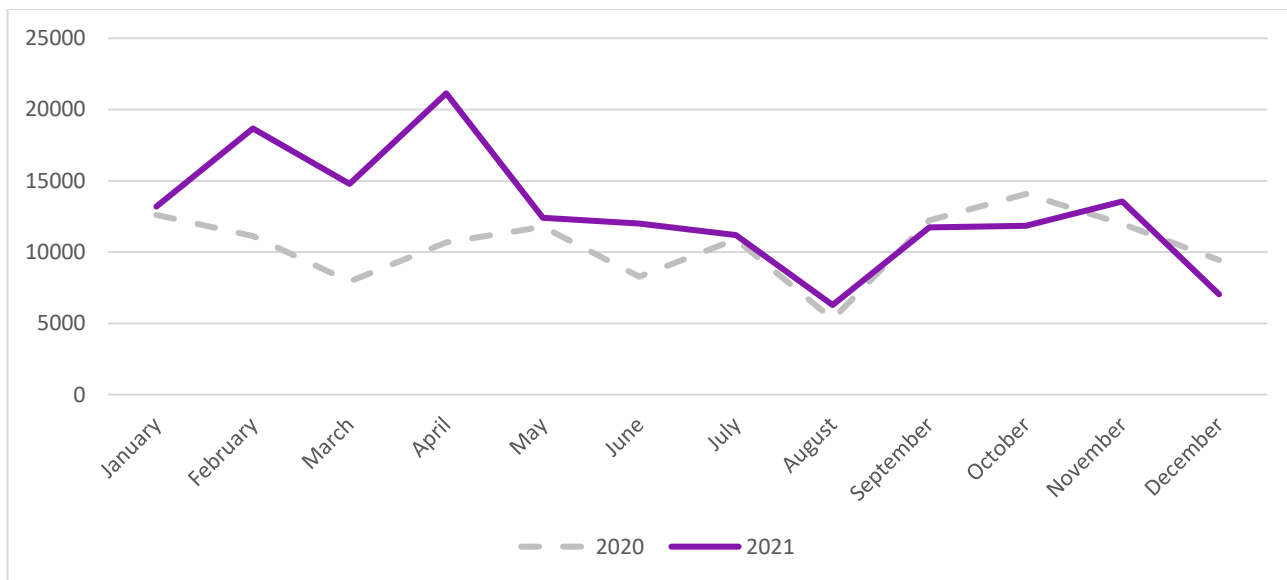

### N° of Page Views

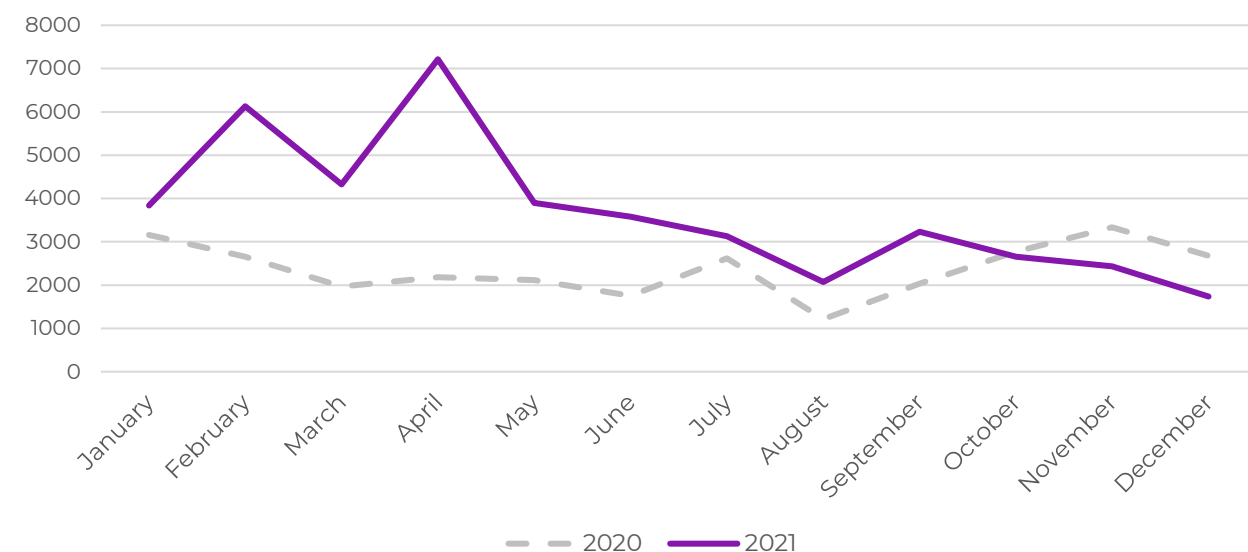

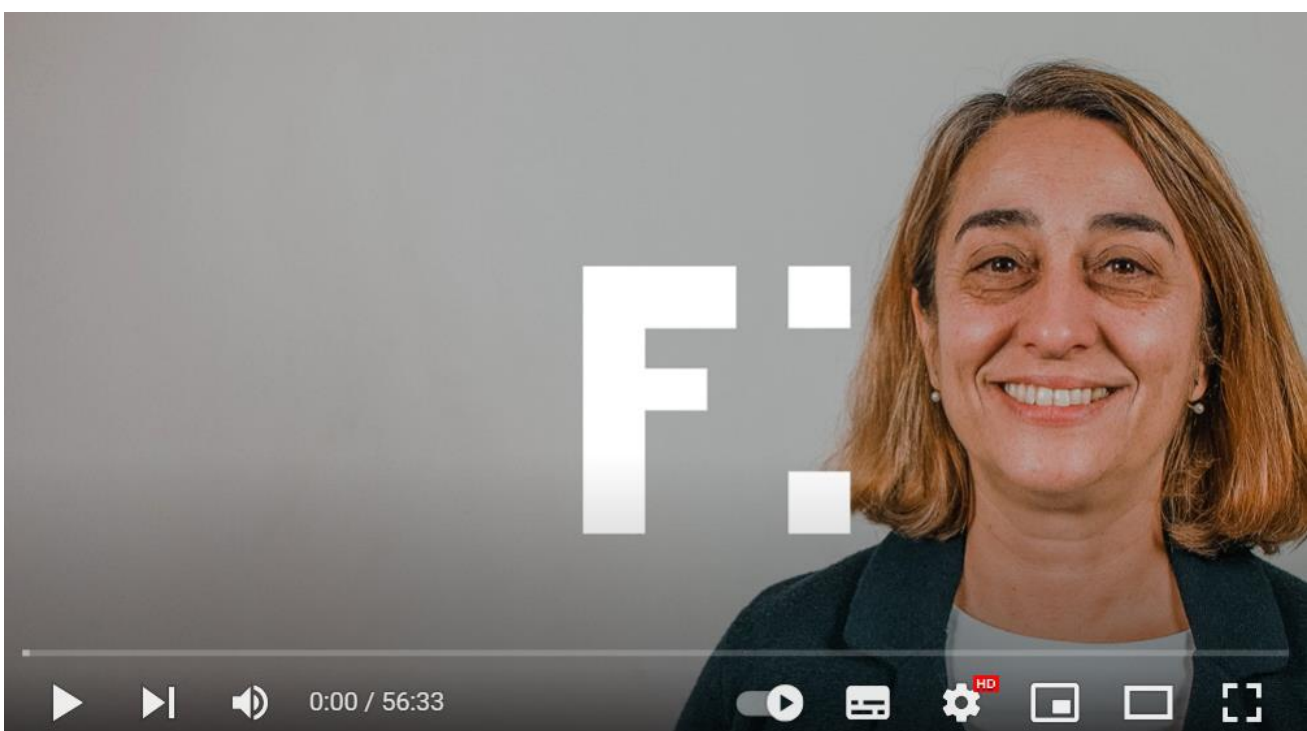
### N° of Users

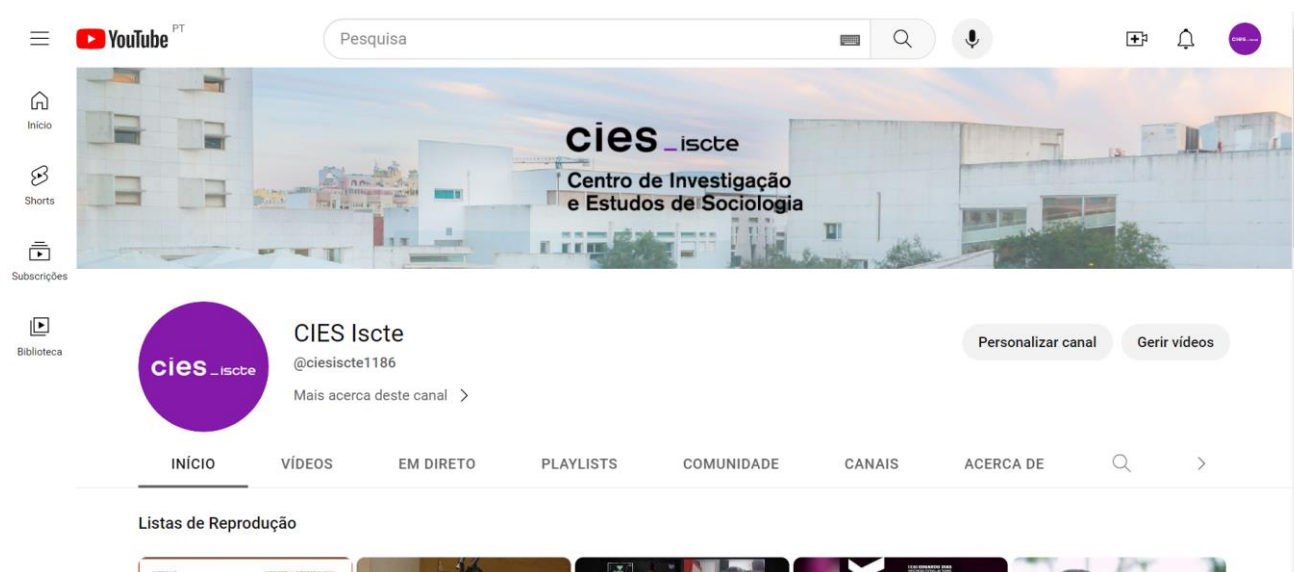

### Youtube Channel

The CIES-Iscte Youtube channel is the main streaming tool of the center and hosts a vast archive of videos of scientific events, podcasts, and documentaries. Throughout 2021, a total of 11 videos were released.



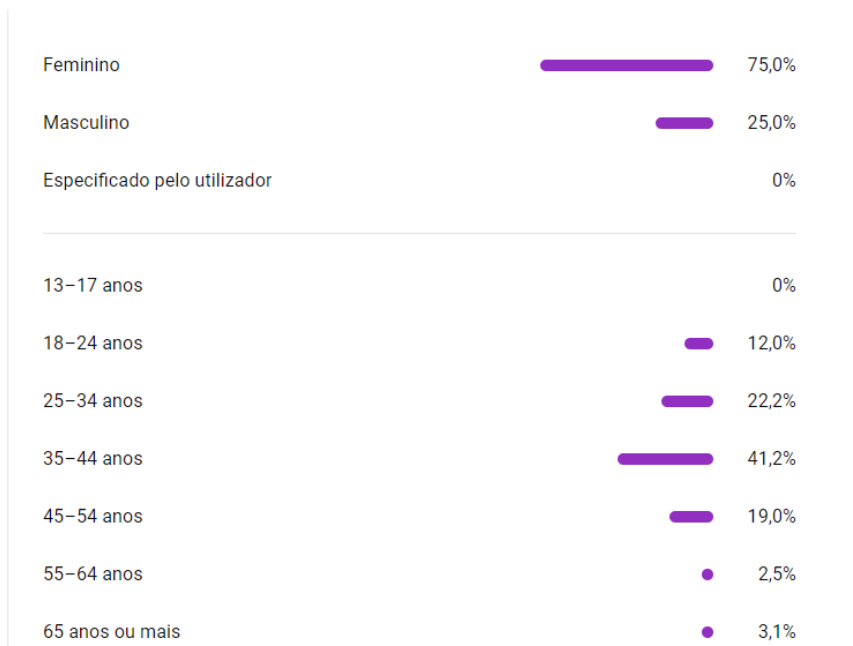
The channel had a total of 7.291 video views and an increase of 255 subscribers. The sudden increase in subscribers is directly related to the increase in live streams of scientific events on the CIES-Iscte YouTube page, which has become a common dissemination practice during the pandemic.

The video with the most views (1037) was the Seminar [“Portuguese Roma: Citizenship and Education”](#), it was also the video with the largest live stream audience, registering a peak of 181 users online. The video of the Seminar [“Decolonizing the literary canon”](#) generated the most subscribers (50).



## Audience

The type of audience is consistent across the different platforms, mostly female and in the 35-44 age group. According to the statistics collected, the type of multimedia content that generates the most audience interaction are photos and videos.

# Sources of Funding

Overall, after the decrease in 2020, largely due to the effects of the pandemic, the volume of the sources of funding has risen in 2021, approaching the pre-pandemic amounts.

FCT remains the major source of funding, given its support to the recruitment of researchers (work contracts for full-time PhDs). Also concerning funding from FCT, the pluriannual funding inflows increased and there were less incomes registered this year from R&D projects.

The level of funding from Portuguese public bodies, local authorities and Portuguese private institutions had an overall rate of 29%. There was a very considerable increase from the previous years with a high diversification of funding sources.

The funding from sources of the European Union has increased significantly, reaching almost half a million euros in 2021.

Regarding the funding from FCT for Post Doctoral Fellowships and PhD scholarships, indirect sources of funding, there was a slight increase in both cases. As mentioned in section 1.3 of this report, FCT no longer opens calls for Post Doctoral Fellowships, so with end of the fellowships that CIES has been hosting this category will cease.

## Expenditure structure

Regarding the distribution of expenditure in 2021 – with a significant increase this year - human resources are the major cost of CIES-Iscte's expenditure, even though with a lower percentage than in recent years. This category includes the technical team of science managers and hired PhD researchers (with work contracts) and research assistants who have grants for the development of activities within the scope of the Center's observatories.

Overcoming some of the mobility limitations due to the COVID-19 pandemic, the travel expenditure increases greatly this year overcoming pre-pandemic values.

The purchasing of services to support researchers and research activities rose, duplicating the figures of the last two years (around 16% of total expenditure in 2021).

Regarding the direct expenditure executed under the FCT Pluriannual Funding, the Human Resources category has registered a relatively slight increase in values, but its weight as a proportion of the total amount had a significant increase given the low expenditure in the other categories. This still stems from the previous year's spending pattern marked by the pandemic and has to do with the timing of payment requests (reimbursement) to FCT.

Regarding the travel category, with the relief of some of the travel restrictions due to the Covid-19 pandemic, there is an increase in mobility-related expenditure, both in the travel and in the dissemination categories. At this point it is important to make a clarification. FCT has introduced a change in the classification of expenses, which are now distributed as follows: under the heading missions (travel) are included expenses related with fieldwork, work and networking meetings, and the dissemination category includes travel expenses (registration, accommodation, and travel) for the presentation of papers at scientific meetings and other activities to disseminate the Centre's activities and scientific results. This will lead in the following years to changes in the distribution of expenses in these two categories.

The procurement to support researchers for expenses such as translation, proofreading and open access registered a slight decrease in 2021.
