# 1.1 Presentation and Guidelines

The Center for Research and Studies in Sociology / Centro de Investigação e Estudos de Sociologia (CIES-Iscte) of the University Institute of Lisbon / Instituto Universitário de Lisboa (Iscte) is a R&D unit, recognised and evaluated by the FCT (Foundation for Science and Technology), in the area of social sciences dedicated to studying contemporary social problems from a multidisciplinary perspective. Constituted in 1985, it is an organic unit of Iscte and is part of its School of Sociology and Public Policy.



CIES-Iscte's main scientific domain is sociology, developing relevant activity in the fields of public policy, political science, communication, education, modern and contemporary history and social work.

CIES-Iscte's activity is characterised by a demanding articulation between basic research, applied research directed at the design, monitoring and evaluation of public policies in various sectors and areas of intervention and advanced training.

The Center's research and scientific production, fosters diversity and the crossing of intensive and extensive approaches, aimed at deepening the analytical relationship between the study of social, political, and historic macro-processes and the social, cultural, and spatial micro-dynamics.

Including 130 integrated PhD researchers, the research team has a considerable number of foreign researchers (15%) from 13 different nationalities.

CIES-Iscte's integrated PhD researchers are professors at Iscte or full-time researchers at the Center. Another part of the integrated PhD researchers are professors at other national universities

and polytechnic higher education institutions, among which the Beira Interior University - UBI, where the CIES-UBI Pole is located.

The scientific structure of CIES-Iscte is based on 7 Research Groups:

- Inequality, Work and Social Well-Being
- Migration, Mobility and Ethnicity
- Education and Science
- Media and Culture
- Family, Generations and Health
- Politics and Citizenship
- Historical Dynamics and Global Integration of the World



Advanced training is another fundamental pillar of CIES-Iscte, closely combined with research activities. The Center is responsible for the scientific and administrative coordination of 7 PhD programs - [Sociology, Public Policy, Communication, Social Work, Political Science, Modern and Contemporary History and Policies of School Administration and Management](#) – and is associated with 4 others (Political Economy; Communication Studies: Technology, Culture and Society; Urban Studies; History: change and continuity in a global world - PIUDHist).

In 2022, face-to-face scientific events with hundreds of participants returned. Two major events were hosted – 28<sup>th</sup> International Conference of Europeanists of the Council for European Studies (CES): The Environment of Democracy and the 7th Global Meeting on Law and Society – and both also included virtual and hybrid components. Beyond these and along with the scientific events as part of research projects or on the initiative of research team members, CIES-Iscte also organised regular activities to contribute to an environment of permanent, up-to-date scientific debate, such as several research seminar cycles as further described. Since its foundation, the Center has also been continuously developing activities to promote scientific culture, in close connection with several partners.

In the editorial field CIES-Iscte publishes since 1986 the scientific journal [Sociologia, Problemas e Práticas](#) [Sociology, Problems and Practices] and, since 2020, jointly with CEI-Iscte, the journal [Ler História](#), both are indexed by several international databases as detailed further below. CIES-Iscte also supports the indexed journals [Portuguese Journal of Social Science](#) and [Observatory \(OBS\\*\)](#) and publishes the [CIES e-Working Papers](#). Since 2010, CIES-Iscte has its own publisher, [Mundos Sociais](#), that publishes the journal and refereed social sciences' academic books.

In terms of institutional organization at macro level, the integration of CIES-Iscte in two structures recently launched will mark its activity in the next years.

CIES-Iscte is the principal institution of the [Sociodigital Lab for Public Policy](#), composed of six research units of Iscte, submitted to FCT in 2020 for the status of Associate Laboratory and approved in 2021. By bringing together and crossing the competences of the six research units in social sciences and digital technologies, it aims to foster interdisciplinary collaboration to find innovative solutions to public policy challenges.



In 2022 the first initiatives took place, such as the 1st Conference on “Digital Transformation in Times of Crisis”, the Brown Bag Seminars for Public Policy and the Science and Technology Week, with several activities, including workshops and information sessions focused on open access publishing, research data management and digital transformation & inclusion in health.


The association [Iscte - Conhecimento e Inovação, Centro de Valorização e Transferência de Tecnologias \(CVTT\)](#) was created in 2020 with Iscte and its research units as founding members. CIES-Iscte is one of those members and its Director is a member of the General Assembly. Its key aim is to provide integrated knowledge transfer solutions for society, organizations, businesses, and public administration by combining two flagship areas of research at ISCTE: social sciences and humanities and digital technologies. The project will bring together in a single space (a building adjacent to the Iscte formerly belonging to the IMT) the research groups and resources – eight research centers, ten laboratories and three observatories – currently dispersed on the Iscte campus. The building construction progressed in 2022 and the relocation to the new facilities is planned for 2023.

## Support Services

CIES-Iscte has a set of support services which include the Communication and Planning Office, the Financial and Administrative Services, the PhD Programs Management and the services of the *Mundos Sociais* publisher and the journal *Sociologia Problemas e Práticas*.

In 2022, eleven full-time staff members were assigned to these services, supporting the research team and the Center's governing bodies.

The functions performed by the Communication and Planning Office are threefold: to search for opportunities and to support the submission of applications for research activities and to monitor and manage the scientific activities in progress; the organization of scientific events and other forms of dissemination, including the promotion of scientific culture; and the communication of activities and scientific results of the Center including online platforms and through social media.

The Financial and Administrative Services ensure budget elaboration and justification for applications and the financial management of ongoing research projects and activities, ensuring compliance with the procedures of the host institution and the requirements of the various funding institutions. These services also ensure the execution of the funds and financial prizes granted to members of the research team provided by Iscte and other sources.

The PhD Management service accompanies the students in all phases of the PhD program, from the application to its conclusion, as well as guarantees support to the teachers and the teaching activities, also managing the International Cycle of PhD Conferences and other scientific meetings.


The supporting services of *Mundos Sociais* publisher and the journal *Sociologia, Problemas e Práticas* cover the entire editorial, publication and dissemination process of the books published by *Mundos Sociais*, the journal *Sociologia, Problemas e Práticas* and the CIES e- Working Papers. They also ensure compliance with the procedures for the inclusion of CIES-Iscte's publications in scientific repositories and in national and international indexation databases.

# 1.3

## Research Team

The CIES-Iscte research team includes Researchers (integrated PhDs), Associated Researchers and Research Assistants. Together, in 2022, the CIES-Iscte research team consisted of 330 members.

### Research team 2018-2022



The Research Assistant category has been growing gradually and consistently. This category is mainly composed of master's or PhD students, who are part of research projects or observatories/laboratories teams, through research grants, and PhD students, with individual grants to carry out the research work for their theses.

In 2022, the Board, in close articulation with the Scientific Committee, defined a set of activity and scientific production criteria to be applied to the Associated Researchers category, which had reached one hundred in 2021. This was necessary because there were some cases of members whose involvement had ceased or whose connection was more tenuous and did not justify, at the time, their membership in the team. There will thus be greater monitoring and updating of this

category, ensuring the membership to the team of researchers who, while not having their main affiliation to CIES, collaborate and promote activities in the Center.

The Researchers (integrated PhDs) category has remained consistent in recent years, very much as a result of some stability resulting from the FCT scientific employment program, which has allowed, since 2019, to hire PhD researchers on a contractual basis. For this category, a set of scientific activity and production criteria have also been defined, to ensure that this group represents the core of the team, ensuring the essential coordination of research activities.

Regarding the number of PhD researchers with 100% affectation and employment contract, as mentioned, in 2019 there was a significant increase following the great effort CIES and Iscte had made to quickly implement the FCT scientific employment program created through the *Decreto-Lei 57/2016, Lei 57/2017*, namely the *Norma Transitória* that converted post-doctoral grants into research contracts (25 researchers were contracted under this program). Also, annually since that year the FCT has opened the Stimulus to Scientific Employment - Individual call, which also allows the hiring of PhDs under the above-mentioned law and under which CIES has hosted researchers with approved applications every year (3 in 2022). In both cases the contracts under this program have a six-year commitment to the institution to develop a research plan that they have proposed.

This legal framework has also allowed the hiring of PhD researchers within the scope of research projects, with national or international funding, and under the Multi-annual Funding of R&D Units by FCT. In these cases, the duration of the contract is more precarious due to its limitation by the duration of the project/funding.

The ongoing contracts have maintained stable figures (33 since 2020) despite some annual renewals. Every year new contracts start, but some come an end, in the context of research projects, and some contracted researchers resigned their position by joining the academic teaching career or permanent positions, at Iscte, in Portugal and abroad.

In 2022, a major step was taken in establishing a research career at ISCTE, recruiting the first researchers through an approved application to the FCT's Stimulus Program for Institutional Scientific Employment. The Foundation will fund the first years of these researchers' contracts, which will then be ensured in their permanent position by the contracting institutions. CIES-Iscte has hired two researchers in the scientific area of Sociology, with specialization in Inequalities, Migration and Public Policies.

These contracts bring new possibilities to structure and support scientific careers and improve scientific work conditions. But there is still a high degree of uncertainty about the future given that there are no guaranteed measures to ensure continuity of recruitment to the career path and its extension to replace limited duration work contracts.

Regarding gender distribution of the team, as can be seen in the table below, the percentage of female researchers in each of these categories is around 60%. This proportion has been consistent in the last few years, with slight and more significant increases in the Research Assistants category.

The number of integrated PhD researchers has evolved with moderate growth, stabilizing over the last three years with 130 in 2022, corresponding to 72.8 FTE (Full-Time Equivalent).


Integrated PhD researchers are mostly professors at Iscte – *Instituto Universitário de Lisboa* or full-time hired researchers at the Center.

Another part of the integrated PhD researchers belongs to other national higher education institutions, among which the University of Beira Interior (UBI) and polytechnic institutes of different areas (Health, Tourism, Education) and regions of the country (North, Central and Metropolitan Area of Lisbon). The seven integrated PhD researchers from the University of Beira Interior (UBI) integrate the CIES-UBI Pole.

Regarding CIES-Iscte members with research grants, they totalized 88 in 2022, of which 57 were PhD scholarships (49 with FCT funding), 29 are grants for research assistants within the framework of research projects, and 2 were postdoctoral grants. These two post-doctoral fellowships were the last CIES hosted with funding under FCTs’ fellowship program, which last edition took place in 2016. As mentioned above, FCT is now implementing the Stimulus of Scientific Employment, which foresees the grant of work contracts of limited duration instead of fellowships.

Looking at the teams’ internationalization, in 2022, 15% of the members of the research team are foreign, of 13 nationalities, as shown on the following map.

### Research team member’s nationalities




In 2022, the Center welcomed 36 visiting researchers from several countries of four of the continents (Angola, Belgium, Brazil, Cape Verde, Chile, Finland, France, Germany, Greece, Hungary, Iran, Italy, Norway, Poland, Spain, Sweden, United Kingdom, and USA). Of these researchers, 23 hold a doctoral degree and 13 are PhD students who have come to carry out research for their thesis within the framework of the cooperation between institutions or the research projects taking place at the Center.

In addition, CIES-Iscte hosted another 13 visiting researchers specialized in different scientific fields to participate specifically in the International Cycle of Doctoral Conferences.

## In Memoriam

### João Ferreira de Almeida (1941 - 2022)



João Ferreira de Almeida, professor, researcher at CIES and former president of Iscte, passed away on June 16, 2022, in Lisbon.

His legacy is invaluable with significant contributions to the sociological study of inequalities and labor, social classes, stratification, social exclusion and poverty, the study of values and social representations, identities and trajectories of youth, education, rural studies, environmental studies, democracy, and economic and social development. His vast work has marked sociology in Portugal and several generations of researcher.

It is with great regret that we bid farewell to Professor João Ferreira de Almeida, whose scientific work and kindness marked so many and will be greatly missed by the CIES-Iscte community.

## INEQUALITY, WORK AND SOCIAL WELL-BEING

This research group aims to contribute to the production of knowledge on the conditions of life and well-being in complex societies, crossed by diverse processes of social change.

Its research makes use of plural theoretical and methodological approaches focusing the social inequalities trends, class restructuring, and the reconfiguration of employment and work conditions. It develops research on the State, institutions, and the impact of public policies in different domains, sectors, and territories. It looks for the socioeconomic and sociocultural impacts and effects of the financial and pandemic crises. This research group has been developing and accumulating a stock of knowledge and expertise about methodologies in policy evaluation. The virtuous triangle combined between (i) the deepening of theoretical frameworks (ii) grounded and fuelled by different and complementary methodological approaches and (iii) the consolidation of policy evaluation matrixes, is the most innovative and outbreaking scientific contribute of this research group. The [Inequalities Observatory](#) (since 2008) and [CoLABOR - Collaborative Laboratory for Work, Employment and Social Protection](#) (since 2018), of which Iscte and CIES are associated entities, are core research structures that operate within this research group.

The researchers of this research group have published sixteen articles in scientific journals (most with relevant impact factor) in 2022, on a wide range of topics related to the fields of work, employment, poverty, social protection, and social rights. It is also interesting to note the publication on topics related to economic activity considering socio-spatial disparities. Social inequalities appear in many cases as a cross-cutting dimension of analysis. The seven published books and their chapters cover similar thematic objects, highlighting the impact of public policies. In this regard, it is worth to highlight the book published by Bristol University Press entitled "[Faces of Precarity](#)", co-edited with international researchers that brought together twenty-one authors of distinct nationalities and from different European institutions and research centers, on the theme of job insecurity considering the intersection with theoretical debates and empirical analyses on work, subjectivities and social struggles. Another important contribution is the book "[Territórios de bem-estar: assimetrias nos municípios portugueses](#)" [Territories of well-being: asymmetries in Portuguese municipalities] which results from research at the municipal scale on the social, economic, and demographic disparities that affect the different territories in Portugal. Particularly important is the analytical relationship established between the production of socio-spatial inequalities and the dimensions of well-being. Also noteworthy is the publication that results from the scientific and dissemination activities of the Inequality Observatory that aims to envision a set of alternatives and public policies that promote equality in the post-pandemic context. These [last two books](#) had a relevant social and societal impact.

The research projects developed by this research group address a notorious diversity of topics with a preponderance on the themes of social rights, social protection, work, employment, and inequalities. Part of it presents a multi-scalar approach comprising comparative analyses between European countries, but also between Portuguese municipalities. It is noteworthy that more than half of the projects focus, directly or indirectly, on the impact and evaluation of public policies addressing the mechanisms that promote social inclusion and empowerment. In addition to the topics mentioned, it is worth highlighting studies on the education system and education policies at regional level, as well as studies on the rights of people with disabilities. Most of the projects fully achieve the fundamental goals that guide this research group by establishing a well operationalized articulation between theoretical problematizations, the development of different quantitative and qualitative methodologies, and the evaluation of public policies. Giving relevant contributions to the design of new waves of public policies capable of framing social complexities and responding to the multiple vulnerabilities that affect various population strata.



This research group has four main research objectives related to (O1) internationalisation, (O2) contribution to public policies, (O3) articulation with digital technologies together with public policies, and (O4) impact on civil society. Specifically, it promotes and reinforces:

O1: International research and networks on the main themes of migration, mobility and ethnicity;

O2: Public policies' perspectives on migration and integration;

O3: Articulation with digital technologies, public policies and migration, within the multidisciplinary research teams of the SocioDigital Lab and the Emigration Observatory;

O4: And research-action with impact on teaching and civil society (public, private and third sectors).

The (O1) internationalisation and (O3) articulation with digital technologies has been promoted with the involvement in international projects and networks with funding from Horizon Europe, International Centre for Migration and Policy Development (ICMPD), Asylum, Migration and Integration Fund (AMIF), Erasmus + actions, including the International Credit Mobility (ICM) funding for research and lecturing in European and African countries.

In (O2) public policies and (O4) research-action with impact in civil society continued and raised the contribution to the design, implementation and evaluation of public policies for national and international bodies. The UN/OIM awarded Portugal on Global Compact for Migration as a 'Champion Country,' for which contributed the training and research of the Secretary of State for Integration and Migration and the team formed with researchers of this research group.

The main achievements in 2022 were developed in internationalization, events, publications, public policies contribution and societal impact, detailed below.

International Relevance of Research Activities can be summarized in the following outcomes:

- An international collaboration for the creation of the Migration Observatory in Cape Verde, two diagnostic and characterization studies of immigrants in Cape Verde, and training of public servants, NGOs professionals and professionals from different sectors in Cape Verde (education (<https://aai.gov.cv/sobre-aai/projetos/coop4int>));
- Erasmus + Capacity-Building project on [Humanitarian Action, Climate Change and Internal Displacements](#). It led to co-research and for the first-time teaching of Humanitarian Action in Cape Verde and Mozambique, contributing to ODS 10, Reduce Inequalities, and ODS 4, Education.
- The reinforcement of members of the research group in the structure of the [IMISCOE network](#) (Board of Directors, External Affairs Committee, Training Committee, and different Standing Committees); An application was submitted and approved for the organization of the 21st IMISCOE Annual Conference to be held in July 2023 at Iscte, with the Organizing Committee composed of researchers from this group;

#### Public Policies Impact main outputs on migration, refugees, and Roma populations:

- [Emigration Observatory](#) produced the yearly report on Portuguese emigration for the Ministry of Foreign Affairs discussed at the Parliament for improvements in legislation and procedures. Moreover, it makes available data through the website for journalists, civil society, researchers, and political makers.
- [Changes in Migration laws and Portuguese language policies for adult immigrants and refugees in Portugal](#), in which obstacles were removed in the language learning courses by creating the Ordinance for the courses of Portuguese Host Language, with the inputs of researchers of the RG in Secretary of State for Integration and Migration team. For the first time, foreigners and asylum seekers awaiting the finalisation of their regularisation were able to learn Portuguese.
- Evaluation of the Implementation of the Municipal Project of Intercultural Mediators in the Municipality of Porto (North), who work with immigrants and Portuguese Roma.

#### Social and Societal Impacts of Research on training and teaching:

- Erasmus + Strategic Partnerships for Higher Education project, [Innovation in Humanitarian Response](#), which for the first time with research-action created a curricular unit together with universities and NGOs on participatory evaluation of public policies on humanitarian action in Turkey, Spain, Brazil, and Colombia;

- Training of civil society actors, public servants, and professionals in specialized sectors (media, education, police forces and health);
- Translation of United Nations modules on trafficking and smuggling of migrants taught in different settings.

## EDUCATION AND SCIENCE

This research group has as analytical focus two fundamental areas of research - Education and Science. It develops research on the relationships between knowledge and society, from diversified but interconnected themes, namely: schooling processes, educational inequalities and trajectories, educational systems, educational policies, key competences and skills, adult education and lifelong learning, literacy and reading, new literacies, higher education networks, science and society, science policies, digital transformations, science communication, public engagement with science and technology.

Considering the decisive role of the investigated themes in contemporary societies, the research focuses on both fundamental and applied modalities, giving special attention to the fields of action and intervention, institutional frameworks, the various actors involved, as well as the policies and debates on these themes. Projects address a multiplicity of contexts, of international and/or transnational, national and local scope, often integrating interdisciplinary and inter-institutional networks and partnerships.

In 2022, the activities of this research group were developed by a core of eighteen integrated researchers and about twelve doctoral students with scholarships or contracted under projects. Around 40% of the researchers were 100% dedicated to research at CIES, enabling a very dynamic development of research projects and publications, and the organization of and participation in scientific events with significant scientific and social impacts.

The research projects and publications carried out in 2022 covered a wide range of topics. If, on the one hand, already established lines of research have been maintained (such as studies on schooling processes, educational inequalities and trajectories, science communication, and research and publication strategies of researchers) others are clearly related to recent events, like research related to the Covid 19 pandemic and its impacts in schools and universities, or the relation between trust in science and Covid risk perceptions.

As achievements in 2022, the strong relevance of internationalization should be highlighted. The international component of this research group is relatively evident, both in its objects of study and in terms of participation in collaborative projects (e.g., international/European surveys), European research programs (for instance Erasmus+), and global programs evaluations. In 23 projects running in 2022, more than a dozen had this type of profile. Examples of this are the research projects “External evaluation of the Schools2030 Program” (an [international program of the Aga Khan Foundation](#), involving 10 countries) and “[POIESIS - Probing the impact of integrity and integration on societal trust in science](#)” (Horizon Europe), a project involving seven partners from across Europe to study the impact of research integrity issues and societal engagement practices on trust in science. In this regard, the establishment and consolidation of increasingly broad international scientific networks should also be noted.

Another significant mark of the group's activities in 2022 was the important contributions to the design, analysis, and evaluation of public policies, at various levels of their definition and implementation. This component was very evident through projects such as the Review of the Educational Charter in several municipalities, or the study about the Future of Doctoral Education in Portugal. This aspect, despite its flagrant expression in the year under review, is the result of the continuous work of the researchers of this research group. This component of the research work has, therefore, an important social impact and allows an effective connection and social recognition of the research work carried out.

This research group's activities also included organizing conferences, seminars and discussion sessions. Some of these events emphasize the relationship between scientific research and teaching activities. This is the case of the participation in the organization of Doctoral Conferences and in the International Cycle of Conferences in Education (organized within the framework of the master's degrees in Education and Society and School Administration). Others have to do with the participation of group members in broader events, aimed at the academic and civil community in general (as is the case of the Colloquium ["Childhood, Education and Family: policies, paths and](#)

[participation](#)", organized by the Thematic Sections Families and Life Course, Sociology of Education and Sociology of Childhood of the APS, of the Portuguese Sociological Association).



**The research group on Media and Culture positions itself on the study of media and culture from a sociological point of view.**

The research on media focuses on the study of communication as a total social phenomenon translated in the adoption and practice of networked communication. The sociological study of media developed at CIES aims to capture and explain the human practices, social relations and social order brought by the social adoption of networked communication. The work is carried with a central focus of research in the Portuguese society but also expanding our attention to contemporary societies in Europe and into the Portuguese speaking world.

From a sociological perspective and with the central focus on the Portuguese society, culture is studied at CIES on several interrelated areas, public policies, management and mediation, access, participation and audiences and creative and cultural work.

The core strategic objectives of CIES for research on Media & Culture can be summarized as follows:

O1: The increase of internationalization, through the promotion of flagship research projects within the ERA.

O2: The consolidation of CIES's central position as a research Hub and as institution of reference for the sociological studies of Media & Culture in the Portuguese speaking world (Brazil, Portuguese Speaking Countries in Africa, East-Timor, and Macau SAR (Special Autonomous Region of China)).

O3: The further development of OPAC - Observatório Português das Atividades Culturais / Portuguese Observatory on Cultural Activities, constituted and in activity within the framework of CIES-Iscte, of the collaboration with OberCom/European Journalism Observatory, and of the MediaLab research competences for the study of social networks, social media and journalism.

During 2022, the focus of research on Media was directed towards the study of disinformation phenomena ([IBERIFIER - Iberian Digital Media Research and Fact-Checking Hub](#), Funding: European Digital Media Observatory), journalism and its professional practices ([NEWSREEL - New teaching fields for the next generation of journalists](#), [European Journalism Observatory](#), Funding: Erasmus+), media fruition and representations towards journalism (Digital News Report; [EUMEPLAT - European Media Platforms: Assessing Positive and Negative Externalities for European Culture](#), Funding: H2020; Monitoring the informal economy in online social networks. Unauthorized sharing of newspapers content in Portugal; DatingLab@MediaLab; MediaLab/ Priberam Barometer).

There was a significant international relevance of the data and analysis produced with application on the wide European research area or beyond. Examples of such relevant activities are the [Digital News Report 2022](#) in collaboration with OberCom or IBERIFIER's role as [EDMO's](#) Hub on disinformation for Portugal and Spain. Also, of notice is CIES's participation on EUMEPLAT as one of the leading contributors, specifically for the coordination of WP2 – Fake News: Platformization of Journalism and its [methodological application and data analysis](#) in 10 European countries.

Research in culture impacted most in the area of public policy, focusing on two lines: a) surveys of reading practices of Portuguese students and [reading promotion practices of mediators](#), in partnership with the National Reading Plan 2027 (culture and education public policies); b) artistic and cultural atlas of Portugal, a research in partnership with the Directorate-General for the Arts/Ministry of Culture, based on a wide range of secondary, official, national statistical sources in all domains of intervention of cultural policies, that [brings new detailed knowledge about the territorial cultural reality](#).

There were also great social and societal impacts with a better understanding of participation and audiences (e.g., visitors to national monuments in Portugal, an OPAC annual survey since 2019; audiences of Doclisboa - Lisbon International Film Festival, in partnership with APORDOC, a three editions study (2021, 2022, 2023). Also, funded by the Calouste Gulbenkian Foundation, a study was

carried out on the Foundation's Grants and Support for the Arts Programs in the areas of training and creation, which allowed to know its impact on Portuguese society.

## FAMILY, GENERATIONS AND HEALTH

The main research topics developed in this group can be grouped in three areas: 1) Family, parenthood and gender issues and identities; 2) The different settings in the life course, from childhood to youth, encompassing transitions and engagements between generations; 3) Health, health professionals and patients; Ethics, risks and medicine use, including substance abuse.

These research topics are conducted through different project profiles, including national and international bids to competitive calls; individual competitive grants and procurement processes of public bodies. Findings aim to increase the stock of knowledge available in these subject areas together with the provision of information for public policies evaluation and planning.

The research group is articulated with other structures where several integrated researchers take part, namely with [nascer.pt - Laboratory for Social Studies on Birth](#), and with the [LIM - Laboratory for Methodological Innovation](#), located in CIES, and with the thematic line of the "Societal Health" of the SocioDigital Lab for Public Policy.

Researchers belonging to the group are involved in sequential international research projects ([COORDINATE](#), [GUIDEPREP](#), both funded under H2020) aimed to build a European Research Infrastructure devoted to the development of a Longitudinal Survey on the Well-being of Children and Young People in Europe. When completed and installed, this research infrastructure will provide important longitudinal data on crucial dimensions of European children and youth upbringing in the physical, psychological, social, and emotional dimensions. The potential of these data for knowledge generation and public policies is vast.

On the international peer-reviewed publication front, there are a few titles that deserve mention, including two handbooks and one edited book ([The Routledge Handbook of Contemporary Inequalities and the Life Course](#), [The Palgrave Handbook of Youth Mobility and Educational Migration](#) – 2<sup>nd</sup> Edition, [Biographical Research: Challenges and Creativity](#)), published by reputed international publishers. More than 20 articles in indexed peer-reviewed journals were published. A similar number of book chapters and many books were also published by the research group members.

Four international conferences were hosted coinciding with the end of FCT funded projects ([ECOS](#), [LINKED](#), [FEMINA](#) and [ConPerLit](#)). The conferences debated the findings obtained through the execution of the projects with national and international discussants. The [Cycle Biographies and Trajectories](#) held two conferences inviting the same number of renowned speakers. The [Cycle Gender, Sexuality and other social markers of difference](#) held four seminars with international invited speakers. The Laboratory nascer.pt promoted five scientific sessions, for both national and international audiences.

Research activities have also made important contributions to public policies at national level, particularly in areas such as combating discrimination and reducing inequalities. Two projects completed in 2022 stand out in this regard: the ["National study on the needs of LGBTI+ people and discrimination on the grounds of sexual orientation, gender identity and expression, and sex characteristics"](#), funded by the Comissão para a Cidadania e Igualdade de Género, which produced recommendations to inform the National Plan to Combat Discrimination on the grounds of Sexual Orientation, Gender Identity and Expression, and Sex Characteristics; and ["FEMINA - Fertility, Immigration and Acculturation: Intersectional Approach to Sexuality and Reproductive Experiences and Expectations in Cape Verdean and Portuguese Families"](#), funded by Fundação para a Ciência e Tecnologia, which included recommendations to reduce social and reproductive inequalities by defining prevention strategies and training professionals.



This group works in four main areas: political representation, social movements, public policies and administration, social rights and social work. While having their own foci, these areas also interact each-others in pursuing four main common objectives – scientific (O1), social (O2), academic (O3) and pedagogical (O4) – fully consistent with CIES and Iscte goals:

O1: Analyse the interactions between civil society and political institutions, through coordination of and participation in path-breaking individual and team research projects;

O2: Improve these interactions, e.g., through engagement in public debate and scientific-based expertise on crucial topics (as elections, social, civil and political rights, environmental issues), collaboration with stakeholders (institutional and grassroots), action-research;

O3: Strength the peer-to-peer scientific dialogue and contribute to the internationalization of Cies and Iscte (e.g., through high-impact publications, coordination of scientific networks and events, exchange programs, attraction of international students);

O4: Promote research-informed teaching (e.g., through transference of innovative knowledge to the graduate and post-graduate programs at Iscte, supervision of MA and PhD theses, involvement of PhD students in the group projects and activities, organization of summer and winter schools).

Substantive research – through individual and team projects – and solid contribution to increasing scientific knowledge in the group's areas have been the basis for all other achievements.

The Observatory of Democracy and Political Representation is its essential coordinating platform: it integrates group's activities around the common objectives, while it also has its own research agenda. Its collaboration with the [Comparative Candidates Survey](#) is a key example of the group's deep involvement in international networks. Other examples are the coordination of the [Council of European Studies RN Social Movements](#), and of the Portuguese team of the [Jean Monnet Network GreenDeal-NET](#).

Publications well reflect the international relevance of the group's research. In 2022, it produced 29 Scopus indexed articles, 26 in international journals, connecting its core-topics with critical issues such as crisis/es (e.g., [The 'Lost Generation' and Its Political Discontents: Age-related Divides in Southern Europe after the Crisis](#)), environment ([Spreading rebellion?: The rise of extinction rebellion chapters across the world](#)), digitalization (e.g., [International public administrations on Twitter: A comparison of digital authority in global climate policy](#)) globalization (e.g., [Superdiversity: New paths for social sciences in the upcoming future](#)), education (e.g. [Policy discourse in times of crisis: Debating educational policy in Portugal in the years of austerity](#)), right to the city (e.g. [Contentious buildings: The struggle against eviction in NYC's Lower East Side](#)). 2022 publications also included path-breaking monographs as [Contesting Austerity. Social Movements and the Left in Portugal and Spain \(2008-2015\)](#) and [Left and Right. Meaning and Correlates in Long Consolidated and New Democracies](#).

Among international events, the [28th International Conference of Europeanists](#) gathered at Iscte together c.a. 1.500 international scholars discussing 'The Environment of Democracy'.

In 2022, group-members regularly participated in public debate on crucial topics (as elections; social, civil, political rights; environmental issues), e.g., through established collaboration with newspaper [Público](#) and magazine [Visão](#), or participation in the [Gulbenkian Conversations about the Future](#). The group's members were also engaged in putting science-based expertise at the service of the community in diverse ways. For instance, project HOPES developed a partnership with housing association *Habita!*, promoting action-research and co-organizing [events](#). It was also among the founders of the [Housing Network](#) (RH) which – with other projects and stakeholders – promoted public debate on housing rights, also participating in the elaboration of recent housing legislation (e.g., *Mais Habitação*).

The relevance of the work developed by team-members was recognized with prestigious awards and grants, as the Portuguese Association of Political Science's Award for the best PhD Thesis and the FLAD-Brown University Professorship grant.



This group conducts research in History, with contributions from other fields, from the early modern to the modern and contemporary periods. It gathers a dozen researchers whose interests span a wide range of History fields, from the history of crime and social control to the history of science and energy, social and economic history, urban history, and culture and heritage.

Although the topics are heterogeneous, the group shares the same historiographical perspective, which consists in approaching History not from a national(istic) point of view but by reinforcing the processes of global integration of space on a planetary scale. This is the distinctive feature of the Group.

The Group develops historical research in the following areas:

- History of population and demography: studies on the demography, history of the family, and systems of marriages in the Modern and Early Modern Periods, with a particular focus on the so-called "Portuguese Empire" from the eighteenth century to the early nineteenth century.
- Economic history: a traditional research field among Iscte historians since Miriam Halpern Pereira launched the History Group back in the 1980s. Research tended to focus on the key moments, such as the so-called Pombalismo (second half of the 18th century) and the Liberalismo and Regeneração in the nineteenth century. Recently, recent studies have approached the land-property, gender, and social division of work and rural history.
- History of contemporary social movements: focused particularly on the opposition movements to the dictatorship that ruled Portugal from 1926 to 1974. Particular attention has been paid to student opposition and its relationship with the establishment of the democratic system in the 1970s and subsequent periods. This line has explored "new" historic methods and approaches such as "Oral History" and the "History of Present time".

- History of crime and social control: stemming from studies in Social History, this area of study has consolidated in the last couple of decades, covering research on a wide range of issues (explanatory frameworks and the dynamics of crime, the police and criminal justice, among others). Currently, it focuses on the study of transnational circulations of criminal practices and the development of new strategies to control them, namely through cooperation between police and diplomatic authorities of various countries. It covers geographical areas that international historiography tends to ignore: Southern Europe (Portugal, Spain, and Italy) and South America (Brazil and Argentina).

- History of science, technology, and energy: History of science, in its broad definition, is one the core areas of the Group. The research deals with a variety of topics, from the confession-ization of science in the seventeenth century, with studies focusing, for example, on the Jesuit scientific activities, to the history of nuclear energy and its different uses, including households, industry, and war. Intimately related to these areas of research, the Group is delving into the Environmental History and history of the Anthropocene.

As mentioned, the global, comparative, and transnational perspective is common to the whole research topics. This historiographical approach has paved the way to integrate the Group in international projects, research networks, and academic associations. These are the cases, for example, of projects directed by Group's members such as [RESISTANCE](#) (H2020) or in which Group's members are Co-PI as in the project [E3GLOBAL - Einstein, Eddington and the Eclipse](#). A global history of the total solar eclipse of 1919. This historiographical approach has also opened the way to participate in international academic consortiums like the [International Commission for the History of Universities](#), [Association d' Histoire des Sociétés Rurales](#), [Commission Internationale pour l'Histoire des Villes](#), and the [Associação Ibérica de História Ferroviária](#). This is also reflected in participation in international publications in indexed journals or books, attendance, and organization of colloquia designed to bring Portuguese issues into international narratives.

Stemming from a previous research center, this team was initially made up of professors of Iscte. More recently, this research group has incorporated more post-doc researchers, selected in national and international contexts. These researchers have been particularly welcome as they are fundamental to broadening the scope of the research fields (historical approaches to cultural heritage and environmental history are cases in point), attracting further dynamic and junior researchers.

The integration in CIES has been fundamental in the development of this Group. Its strongly interdisciplinary nature has been a source of inspiration and mobilization allowing the incorporation of

new methodologies and fields of studies, but also contributing to developing a historical understanding in the field of social sciences. Furthermore, the group aims to expand involvement in international and national networks, increase publication records, and contribute to public awareness of History and social sciences.

The research activities carried out in the various areas and themes covered by this group have an international impact. In 2022, with the aim to impact also in geographies often little covered by international historiography, such as the South Atlantic, an international collective research project began: [CINCRA - International collaborations: crime and police cooperation in the Ibero-American Atlantic, c. 1870-1940](#) (FCT). The coorganization of the event Bicentenary of Brazilian Independence: Reflections and Perspectives (*Bicentenário da Independência Brasileira: Reflexões e Perspectivas*), organized by CEI-Iscte in partnership with CIES and Casa do Brasil with active involvement of PhD students, also had the same aim.

In 2022, in addition to the diverse range of publications produced (4 articles in international journals, 12 book chapters in books published in Portugal and abroad, a book authorship, 3 edited books, 6 dictionary entries), the work as editors of two academic journals by group members can be stressed. *Ler História*, edited by CIES and CEI, is one of those journals and was ranked quartile 1 in 2021 and is currently ranked quartile 2. This being the case, *Ler História* is the better-ranked journal of History in Portugal and one of the best in the Portuguese-speaking countries.

Regular sessions took place within the group debate cycles, such as [Cities and Empires. Local dynamics, global flows](#) and [New Perspectives in Modern History](#).

Most of these activities had a social impact that goes beyond the academic community with the dissemination of its activities by engaging the general public, integrating working groups that interacting with very wide audiences, and meeting what has been called Public History. In this sense, there has been an intense collaboration in the realization of events, namely on the Liberal Revolution of 1820 or the Revolution of April 25, 1974, among other various initiatives. The organization of these seminars and activities included collaboration with the mass media to promote public awareness of history and its questions.

# Overall Research Indicators

## Research Projects

CIES-Iscte conducts basic research projects funded by public calls with scientific assessment issued by public and private, Portuguese, and European agencies and foundations and applied research projects directed at the design, monitoring and evaluation of public policies based on the Centers' consolidated scientific skills.

Researchers can propose projects and other scientific activities with much independence. This culture of initiative and cooperation is a firmly established practice. It is the source of the Center's ability to quickly react to the opportunities and challenges in research and enables it to place emerging, socially, and scientifically relevant issues on the research agenda.


For example, there have been several initiatives and projects to analyze the effects of the Covid-19 pandemic on various sectors of society and the perceptions about it.

Concerning the overall number of ongoing projects, there has been a gradual increase in the number of funded projects reaching 115 in 2022.

In 2022, of the 29 projects with international funding, the following sources can be highlighted: Horizon 2020/Horizon Europe, Erasmus+, AMIF - Asylum, Migration and Integration Fund, EURES, EEA (European Economic Area) Grants, European Digital Media Observatory, CERV - Citizens, Equality, Rights and Values Program). Worth highlighting is that CIES is a member of the consortiums of 4 Horizon Europe (including an ERC Synergy Grant) and 5 Erasmus+ proposals approved in 2022.

Among the projects with national funding, there are a variety of sources, demonstrating the ability to attract and obtain funding from sources other than FCT. The projects were funded by central government bodies (e.g. Directorates-General: Cultural Heritage, Arts, Labour, Solidarity and Social Security, Foreign Affairs, National Defense Resources), local government bodies (9 projects funded by municipalities: Municipalities of Cascais, Estremoz, Lisboa, Porto and Sesimbra; Intermunicipal Communities of Alto Alentejo, Baixo Alentejo and of Cávado ), public institutes such as the High Commission for Migrations (ACM) and private and third sector institutions (Aga Khan Foundation, Calouste Gulbenkian Foundation, FFMS - Francisco Manuel dos Santos Foundation).

# Publications

Publication is a core element of scientific activity as a way of disseminating knowledge and results to the scientific community and society. Recent years have shown a transition in the publication pattern of the team of researchers at CIES-Iscte. Despite the increase in articles in indexed journals, namely in the Scopus and the Web of Science (WoS) databases, CIES-Iscte researchers managed to keep a balance between the diverse types of publications, maintaining the publication rates of books and chapters and thereby ensuring the presentation of results to the international scientific community and dialogue with Portuguese society.

The overall number of publications is at the same level as in recent years, amounting to 474 in 2022, as shown in the following table.



## Presentations at scientific meetings

In 2022, most scientific meetings were in a hybrid format. The transition to this format has allowed a widening of audiences and increased the dissemination of events and their outcomes. Scientific Events – to contribute to an environment of up-to-date scientific debate, such as the research seminar cycles and the annual Research Forum, in this edition dedicated to Reflections and Interventions in Communication and Culture.

In total, in 2022, researchers participated in the organization of 265 national and international scientific meetings and presented 489 communications, returning to the pre-pandemic figures.



# Observatories and Laboratories

CIES-Iscte fosters a number of permanent research observatories and laboratories in scientific relevant areas promoting public debate on pertinent issues in each area. The Inequality Observatory (OD) and the Emigration Observatory (OEm) have fifteen years of existence and have achieved growing scientific and social recognition. In 2018, two other research platforms were created within the framework of CIES-Iscte: The Portuguese Observatory on Cultural Activities (OPAC) and the Laboratory for the Social Studies on Childbirth (nasc.pt). More recently, the Observatory for Democracy and Political Representation has started activity and, from 2021, significant steps were taken in the development of the Laboratory of Innovative Methodologies (LIM), a research structure that will seek to disseminate and further develop methodological innovation practices among CIES-Iscte researchers and research areas and to strengthen interdisciplinary collaboration in this area.

CIES-Iscte is also an honorary member of the Communication Observatory ([Obercom](#)), which analyses and assists in public policies, sector companies and academic research in communication sciences, and integrates the Collaborative Laboratory for Work, Employment and Social Protection - [CoLABOR](#), that was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

CIES-Iscte is responsible for the operation and scientific coordination of the Inequality Observatory (OD) having as partner institutions, since its initial phase, the Institute of Sociology (Instituto de Sociologia) of the Faculty of Arts of the University of Porto (ISFLUP) and the Center for Social Studies (Centro de Estudos Sociais) of the University of the Azores (CES-UA, today CICS.NOVA.UAc). The OD studies several aspects of inequality. It conducts international comparisons of statistical indicators and a wide range of constantly updated studies and research.

In its implementation phase in 2008, it received the support of the Presidency of the Council of Ministers, the Ministry of Labour and Social Solidarity and the Ministry of Education. Since then, it has been supported exclusively by CIES-Iscte. In addition to fostering scientific knowledge in this area, the OD's mission is to publish accurate, up-to-date information on inequality from the viewpoint of citizenship and a contribution to the justification and assessment of public policies. This means that it is a tool for research and scientific dissemination. It is a founding member of the European Inequality Watch network, which involves similar observatories and other institutions from different countries.

In addition to its permanent work of updating and developing of new indicators, expanding the glossary and the national and international links, producing the newsletter, news releases, replying to press requests, hosting internships namely for master students, among others, in 2022 the main activities and outputs were:



Edition, launch and dissemination of the book [“Que Futuro para a Igualdade? Pensar a Sociedade e o Pós-pandemia”](#) (What Future for Equality? Thinking about Society and the Post-pandemic) by Renato Miguel do Carmo, Inês Tavares and Ana Filipa Cândido (eds.).

Conduction and publication of the study [“O Desemprego em Portugal e na Europa: Quão Penalizados Estão a Ser os Jovens?”](#) (Unemployment in Portugal and Europe: How Penalized are Young People?) by Inês Tavares and Renato Miguel do Carmo.

Development of [new indicators](#), such as "Public expenditure on health", "Public expenditure on housing" or "Material and social deprivation".

Coorganisation of the conference [“Desmercadorizar o trabalho? Da \(in\)segurança no emprego à proteção social”](#) (De-merchandising work? From job (in)security to social protection) that took place on the 24th of March 2022 and promoted a cross-sectional reading of the recent impacts of social and economic crises on people's work and social conditions, on the forms of action of public policies, and on the greater or lesser vulnerabilities that affect the territories. In addition to mapping the inequalities affecting labour markets, it also aims to reflect on viable alternatives that involve greater universal access to quality employment. The conference was concluded with the exhibition and debate around the web-documentary [“Demasiado novo para ser velho”](#) (Too young to be old) which brings together 6 life journeys, described in the first person, of workers and unemployed people who struggle every day to survive and not fall into situations of extreme deprivation and social vulnerability and resulted from the project EmployALL - The Employment Crisis and the Welfare State in Portugal: Deterring the Production of Social Vulnerabilities and Inequalities (reference PTDC/SOC-SOC/30543/2017) developed at CIES with FCT funding.

# Emigration Observatory

The Emigration Observatory (OEm) is an independent research and technical structure integrated in the CIES-Iscte, where it has its office. It operates based on a partnership between this Center and the Center for Geographical Studies and the Research Center for Economic and Organisational Sociology, both University of Lisbon and the Institute of Sociology of the University of Porto. The interdisciplinary research team is supported by a Scientific Council which brings together experts from Portuguese universities.

The main objective of OEm is to collect, harmonise and analyse information on the evolution and characteristics of Portuguese emigration and emigrated Portuguese populations, in particular, by collecting data from the statistical institutions of the countries of destination of emigration. The objectives of the Observatory are also: to disseminate all the information compiled and promote their availability and discussion to the general public, to researchers, technicians, students, policy makers and journalists; contribute, through its activity, for the definition and evaluation of information-based public emigration policies and knowledge about this policy area.

OEm is a pole of other initiatives, such as the Migration Network, which includes 410 researchers from 21 countries (Australia, Belgium, Brazil, Canada, Cape Verde, Spain, USA, Finland, France, Netherlands, Hungary, Italy, Latvia, Mozambique, Norway, Wales, Portugal, United Kingdom, Sweden, Switzerland and Ukraine), and is also the interlocutor of other national and international observatories and collaborates regularly with the media.

As in previous years, annual indicators were made available on stocks (total population, nationality, nationality, Portuguese origin and consular records), Portuguese inflows in destination countries, acquisition of nationality in the destination country and emigrants' remittances. In 2022, the work of periodic compilation of statistical indicators on the entry and stay of Portuguese in the countries

of destination of emigration was continued, updating the indicators for the set of destination countries. The number of countries with information on the new indicators on sex and age group for those born in Portugal, with Portuguese nationality and entering Portuguese was also extended to all countries for which information was available.

The Observatory also systematically and periodically collects diverse documentary information on Portuguese emigration, namely bibliographic, film and research references, links to distinct types of entities, particularly emigrants' associations, and press clippings. In 2022, the Observatory continued the work of periodically compiling this information, available on the website under "Resources".

The website is indeed the main instrument of daily relationship with the OEm audiences, as it is regularly updated and progressively extended to cover more data, publications, and relevant information, with access open in three languages (Portuguese, English and French, the latter still being updated) and disseminated through a newsletter.

Regarding expert interviews, in 2022, the Observatory ensured the publication of four interviews, conducted in 2021, with Jean-Pierre Cassarino, Andrew Geddes, Christof Van Mol and Asaf Augusto, and the revision and publication of an interview with researcher Joana Azevedo.



OEm publications include books, reports, information briefs, studies, and testimonials, and are organised into six periodical collections: OEm Conversations With..., OEm Country Reports, OEm Fact Sheets, OEm Working Papers, Portuguese Emigration Factbook the Statistical Report. In 2022, the Observatory published four issues of the OEm Conversations With... collection, two OEm Fact Sheets, on births in Germany of Portuguese mothers, 1960-2020 and births in Switzerland of Portuguese mothers, 1987-2021; two OEm Working Papers on Portuguese emigration to Colmar during the *Estado Novo* and the Portuguese population of Macau, 1800-1850; the Portuguese Emigration Factbook 2021 (in English) and Portuguese Emigration 2022 Statistical Report, partially integrated in the seventh annual report on Portuguese emigration of the responsibility of the Office of the Secretary of State for the Portuguese Communities.

The Observatory promotes, in collaboration with other entities, scientific and science communication meetings, as well as training actions. In 2022 the highlight goes to the organization of five webinars with international speakers on various migration-related topics: Andrew Geddes "Repertoires of migration governance in the EU"; Catherine Wihtol de Wenden "Migration, borders and the right to mobility"; Ian Goldin "Imperatives of immigration"; Jean-Pierre Cassarino "Through the looking-glass of the EU's readmission system"; and Asaf Augusto "Portuguese migration to Angola and Angolan migration to Portugal".

# Portuguese Observatory on Cultural Activities

The Portuguese Observatory on Cultural Activities (OPAC) was launched in 2018 within the framework of CIES-Iscte, which is responsible for its scientific coordination and functioning. Its main goals are to ensure the development of accurate and up to date research and public availability of studies and information related with various cultural domains and themes aiming to contribute to current debates in Portuguese society and the formulation, monitoring and evaluation of public policies. Despite the strong emphasis on Portuguese reality, OPAC also has a transnational comparative perspective, particularly within the EU.

In 2022, the activities carried out under the OPAC included six research projects, four of which started in previous years, various publications resulting from the research carried out by the Center's teams, including in scientific journals, meeting and dissemination proceedings, conference papers. They also included training actions and scientific dissemination initiatives and the hosting of internships.

In terms of research projects, in addition to the start of a partnership with another observatory, the OBAP - Observatory of Popular Associations, continuity was given to the partnership with the PNL2027 – Plano Nacional de Leitura (National Reading Plan) with the project "Evolution of Reading Practices of Students in Basic and Secondary Education - Barometer" and the beginning of another, "Reading Promotion Practices: Survey of Reading Mediators".

The study "DOCLISBOA - International Film Festival: impact of the festival and its audiences" also continued, with the survey on the 20th edition of the festival, as well as the "Study of the Artistic and Cultural Sector in Portugal" with the realization of the Artistic and Cultural Atlas of Portugal module, a research in partnership with the Directorate-General for the Arts/Ministry of Culture, based on a wide range of secondary, official, national statistical sources in all domains of intervention of cultural policies. The [official presentation of the study "Atlas Artístico e Cultural de Portugal" \(Artistic and Cultural Atlas of Portugal\)](#) took place at the 2nd RTCP Conference, at Sardoal, on 5 December 2022, bringing new detailed knowledge about the territorial cultural reality.

Finally, the study "From safeguarding to valorisation. Portugal's national monuments and their opening to the public", which began in 2019, had its fourth edition.

# Laboratory for the Social Studies on Childbirth – nascer.pt

Nascer.pt, the Laboratory for the Social Studies on Childbirth, is a permanent structure linked to CIES-Iscte, which brings together a group of researchers from different scientific and professional areas, and from different institutional and geographical contexts. Its aim is to foster knowledge about the conditions and characteristics of childbirth in Portugal, to contribute to the consolidation of the Sociology of childbirth and, at the same time, to develop synergies between structures and multidisciplinary approaches in the study of childbirth, both at national and international level.

In 2022, the Laboratory nascer.pt continued its regular activity, promoting scientific sessions, for both national and international audiences. With the end of the covid-19 pandemic and confinement in the beginning of the year, the activities were adjusted for a hybrid format, happening both presential, at Iscte, and online, through Zoom, allowing more audience to join.

Throughout the year, the laboratory increased its number of members to 45, with 4 new members. Starting in February 2022, nascer.pt now has the regular support of the grantholder and PhD student Mariana Évora.

Among the activities of nascer.pt the hosting of the visiting researchers Patrizia Quattrocchi (University of Udine, Italy) and Pía Rodríguez (University of O'Higgins, Chile) in September and November 2022, respectively, were important for the development of collaborative activities and for the submission of applications to international funds.

The Collaborative Laboratory for Labour, Employment and Social Protection (CoLABOR) was constituted in 2018 under the FCT attribution of the title of Collaborative Laboratory.

With nine partners and a multidisciplinary team of highly qualified researchers [CoLABOR](#) mobilises resources from academia, companies, and third sector institutions, having four central objectives: to support the design and restructure of policies in their thematic areas; capacity-building of institutions, including public administration, businesses and institutions in the third sector; to qualify employment through training and the creation of scientific jobs; contribute to public debate in the areas of work and social protection, through effective and innovative forms of dissemination of the results of the research it carries.



CoLABOR achieves these objectives through an ambitious agenda of deepening scientific knowledge around three central thematic axes: work and employment; social protection and social facilities and responses.

Across these thematic areas, CoLABOR developed [DataLABOR](#), an innovative platform that aggregates and cross-references statistical and legal data on work and employment, social protection and the social and solidarity economy in Portugal.


MediaLab-Iscte is a laboratory dedicated to experimentation, supporting research and production of editorial content in the field of communication sciences, but covers also other disciplines in the fields of social and human sciences.

The MediaLab was set up with the strategic objective of providing CIES-Iscte with skills and resources to support scientific research and innovative projects. Its ability to connect theoretical and empirical research with the technological dimension is essential to follow the dynamics of social transformation.

The lab encourages and supports communication practices in its different models and objects – from digital to analogue, from plain text to multimedia, from analysis of online networks and trends to social media networks, research online and user reviews, news media monitoring, data visualization and big data.

In the last two years, MediaLab has been focused on the study of the role of the media and the analysis of disinformation on social networks in the context of the Covid-19 pandemic. In 2022, this line of research was carried out by supporting researchers participating in the [IBERIFIER - Iberian Digital Media Research and Fact-Checking Hub](#) and the [EUMEPLAT - European Media Platforms: Assessing Positive and Negative Externalities for European Culture](#) projects. In other thematic areas, in the context of international cooperation in research projects, MediaLab supported researchers in the project [NEWSREEL - New teaching fields for the next generation of journalists, European Journalism Observatory](#).

In 2022 MediaLab continued its work monitoring news production in Portugal, [MediaLab-Príberam News Barometer](#), producing 12 monthly reports and creating structured databases for consultation and further study and to host the Portuguese participation in the European Journalism Observatory (EJO) and actively collaborated in the realization of the comparative study "[Migration coverage in Europe, Russia and the United States](#)".

# Observatory for Democracy and Political Representation

The year 2022 was marked by the launch of the Observatory's website that includes information of its activities and publications, and data of relevant research projects.

Another central activity in 2022 was the revision and editing of the chapters resulting from the presentations of the conference "Da austeridade à pandemia: Portugal e a Europa entre as crises e as inovações" (From austerity to pandemic: Portugal and Europe between crises and innovations), held on 17 and 18 June 2021, for the edition of the book with the reference: Freire, André, Guya Accornero, Viriato Queiroga, Maria Asensio, Helena Belchior Rocha and José Santana Pereira (org, in press 2023), *Da austeridade à pandemia: Portugal e a Europa entre as crises e as inovações*, CIES-Iscte, Lisbon, *Mundos Sociais*. The book is currently in the final stages of editing and will be published in 2023.

Regarding the survey(s) of candidates for the legislative elections (elected and non-elected), the 2022 edition was prepared for sending via email and post, the database, the respective report and codebook were produced. Data were collected on the biographies of the Members of Parliament of the XV legislature "Fichas dos Deputados Elections 2022 – Databases and will be made available soon.

The database on the "Survey of Candidates for Members of Parliament in the 2019 Legislative Elections (elected and non-elected)", with respective codebook, was finalized and sent to the international network [Comparative Candidates Survey](#) for harmonisation and publication.

In terms of events, support has given for the organization of several conferences, namely under the Doctoral Conferences of the PhD in Political Science (6 sessions), the 28th International Conference of Europeanists (28 June to 1 July 2022) and the monthly Seminars on Social Movements and Political Action (9 sessions).

# Laboratory of Innovative Methodologies

The year of 2022 was the first full year of activities of the Laboratory for Methodological Innovation. As such, the initial activities included the analysis of activities undertaken by similar institutions, such as the National Centre for Research Methods (a partnership between the University of Southampton, the University of Manchester, and the University of Edinburgh), and the search for scientific literature on innovative research methods.

These initial steps were undertaken together with some hands-on experience on mixed methods, based on available material from the [MYPLACE Research Project](#) (2011-2015, financed by the European Commission), of which CIES was part, that included quantitative and qualitative data considered adequate for this mixed methods venture. Further steps included a positive experience with the use of Qualitative Comparative Analysis on this material which led to a presentation made on the Portuguese Sociological Association Conference (April 2023).

Other activities included internships at the Laboratory done by Iscte's MA and undergraduate students, which had the opportunity to participate in several activities, such as working on bibliography on research methods and some practical activities of data analysis, including quantitative (SPSS) and qualitative (MAXQDA).

## PhD Programs with connection to CIES-Iscte

CIES-Iscte has long-standing experience of hosting PhD students, which creates a strong interdependence between its teaching and research environments. To ensure the completion of high-quality research, PhD students are provided with guidance and supervision by experienced researchers.

Within the School of Sociology and Public Policy at Iscte, the Center provides scientific coordination and management of the following seven PhD programs:

# PhD Programs coordinated by CIES-Iscte

As mentioned in the previous section CIES-Iscte currently coordinates a total of seven PhD Programs. The Communication Sciences and Public Policy programs take three years of study, and the Political Science, Modern and Contemporary History, Policies of School Administration and Management, Social Work and Sociology programs take four years of study. In the first year, the students attend seminars on theories and methods and optional curricular units. In the other years, they prepare their PhD thesis, carrying out research at CIES-Iscte. Complementarily, they attend a Doctoral Seminar, the International Cycle of PhD Conferences and the Doctoral Colloquy.


At CIES-Iscte, PhD students actively engage in a diverse range of activities while being strongly encouraged to share the outcomes of their research incrementally and participate in national and international debates.

The Center's support structures ensure the necessary follow-up, both in the administrative management of the students' training path and in their research activities. In this context, CIES-Iscte also provides invaluable assistance to PhD candidates in preparing applications for scholarships from the National Foundation for Science and Technology (FCT), the Iscte and other funding institutions.

PhD students also have access to specialised software (SPSS, MAXQDA, Qualtrics, etc.), to Iscte laboratories (namely, the MediaLab), and to the Iscte Library and access to the Online Knowledge Library (b-on), which provides access to the full text to thousands of journals and ebooks of the main international scientific publishers. Doctoral students with exclusive dedication and scholarships are offered a working space in a shared office.

In 2022, 24 doctoral theses were defended by students of the PhD programs managed by CIES-Iscte and one was concluded hosted at CIES in the framework of the FCT PhD program Communication Studies: Technology, Culture and Society.

## Doctoral Colloquium

The Doctoral Colloquium of the School of Sociology and Public Policy (ESPP) is an initiative, held since 2013, to publicly present and discuss ongoing research within the doctoral programs coordinated by the School's two research centers, CIES-Iscte and the Center for International Studies (CEI-Iscte). After the last edition, which took place exclusively online, the initiative returned to its face-to-face format in 2022. This year's edition was attended by around three dozen doctoral students. They were joined by researchers and professors with doctorates in political science, communication sciences, modern and contemporary history, history, security and defense studies, public policy, school administration and management policy, social work and sociology.

The Colloquium continues to be an initiative to promote and disseminate doctoral research by encouraging a broad debate on different scientific fields, but also on research methods, problems and results

## 4.3 Other advanced training activities

### Summer and winter schools

#### **European Drugs Summer and Winter School**

In partnership with the IPPS, CIES organizes two annual training activities: [the European Drugs Summer School](#) and the [Winter School](#). These are supported by experts from the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA).

The winter edition of the school was held online from 14 to 25 February 2022 and focused on "Cannabis: trends, regulations and debates in the EU and beyond" and the summer school will take place in person from 27 June to 8 July 2022. It will focus on "Community responses to drug-related problems" and will last for two weeks.

The schools aim to equip professionals and students with the knowledge and skills to address complex policy issues related to drug use in Europe and around the world.

### ASTRA Summer School

From 23 May to 3 June, CIES hosted [the second Summer School of the ASTRA project](#) "Applying Research on the Transition to Sustainability in Social Work to Address the Societal Grand Challenge of Social Inclusion", a Marie Skłodowska-Curie Innovative Training Network (H2020, GA: 955518).

Aiming to strengthen and deepen understanding of the complex interrelationship between environmental, economic and social sustainability and its applicability to social work theory, research and practice, the school's main themes were: biosphere protection and sustainable use of nature for human well-being; new models of sustainable local and regional economies and social inclusion by contributive justice and ecosocial innovations.



# Research internships

CIES-Iscte welcomes students at various levels of their studies (undergraduate, postgraduate or doctoral) and offers them the possibility of working as interns in its laboratories and observatories or on research projects conducted at the center.

Research internships are a chance for students to contact the reality of a research center. They also allow them to develop methodological and scientific skills that are essential for the development of their projects and theses.

During the traineeship, students are mentored by researchers specialized in the topic of the traineeship and are integrated into the project team or laboratory where the traineeship takes place.

In 2022, CIES-Iscte hosted 17 trainees: 7 bachelor students and 10 master students.

Under the 2021/2022 edition of Iscte's Scientific Initiation Competition, aimed at promoting scientific training among first-year students, CIES-Iscte hosted two undergraduate sociology students with the project "Transitions to adulthood in young people in residential care."

# Scientific events

CIES-Iscte is responsible for promoting events and initiatives that foster an environment of broad and timely scientific debate.



Since 2020, the Center has adapted to scientific events in hybrid formats. This allows wider audience access and availability of content.

In addition to scientific events linked to research projects or initiated by members of the team, CIES-Iscte also organizes regular activities, of which the following are examples.

## CIES-Iscte Research Forum annual

The [CIES-Iscte Research Forum](#) is an annual initiative promoted by the Center that has been taking place since 2006. This initiative aims to publicise the work of CIES researchers in the various fields of the social sciences. It is also an opportunity for exchange, reflection and in-depth discussion on the topics covered.

Each year, the Forum is dedicated to one of the social science themes. For the year 2022, the Forum will be dedicated to "Education and Educational Policies" and is expected to take place in early 2023.

## CIES-Iscte Research Workshops fortnightly

CIES [research workshops](#) are meetings where researchers present and discuss methods, processes and results of scientific research in specific social science fields.

Five workshops were organized by the Center in 2022 - one online, one face-to-face and three in a hybrid format.



# International Cycle of PhD Conferences annual

Every year, the School of Sociology and Public Policy (ESPP) of the Iscte, together with the research centers belonging to the School, organizes the International Cycle of PhD Conferences. This initiative brings together doctoral programs in Political Science, Communication, African Studies, Sociology, Modern and Contemporary History, International Studies, Social Work and Policies of School Administration and Management.

The International Cycle of PhD Conferences takes place between October and May of each academic year. Renowned researchers specializing in various topics are invited to participate in these sessions, which are held in a hybrid format.



# Public Policies Forum annual

The Public Policies Forum is an initiative of Iscte public policy professors and researchers, held annually since 2012. It aims at promoting ideas, knowledge, and information on public policies and at helping improve processes for planning, implementing, regulating, and evaluating public policies in Portugal.

In 2022, the Forum was held in May and focused on the relationship between the [University and the Local Authorities](#).

## New Perspectives on Modern History

The [New Perspectives in Modern History](#) cycle has been taking place regularly since 2005. It is an initiative aimed specifically at master's and PhD students in the History Department of Iscte but open to all interested parties.

The sessions include the presentation of some of the research projects in progress, developed by Portuguese and foreign historians, from different universities, specialties, and generations. This cycle of seminars provides an insight into the current trends in Modern History research: the topics that are most developed at the moment, the main problems in focus, the new methodologies, the sources used, and the new interpretations that are being produced.

In 2022, 5 sessions of this cycle of seminars were held in a hybrid format.

## Monthly seminar on social movements and political action

The [monthly seminar](#) cycle began in 2014, with the aim of multidisciplinary reflection on issues related to social movements and different forms of political action, militancy, and activism.

In addition to bringing different perspectives, methodologies and approaches into dialogue in order to develop an in-depth and innovative debate, the seminar also aims to take advantage of Portugal's special geographical, linguistic and epistemological position to cross different traditions of social movement and political action studies, the different European/North American and South American ones, as well as cases and areas often excluded from this field of study, such as Portuguese-speaking Africa.

9 sessions of this cycle of seminars have taken place in 2022 and all of them can be watched on the [Youtube channel](#) of the CIES-Iscte.

## Meetings about Migration Experiences

The [Migration Experience meetings](#) are an initiative of researchers from CIES-Iscte and CRIA, in partnership with the Emigration Observatory. The main objective is the interdisciplinary exchange on international migration studies. Each meeting focuses on specific ongoing or completed work and research and cross-references practices and questions on methodologies and theories. 5 sessions of meetings in hybrid format are planned for this year 2022.

As part of the migration theme, CIES-Iscte is also organizing the International Seminar Cycle [Migrations in the Digital Space: Experiences, Transformations and Resistances](#). The aim is to develop an interdisciplinary analysis that contributes to understanding how migrations are currently constructed, transformed, and shaped by the digital space.

In this context, each session counts with the participation of experts in the field, from media to politics.

2 discussion sessions were planned in a hybrid format.

## Gender, Sexuality and other social markers of difference

The regulation and interaction of gender, sexuality and other social markers of difference such as social class, race, national origin, migration status, religion or generation create categories of subjects and regimes of social inclusion and exclusion.

The cycle of meetings on ["Gender, Sexualities and Other Markers of Difference"](#) aims to promote interdisciplinary dialogue on the articulation of these markers and on the possibilities and limitations they present. The 2022 calendar presents 4 sessions of the cycle, exclusively online.

## Other important discussion activities

Besides the regular activities, CIES-Iscte hosts the following initiatives: Biographies and Trajectories Seminars, Cidades & Impérios: dinâmicas locais, fluxos globais, Meetings on China Studies, ETNO.URB Readings and Cultural Diversity in Contemporary Families.

Some of the events with the highest impact in 2022 that took place at CIES-Iscte were the following:



## 28<sup>th</sup> International Conference of Europeanists

CIES-Iscte hosted the [Twenty-Eighth International Conference of Europeanists](#), organized by the Council for European Studies (CES) and held at Iscte - Instituto Universitário de Lisboa from 29 June to 1 July 2022. The organizing committee was chaired by the CIES-Iscte researcher Guya Accornero.



During the three days of the conference, several panels and sessions were dedicated not only to the quality of democracy and the environment but also to new forms of democratic participation.

Moreover, the conference allowed for a dialogue between the social and natural sciences in the debate on environmental issues, including their democratic implications. The

Lisbon 2022 conference also aims to bring together scholars from different fields to reflect on and discuss the relationship between the environment and democracy from a multidisciplinary and multilevel perspective.

## 7<sup>th</sup> Global Meeting on Law & Society Rage, Reckoning, & Remedy

The [7th Global Conference](#), sponsored by Law & Society, was held at Iscte from 13 to 16 July 2022 and was supported by the R&D units CIES-Iscte and Dinâmia'CET took part in the conference. The CIES team included Susana Santos, who co-chaired the meeting, and António Pedro Soares.



The event, themed 'Rage, Reckoning and Remedy', provided a forum for national and international researchers to discuss and analyze issues of race, colonialism, human rights, and slavery legacies.

To make the conference accessible to those who could not attend in person, particularly in Lisbon and at the Iscte, the conference, which included several parallel sessions, was held in a hybrid format.



The conference also provided an opportunity to promote the development of scholarships on the subject and to encourage the exchange of ideas and networking between researchers in fields such as sociology, law and culture, and the legal community at large.

## National study on the needs of LGBTI

On the International Day against Homophobia, Transphobia and Biphobia, CIES-Iscte and the Commission for Citizenship and Gender Equality (CIG) promoted the [public presentation](#) of the "National study on the needs of LGBTI people and discrimination on the grounds of sexual orientation, gender identity and gender characteristics". The study was coordinated by researcher Sandra Saleiro and the event held at Iscte was attended by CIG members, researchers and journalists and promoted an in-depth debate on issues raised in the study.

In the same vein, CIES-Iscte joined with the [Meeting 40 Years of Decriminalization of Homosexuality: LGBTI+ History in Portugal](#), held at Iscte - University Institute of Lisbon, where, apart from sharing stories and discussing the issue, there was an exhibition by the Safo Club Association on lesbian activism in Portugal and the presence of the lesbian community in the LGBTI+ movement.

## EduCig

As previously mentioned, several projects with FCT funding ended in 2022 and their final conferences were held. As an example of these events, and in addition to those already presented by research group, the [EduCig - Educational achievements among Ciganos: research action and co-design](#) project can be mentioned. Several initiatives were carried out, including conferences, workshops, and training. An [international seminar and the final conference](#) of the EduCig project - School performances among Roma: action-research and co-design project were held in 2022.

The conference included the screening of a documentary film containing a compilation of interviews with the project's research team, Roma students, families, and cultural mediators.

# Promotion of Scientific Culture

The development of initiatives promoting scientific culture has been one of the Center's concerns since it was founded, and researchers have participated actively and regularly.

CIES-Iscte actively participates in science outreach initiatives organized by Agência Ciência Viva, including Science and Technology Week and school-holiday scientific activities for young people. Moreover, the Center regularly takes part in the European Researchers' Night, an event funded by the European Commission.

The center's research team members also undertake other activities promoting scientific culture, including events for the general public, scientific articles, participation in TV programs, book releases, etc.

## Science and Technology Week & Science in the Holidays for Young People

Science and Technology Week and the Science in the Holidays for Young People program enable young people to come into contact with everyday life, people, projects and methods at a research center as part of the research conducted by CIES-Iscte researchers.



In April 2022, CIES-Iscte promoted an Open Day with the purpose of showing some activities developed in and by the research center. The visit was attended by 43 students from Miraflores Secondary School. The initiative included Focus Group and Young Students Parliament activities, conducted by CIES researchers. The Open Day also included a presentation by the School of Sociology and Public Policy (ESPP) and the Núcleo de Estudantes de Sociologia do Iscte - Instituto Universitário de Lisboa (NESISCTE).



As part of the Science and Technology Week and to celebrate the National Day of Scientific Culture (November 24), CIES has opened its doors and hosted a number of activities, providing participants with opportunities to get in touch with social scientists from various areas of scientific expertise, but also to closely follow the techniques and methodologies that can be adopted in research.

In a collaboration with CEI-Iscte (Center for International Studies), CIES-Iscte has participated in the 18th edition of Science in the Holidays for Young People, promoted by Agência Ciência Viva.

Over two weeks, the 4 secondary school trainees learned about the activities and work of the research centers involved and under the theme "Challenges of Society in the 21st Century", they worked on topics such as social movements, social and student activism, disinformation and war.

The activities developed were led by researchers from CEI and CIES. At the end of the internship, the students chose one of the themes addressed to develop a research project that has been presented to the members of the two centers.

# European Researchers' Night

The European Researchers' Night (NEI) is an initiative funded by the European Commission, under the Horizon 2020 program, Marie Skłodowska-Curie Actions (MSCA), which aims to bring researchers and citizens closer together in several European cities typically on the last Friday in September.

The 2022 edition of European Researchers' Night took place at European level, with the theme "Science for All - Inclusion and Sustainability".

CIES-Iscte participated in the local program in Lisbon, with the activity "There is no Planet B", organized with CEI-Iscte (Center for International Studies) and Arquivo Ephemera.



The activity consisted in an exhibition of handmade posters rescued from the School Strike for Climate and other climate demonstrations, reflecting the cry of a generation that appeals to governments and politicians for urgent and structural changes (explore the virtual expo at [bit.ly/nao-haplanetaB](https://bit.ly/nao-haplanetaB)). NEI participants were also challenged to create their own posters.

# Publishing Activities

CIES-Iscte has published the scientific journal *Sociologia, Problemas e Práticas* (SPP) since 1986. The center has had its own publishing house, *Mundos Sociais* since 2010. It publishes the SPP journal and peer-reviewed social science book collections. The center also publishes the journal *Ler História* jointly with CEI-Iscte and belongs to consortiums that manage the indexed journals *Portuguese Journal of Social Science* (PJSS) and *Observatório* (OBS\*) and publishes the CIES e-Working Papers.

CIES-Iscte actively follows an open science policy. SPP articles and the CIES e-Working Papers are totally available online in their websites and at the RCAAP (Open-access Scientific Repositories in Portugal), and *Mundos Sociais* has published its first books with online editions.

CIES-Iscte was a pioneer at Iscte in providing open access to its publications at the Iscte repository. It has been its largest contributor to scientific documents (over 3500 available). The center is a founding member of the Portuguese Social Information Archive (APIS) and Production and Archive of Social Science Data (PASSDA) which stores and shares data produced in social science research projects.

# 7.1 Sociologia, Problemas e Práticas

*Sociologia, Problemas e Práticas* is a scientific journal whose main purpose is to publish sociological analysis articles resulting from original research, the development of theory, or thematic evaluation. It also accepts papers from other social science areas, where there is an interdisciplinary interest. It is directed towards an international audience, publishing articles in Portuguese, English, Spanish, and French, by authors from various countries.

The journal's editorial stance is governed by principles of scientific quality, paradigmatic pluralism, and social relevance. It aims to ensure that the articles published make a significant contribution to the advance of knowledge. Articles submitted for publication undergo a blind independent review by at least two recognized specialists drawn from a range of countries. The journal *Sociologia, Problemas e Práticas* was established in 1986, and since when it has been published without interruption. It is indexed in various international bibliographic databases.

*Sociologia, Problemas e Práticas* remained on track in 2022 and its three annual numbers (n° 98, n°99 and n°100) were published regularly and punctually.


The inclusion of *Sociologia, Problemas e Práticas* in indexed online platforms and the visibility that they afford the journal increase quotations from its articles. It is positioned in Quartile 3 of SCImago/Scopus, in the fields of Sociology and Political Science and Social Sciences (miscellaneous).



In 2022, the book "Ir para Fora" was published and several were evaluated and formatted for publication in 2023.

# Ler História, Portuguese Journal of Social Science and OBS\*

CIES-Iscte publishes jointly with CEI-Iscte (Center for International Studies) the journal *Ler História* and is part of the consortiums that publish the journal *Portuguese Journal of Social Science* and the e-journal *OBS\**.

Launched in 1983, [Ler História](#) is a Portuguese academic journal in the scientific area of History, dedicated to the history of Portugal, the Portuguese Empire and the Lusophone countries, in the modern and contemporary eras, which is published in Portuguese, English, Spanish and French.

*Ler História* also includes in its field of interests other chronologies and geographies, such as Iberian and Ibero-American history, the history of Africa and the history of Asia, among others, being particularly receptive to approaches of comparative, transnational, or global history.

As a publication of Iscte, since 2020 it began to be published by CIES-Iscte and CEI-Iscte given the relevance to the scientific and thematic areas of the two research units.



The journal is indexed in several international databases among which SJR (Scimago Journal & Country Rank) is of particular note, in which *Ler História* is classified Q2.

In 2022, issues 80 and 81 of the journal were published.

[Portuguese Journal of Social Science](#) (PJSS) is published by Intellect and is managed by a consortium formed by Iscte and three of its research units: CIES-Iscte, CIS-Iscte and DINÂMIA'CET-Iscte. Since 2019 a researcher of the CIES-Iscte team, Nuno de Almeida Alves, is Editor of the journal.

PJSS is indexed in the following databases, among others: SCOPUS (Scimago), Capes-WebQualis, Cambridge Scientific Abstracts, ISBSS, Sociological Abstracts, Worldwide Political Science Abstracts, Latindex, EBSCOhost.

The journal [OBS\\*](#) is published within the scope of the collaboration of CIES-Iscte and OberCom (Communication Observatory), being an interdisciplinary journal, open to contributions from disciplines related to communication studies, which publishes articles in English, Spanish, Italian, Galego, French and Portuguese, in open access.



The journal is indexed in several databases, such as Scopus Elsevier/Scimago, ERIH-PLUS and Scielo. In the Scientific Journal Rankings (SJR) of Scimago, the journal is now established in Quartile 3 and is placed in 2nd place among the Portuguese journals in the area of Communication.

In 2022, the OBS\* journal maintained the course of its activity ensuring the regular and timely publication of its annual issues (Vol. 16) and the Special Issue in Media Literacy and Civic Cultures.

# CIES-Iscte e-Working Papers

The main goal of the [CIES e-Working Papers \(e-WP\)](#) series, initiated in 2005, is the publication of scientific papers in electronic format that result from research developed by CIES-Iscte researchers, as well as by researchers who collaborate with members or activities of the Center and students from Iscte.

CIES e-WP are typically work in progress and may be theoretical or conceptual, methodological, or empirical in nature. Texts proposed for publication are assessed by the Editorial Board and submitted to peer review to ensure the Center's standards of quality and scientific relevance.

There were two CIES e-Working Papers published in 2022, and a total of 241 working papers have already been published.






CIES-Iscte posts reached 40 018 users organically. This metric also includes reach from other sources, such as identifications and visits to the Page or profile. The present results represent an increase of 95.2% compared to 2021, without using paid ads.

Throughout the year, with an average of 1 organic like per day and 0 cancellations of likes per day, 393 more likes were added, making an estimate total of 6305 likes on December 27.



## YouTube Channel


The CIES-Iscte YouTube channel is the main streaming tool of the center and hosts a vast archive of videos of scientific events, podcasts, and documentaries.


## Audience

# Sources of Funding

Overall, the volume of the sources of funding remains similar to the previous year, with a very slight decrease.

FCT remains the major source of funding, given its support to the recruitment of researchers (work contracts for full-time PhDs), which accounts for nearly 40% of all external funding of the R&D activities. Also concerning funding from FCT, the pluriannual is being maintained and there has been an increase in income from R&D projects.

The level of funding from Portuguese public bodies, local authorities and Portuguese private institutions had an overall rate of 21% and there continues to be a high diversification of funding sources.

The European Union funding decreased in 2022 largely due to the change of framework programs. Given the ongoing projects under Horizon Europe, the volume of income is expected to increase in the coming years.

Although CIES was directly involved in two major scientific events in 2022, the volume of this category does not reflect the overall amount because the income was managed at ISCTE level, following protocols signed with the institutions promoting the events.

Regarding the funding from FCT for Post Doctoral Fellowships and PhD scholarships, indirect sources of funding, the number of the of the latter has increased raising the amount of funding. As mentioned in section 1.3 of this report, FCT no longer opens calls for Post Doctoral Fellowships, so the figures of 2022 are from the last two fellowships that CIES has hosted that will end in 2022, ceasing this type of funding.

## Expenditure structure

The distribution of expenditure in 2022 remains broadly similar to previous years.

Human resources are the major cost of CIES-Iscte' s expenditure, even though with a lower percentage than in recent years (60% in 2022). This category includes the technical team of science managers and hired PhD researchers (with work contracts) and research assistants who have grants for the development of activities within the scope of the Center's observatories.

Overcoming mobility limitations due to the COVID-19 pandemic, the travel expenditure has been increasing in the last two years, overcoming pre-pandemic values.

The purchasing of services to support researchers and research activities has not significantly differed from the previous year (around 17% of total expenditure).

Regarding the direct expenditure executed under the FCT Pluriannual Funding and by category, the following is observed:

The Human Resources category has registered a slight increase in value, but its weight as a proportion of the total amount has fallen due to the increase in expenditure in other categories (such as travel).

With the end of travel restrictions due to the Covid-19 pandemic, there is an increase in mobility-related expenditure, both in the travel and in the dissemination categories. At this point it is important to make a clarification. FCT has introduced a change in the classification of expenses, which are now distributed as follows: under the heading missions (travel) are included expenses related with fieldwork, work and networking meetings, and the dissemination category includes travel expenses (registration, accommodation, and travel) for the presentation of papers at scientific meetings and other activities to disseminate the Centre's activities and scientific results. This has led to changes in these categories over the last two years.

The procurement to support researchers for expenses such as translation, proofreading and open access registered an increase, keeping the relative ratio.

At last, the dissemination category also comprises an investment that has been made for the re-design of the CIES-Iscte website, so the information is provided in a more targeted and relevant way. There will be an update of the image and the adaptability to the multiple screen types (including mobile).
